## Terms and Conditions for all Parade Entries



The Santa Fe Human Rights Alliance (herein referred to as HRA) proudly presents Santa Fe Pride, Santa Fe's arts and culture festival for the LGBT community and its friends and allies. Santa Fe Pride is herein referred to as SFP. SFP is presented to the public as an educational event and reserves all rights as producers. Any reproduction, broadcast, or commercial use of any portion of the event or logos of HRA or SFP, in whole or in part, in any form without explicit written consent of HRA, is strictly prohibited.

**HRA and SFP reserve the right to refuse anyone participation at this event and does not guarantee your success at this event.**

By Signing and submitting the attached application, you (herein referred to as "Entries" or "Units") agree to comply with the following terms and conditions. Violators of these terms and conditions can be cause for removal from the festival grounds without refund and can result in being expelled from future events.

### **NO INCOMPLETE APPLICATIONS WILL BE ACCEPTED.**

1. All entries must check in at the parking lot in front of the PERA Building between 9:00AM and 10:00 AM on Saturday June 30, 2018.
2. **THE PARADE STARTS PROMPTLY AT 11:00AM.**
3. All vehicle entries are required to complete a Hold Harmless/Indemnity form before entering the lineup for the parade. All requested information must be provided.
4. All units must be ready to move on cue or the next unit will proceed. The delayed unit will proceed only at the next convenient time as determined by the parade organizer.
5. All Parade participants are **forbidden** to throw anything from their unit per City regulations.
6. HRA/SFP reserves the right to remove persons from any float or vehicle unit which it determines unruly, offensive, unsafe, and/or a hindrance to the progress of the parade, or places other participants and/or spectators in physical danger, or violates any regulations set forth in this application. (Including any nudity and intoxication).
7. All applicants are responsible for any and all acts and/or omissions on their part, or on the part of their agents and/or employees, which may result in injury or damage to themselves or third parties. Applicant specifically agrees to hold HRA/SFP free and harmless from any and all claims arising out of such act or omission.
8. All entries are required to ABIDE BY THE RULES AND REGULATIONS as established by HRA/SFP, and by the laws of the city of Santa Fe and the State of New Mexico. Violators are subject to citation and/or possible removal from the parade route.
9. HRA/SFP presents the annual Santa Fe Pride on the Plaza Celebration for the public as an educational and entertainment event and reserves all rights as producers. Any reproduction, broadcast, or commercial use of any portion of the event, in whole or in part, in any form without explicit prior written consent from HRA/SFP is strictly prohibited. HRA/SFP may, at its discretion, film photocopy, or tape any and all portions of the parade for commercial use.
10. **Limitation of liability, indemnity and release**

- a. Neither HRA/SFP, nor any of its officers, agents, volunteers, employees, independent contractors or other representatives shall be held liable for, and they are expressly released from, liability for any damage, loss, harm, or injury to the person or property of exhibitor or any of its officers, agents, volunteers, employees, independent contractors or other representatives, resulting from theft, fire, water, accident, or any other case.
- b. Parade entries indemnify, defend and hold harmless HRA/SFP and any of its officers, agents, volunteers, employees, independent contractors or other representatives (I) from and against any and all claims arising from any acts, failures to act, or negligence of parade applicant or any of its officers, agents, volunteers, employees, independent contractors or other representatives, (II) from and against any and all claims arising from breach of, or default in the performance of any obligation on exhibitor's part to be performed under, these terms and condition, and (III) from and against all costs, attorney's fees, expenses, and liabilities incurred in the defense of any such claim or any action.
- c. All entries/participants displays, products, equipment, furniture and furnishings are placed on the parade route at the sole risk of the participant, and HRA/SFP will not assume any responsibility for the loss or damage to the participant's property. HRA/SFP shall not be liable for any such damage occasioned by failure to maintain the festival grounds.
- d. Under no circumstances shall HRA/SFP be liable for consequential, indirect, special or punitive damages of any kind, whether foreseeable or unforeseeable, whether based upon lost goodwill, lost profits, loss of entrance in parade, or otherwise, and whether arising out of breach or any express or implied warranty, breach of contract, negligence, misrepresentation, strict liability, or otherwise.
- e. Parade entries hereby agrees that HRA/SFP shall not be liable for any injury to participants, and any of its officers, agents, volunteers, employees, independent contractors or other representatives, or any loss of income there from
