

Boston's Award-Winning Wine Shop The Urban Grape Shuts Down

The Urban Grape, a celebrated South End wine retailer, has permanently closed after unsuccessful negotiations with its lender.

Owners TJ and Hadley Douglas announced the closure on Instagram, revealing that their Columbus Avenue shop was forced to shut down following a breakdown in discussions with Cambridge Savings Bank, their SBA lender. The couple

disclosed that they had spent more than a year working with family members and investors to reach an agreement that would preserve the business and restore its inventory to previous levels.

"For over 12 months, TJ and I, along with our family and a group of wonderful investors, have worked tirelessly to reach an agreement with our local SBA lender, Cambridge

Two RI Men Await Trial After South End Takeover

Two Rhode Island men are awaiting a pre-trial hearing next month after being charged in connection with a violent confrontation that left a Boston police cruiser destroyed during an early morning "vehicle takeover" on October 5.

Julian Bowers, 18, of Cumberland, and William Cantwell, 19, of Warwick, were arrested following the chaotic scene at the intersection of Massachusetts Avenue and Tremont Street around 2 a.m. Both

men pleaded not guilty at their arraignment on October 7 in Roxbury District Court.

According to Boston Police, a crowd of more than 100 people blocked the intersection with vehicles and immediately began attacking marked cruisers with fireworks, traffic cones, poles, and other objects. One cruiser sustained extensive damage after being repeatedly struck with fireworks,

Immigrant's Story Shines in Triumphant 'Hamilton' Return

The original 13 colonies had to free themselves from a kind of bondage to King George III and England. In light of the need to establish an American republic, was Alexander Hamilton a kind of American Revolution Moses? Lin-Manuel Miranda, the brilliant author and composer of the Pulitzer Prize-winning musical "Hamilton", may have been thinking just that when he alluded to the great Jewish leader in the early going of his landmark show.

In suggesting that the distinctive Founding Father was similar to Promised Land-heading Moses, Miranda's provocative book has

Fatal Pedestrian Accident on BU Medical Campus

A pedestrian was struck and killed by a Boston University shuttle bus near 774 Albany Street on the BU Medical Campus at approximately 7:58 a.m. Monday morning. The victim, whose identity has not been

released, became trapped beneath the vehicle and was pronounced dead at the scene.

Boston Police Department's Homicide Unit and Fatal Collision Investigation Team responded to the incident. Albany Street between Northampton Street and Massachusetts Avenue was closed in both directions for several hours, with

the Mass. Ave. Connector to Boston Medical Center also temporarily shut down. All roads reopened by early afternoon.

The investigation remains ongoing, and no arrests have been made. BU spokesperson Colin Riley called the incident "a terrible tragedy."

Hamilton allow that he might not live to see America's glory. (In fact, a first act number revealingly entitled "Ten Duel Commandments", that will connect with Hamilton's death at the hands of Aaron Burr, may be a subtle allusion to the fact that Hamilton actually learned the Ten Commandments in Hebrew).

Some history buffs may see this comparison as a stretch, but the wonderfully entertaining and thoughtful musical, now in a stellar return tour at the Citizens Opera House, clearly makes a strong case for seeing Hamilton's writings and actions as essential to the beginning of the American Experiment.

As the show's informative backstory explains, Hamilton immigrated to the American colonies from the Caribbean (actually from the island of Nevis). At various points, the influence of his mother (who would convert to Judaism before his birth) is stressed. Eventually George Washington, as indicated in the musical's book, especially in a number entitled "Right Hand Man", would depend on Hamilton's thinking and writings.

In the later going, even his detractors admit that he composed the lion's share of the Federalist Papers, many more than those penned by James Madison and Thomas Jefferson. Where Jefferson complains about projected expenses in Hamilton's plans, the latter sharply notes that the former's Virginia is doing particularly well thanks to plantation slave labor.

Ultimately, of course, the focal conflict throughout the musical is the on-going rivalry between Hamilton and Aaron Burr. Miranda's book has Hamilton tellingly accusing Burr of consistently failing to take a stand on the issues involved in establishing America. At the same time that Burr resents Hamilton's seeming favored place, reflected in the number "Washington on Your Side," the very ambitious political figure is virtually obsessed with "The

Room Where It Happens", a standout number that has become a kind of idiom for involvement in decision-making.

Make no mistake. While "Hamilton" celebrates the importance of immigrants like the title character to the greatness of America and makes smart use of historical material in the process, the show always provides breath-taking stage craft and a rich repertoire of musical performance. The talented cast is as good in its own way as that of the previous tour and the Broadway original (which this critic saw in 2015).

Nathan Haydel as Hamilton (at the performance this critic saw; some cast assignments change throughout the run) combines his character's enthusiasm as a budding lawmaker, especially on the lively early number "My Shot" and his boldness in advancing his ideas. Amanda Simone Lee is a standout as Hamilton's sister-in-law Angelica Schuyler, particularly as the musical's moral anchor in the face of her brother-in-law's infidelity. Deonte Goodman captures all of Burr's drive and discontent (Jimmy "JJ" Jeter has assumed the role for the rest of the run). A. D. Weaver moves very convincingly as George Washington from President to private citizen speaking of retiring under a grapevine and fig tree, clearly a biblical allusion.

Christian Magby successfully alternates between French heroically Lafayette and Jefferson. Magby is a jazzy hoot in the catchy second act opener "What'd I Miss" as Jefferson returns from France. Lauren Mariasoosay is touching as the loving and loyal wife Eliza Hamilton. Jorge Guerra has all of son Philip Hamilton's earnestness and vulnerability. Matt Bitner as King George III sings and moves with amusing if evolving certainty that the colonies will eventually return to the British Empire.

A first act statement that "Immigrants, we get the job done" rightly elicited cheers from the Opera House audience. Hamilton certainly did, and the same can be easily said about the strong current tour.

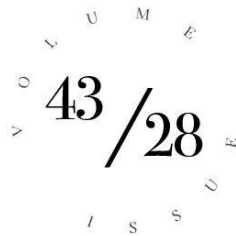

El presupuesto municipal de la alcaldesa Michelle Wu para el año fiscal 2026-27 ya está en manos del Ayuntamiento, y los defensores de los Amigos de la Biblioteca de South End han comenzado a presionar al Ayuntamiento para que proteja los 30 millones de dólares asignados en el presupuesto para la sustitución de la Biblioteca de South End.

Yvette Jarreau, presidenta de los Amigos de la Biblioteca de South End, intervino el 6 de mayo en la audiencia sobre el presupuesto municipal, presidida por el concejal del Distrito 4, Brian Worrell. Jarreau señaló que la sucursal de South End ha estado cerrada durante casi cinco años debido a la COVID-19 y las inundaciones. La nueva biblioteca no abrirá hasta finales de 2028.

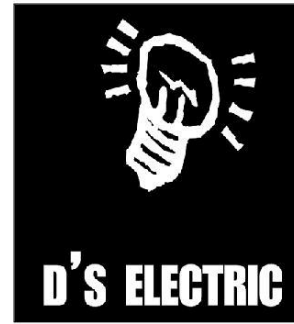
Conciertos de verano en el Parque de la Biblioteca

causing smoke and fire inside the vehicle. Members of the crowd also jumped onto the hood of the cruiser before it was ultimately destroyed by fire and towed from the scene.

Bowers faces charges of malicious destruction of property over \$1,200, disorderly conduct, assault and battery on a police officer, and resisting arrest after allegedly throwing objects at officers and their cruiser. Cantwell faces identical charges, plus possession of Class D marijuana after officers discovered two packages of edibles in his bag. The legal age for cannabis use in Massachusetts is 21.

Both suspects posted bail—\$500 for Bowers and \$1,000 for Cantwell—significantly lower than the amounts prosecutors requested. The district attorney's office had sought \$15,000 bail for Bowers and \$20,000 for Cantwell, along with GPS monitoring and curfew conditions.

The low bail amounts sparked immediate criticism from state officials. Massachusetts Governor Maura Healey issued a strongly worded statement condemning the incident and the bail decision. "These individuals' behavior was completely destructive, dangerous and against the law," Healey said. "I'm disgusted by these meetings, and I will be taking action to support law enforcement and hold accountable anyone who attacks our police and communities to the fullest extent of the law. Bail should have been set higher as the prosecution requested."

Boston Mayor Michelle Wu also condemned the violence. "The outside individuals who brought dangerous and disorderly conduct into Boston last night will be prosecuted and held fully accountable for their actions," Wu said in a statement issued after the incident. "These groups are not welcome here and will face serious consequences."

Larry Calderone, president of the Boston Police Patrolmen's Association, described the event as a coordinated attack on law enforcement. "There shouldn't be any tolerance for this type of behavior," Calderone said. "They knew what they were going to do and they were hell-bent on attacking police officers."

As conditions of their release, both men must wear GPS monitoring bracelets and are prohibited from entering Boston except for court proceedings or meetings with their attorneys. Court records indicate both suspects also have a pending drag racing case in Rhode Island.

The two men are scheduled to appear in court on November 5 for a pre-trial hearing.

Boston Police continue to investigate the incident and are asking anyone with information to contact detectives at 617-343-4683.
