## Breadon Makes History as Boston's First Openly LGBTQ and immigrant City Council President

Culpepper sworn in as District 7 Councilor

In a stunning upset Monday, District 9 Councilor Liz Breadon secured the Boston City Council

presidency with a 7-6 vote, becoming the first openly LGBTQ person to hold the position.

Breadon, who in 2020 became the first openly gay woman to serve on the council, emerged as a last-minute compromise candidate following intense behind-the-scenes

### Boston's 2025 Municipal Elections

Mayor Michelle Wu won a second term after finishing first by a wide margin in the September preliminary election. Her leading challenger, nonprofit executive Josh Kraft, later withdrew from the race, leaving Wu effectively unopposed in

### Boston Chops Closes Both Locations

Both locations of Boston Chops steakhouse closed January 1, 2026, including the South End restaurant that had served the neighborhood for more than a decade, originally reported by Boston Restaurant Talk.

The closure comes as Urban Hospitality Group CEO Brian Piccini secured new ownership for the properties. An Instagram post from Boston Chops announced the restaurants "are now closed to

make way for new ownership and a revitalized concept to better serve the community."

Piccini had announced in October that he was selling Boston

November. She went on to win re-election with an overwhelming share of the vote, entering her second term with strong political footing.

The City Council at-large races resulted in continuity, with all four incumbent at-large councilors winning re-election, reinforcing stability in council leadership.

### District 7 and District 2 Council Races

The most significant council race affecting the South End was District 7, which includes portions of the neighborhood. The seat became open following the resignation of Councilor Tania Fernandes Anderson, who pleaded guilty earlier in the year to federal corruption charges related to misuse of public funds.

Fernandes Anderson was sentenced in September to one month in federal prison, followed by supervised release and restitution. She completed that sentence and was released from custody in mid-November 2025. Her resignation set the stage for a closely watched election to replace her.

Voters elected a new District 7 councilor in November, Miniard Culpepper, closing a turbulent chapter and shifting attention toward restoring trust, accountability, and constituent services.

In District 2, which also includes the South End, the incumbent councilor Ed Flynn retained the seat.

### Restaurants, Bars, and National Attention

The South End's dining scene remained one of Boston's most closely watched:

- 311 Omakase received a Michelin star when the Michelin Guide debuted in Boston, bringing international attention to the neighborhood.
- Louis Corner opened in the former Butcher Shop space on Tremont Street, featuring

marking a high-profile transition.

- Banyan Bar + Refuge closed after a kitchen fire and subsequent burglary, highlighting the vulnerability of small businesses during a difficult year.
- JJ Foley's Café earned national recognition for serving what was described as the best Guinness in America.

Late in the year, chef George Mendes announced plans for two future South End concepts, signaling continued confidence in the neighborhood's long-term appeal.

### Development and Planning

Several projects shaped discussion about the South End's future:

- Plans advanced to convert 95 Berkeley Street from office space into residential units.
- A proposed artist live-work development at 52 Plympton Street sparked debate about affordability, displacement, and preserving the neighborhood's artistic legacy.
- Planning continued for projects along Tremont Street tied to institutional and mixed-use development.

### Recognition and Civic Investment

The year also brought notable recognition:

- Several South End institutions were honored as Boston Legacy Businesses during a ceremony held in the neighborhood.
- Boston received national climate recognition in 2025, with a South End affordable housing development cited as a model for energy-efficient retrofits.
- Northeastern University awarded community grants to organizations serving the South End and surrounding neighborhoods.

With some of the strongest efforts movingly dealing with the full meaning of Emma Lazarus' anthem—like the call to "huddled masses" on the Statue of Liberty, theatergoers have seen timely and resonant productions bringing dignity and important insight to immigrants and often marginalized Americans particularly in the face of antisemitism and other forms of hatred.

This year's visiting plays and musicals have often probed these themes with equally compelling results. The best of these stagings have ranged from Tony Award-winning musicals to very sharp original solo works. As in previous years, I am presenting my best list in two parts, area and visiting, to do full justice to the year's finest productions.

### The following are this critic's choices for 2025:

#### Area Stagings

*A Man of No Importance* (SpeakEasy Stage Company) - Eddie Shields is a brilliant portrayal of an English bus driver coming to terms with his true identity.

*Blood Brothers* (Theater Uncorked) - Sehnaz Dirik haunting as a mother making a Greek tragedy — like sacrifice involving two very different twins.

*Fun Home* (The Huntington) - A stellar cast as good in its own way as the Tony Award-winning one in director Logan Ellis' very fresh conception.

*Jaja's African Hair Braiding* (SpeakEasy Stage Company) - A riveting ensemble portraying immigrants from Africa striving for acceptance in a disarming play with a closing theatrical punch.

*The Beautiful Land* (Teatro Chelsea) - A stirring celebration of Puerto Rico and an important reminder of its worthiness.

*The Glass Menagerie* (Gloucester Stage Company) - A spell-binding revival that would easily impress Tennessee Williams himself.

*The Hills of California* (The Huntington) - An artful staging of a tricky family — focused Jez Butterworth play with a Broadway caliber design.

*The Light in the Piazza* (The Huntington) - A beautifully designed production actually superior to the multiple Tony Award-winning musical's earlier tour and truer to the Lincoln Center original.

*The Piano Lesson* (Actors' Shakespeare Project) - Another masterful ASP version of an August Wilson gem with a powerhouse lead performance by Omar Robinson.

*Tick, Tick... Boom!* (Umbrella Stage) - An exuberant production of Jonathan Larson's important effort before "Rent."





Craft Gallery, 793 Tremont Street.

The brunch celebrated Kujichagulia (Self-Determination), the second principle of Kwanzaa, and presented the organization's third Mel King Leadership Award to Harrison Clark, a UMass student and civic activist who has spoken nationally on health equity and reparations.

The monthly brunches honor the late Mel King, the Boston civil rights activist, organizer, poet, politician, and university professor who passed away in 2023. For over fifty years, King opened his home for Sunday brunches that welcomed the entire community—a tradition the South End Brunch Club was founded to continue.

"The Mel King Brunch is about amplifying the important work of culture bearing by purposefully engaging with the community to share resources and close intergenerational gaps," said Heather Cook, founder and CEO of TSEBC.

All five brunches in 2025 reached capacity. In November, instead of hosting a brunch, the organization provided a Turkey Feast Giveaway for 150 families and 100 holiday meals to elders. TSEBC also hosted a BARZ Women's Empowerment Brunch and spon-

sored a second holiday meal giveaway with partners including the Caribbean Foundation of Boston and Urban Community Home Health Aide services.

Looking ahead to 2026, the South End Brunch Club has partnered with Boston Neighborhood Network to produce "The Mel King Blueprint," a monthly one-hour community news and interview program premiering in February.

"It is an honor to see so many in our community gather in the spirit that Mel King established with his Sunday Brunch," said Edwin Sumpter, chief operations officer of TSEBC. "We are extending his Blueprint for community service through our Mel King Brunch and other endeavors in our Beloved Community."

Bless Robinson, chief creative officer, added: "For the past seven months, I have walked as a universal activist in service to my community and the experience has been both deeply humbling and profoundly gratifying."

The South End Brunch Club has received support from the Mel King family, Boston City Councilors Ed Flynn and Julia Mejia, former Councilor Frank Baker, and numerous local businesses and community organizations including Starbucks Back Bay, Lambert's Supermarket, Hummingbird Jamaican Cuisine, and Boston Neighborhood Network.

negotiations that stretched into Sunday night. The physical therapist, who immigrated from Northern Ireland in 1995 and lives in Brighton with her wife, defeated District 4 Councilor Brian Worrell in the closely contested race.

"At the federal level, we face deep uncertainty, attacks on democratic norms, on civil rights, on the social safety net that so many Bostonians rely on," she said after winning the presidency. "In this context, cities matter more than ever. Boston must continue to lead by protecting immigrants, by advancing racial and economic justice, by investing in public education, by treating housing as a human right, and by standing firmly by our LGBTQ+ equality, reproductive freedom, and the dignity of all people."

The council vote came hours after Boston Mayor Michelle Wu was sworn into her second term Monday morning at Symphony Hall. Wu ran unopposed in the General Election after Democratic candidate Josh Kraft suspended his mayoral campaign in September.

In her opening remarks, Wu criticized the Trump Administration for cutting funding for housing, education, and health care. "We will not appease or abet any threat to our city, and we will not wait for permission to build the

world our families deserve," Wu said. "Over the next four years, Boston will be the proof that the nation we fought for is possible — a place where we take care of each other and take on the challenges that matter the most."

Other members of Boston City Council were also sworn in Monday, including Miniard Culpepper as the new District 7 Councilor. Culpepper replaced convicted former City Councilor Tania Fernandes Anderson.

The path to the council presidency came after Councilor Gigi Coletta Zapata withdrew from the race Sunday evening, having previously claimed she had secured the votes. Councilors Enrique Pépén and Sharon Durkan made a late-night visit to Breadon's Brighton home to ask her to "consider being a compromise candidate."

"I didn't know I'd be standing here this time yesterday, but that said, I'm ready to lead," Breadon told her colleagues during Monday's meeting. In her floor speech, she pledged to "continue to be a peacemaker, a bridge builder, and someone who hopefully will be instrumental in helping us go forward positively, with strong leadership from all of us."

Breadon succeeds Councilor At-Large Ruthzee Louijeune and has served on the council since 2020, now beginning her fourth term.


