"I was the conductor of the Underground Railroad for eight years, and I can say what most conductors can't say; I never ran my train off the track and I never lost a passenger."

Every summer, several people gather in a park located in a small triangular park at Columbus Avenue between West Newton and Pembroke Streets in Boston's picturesque and historic South End neighborhood in

## Jackson asks for virus reaseach halt

On Tuesday the City Council considered a proposal from Councilor Tito Jackson (Roxbury) for a hearing on barring research that involves "aerosolizing" pathogens not currently native to Boston—such as Ebola—at least until after scientists across the country have been able to figure out how to really keep us safe from inadvertent releases from laboratories.

The measure is aimed specifically at BU's National Emerging Infectious Diseases Laboratories in the South End.

Jackson says the risks to the public of such mists escaping the lab are just too high without additional safety assurances.

Such aerosolization experiments have been used to generate novel potential pandemic pathogens (PPP), such as versions of the Asian bird flu (H5N1) and Chinese influenza virus (H7N9) with increased infectivity to mammals.

richly complemented by Oana Botez's vivid costumes and Antoinette Di-Pietropolo's eye-catching choreography.

Veteran music director Rob Slovik and the versatile Big Apple Circus Ban-perched above a fitting travel-poster dominated backdrop, accompany the high-stepping full cast during the show's flashy Charleston dance-driven entry and finale. Under Mark Loneragan's sharp direction, "The Grand Tour" immediately amazes with Chiara Anastasini's stunning hula hoop act. Defying gravity as she balances a continually increasing number of hoops, the standout Italian-American talent eventually becomes a kind of human slinky. Another showstopper soon follows- namely Russian juggler Alexander Koblikov. Disarmingly unassuming in the role of a 'swaying sailor,' he displays both impressive grace and his own balancing gifts with 14 balls (a feat unsurprisingly cited by the Guinness Book of World Records). Brothers Erick and Jayson Dominguez pull off the challenges of the fast-moving Wheel of Wonder with exciting agility. China's acrobatic Energy Trio displaying remarkable strength in demanding first act balancing- sometimes depending on only one arm.

During both acts, the show's multi-talented writer-creator Joel Jeske and Brent McBeth make a diverting duo with crowd-pleasing slapstick-especially pratfalls and a water bucket splashing. Both clowns demonstrate a facility for engaging audience members in

some of their routines, notably the 'Red Nose Transplant.' Veteran Big Apple circus fans may yearn for the earlier singular comedy of Barry Lubin as the signature character Grandma or the daredevil antics of Bello Nock, but Jeske and McBeth do display good chemistry in their skits. First act dogs and ponies and second act full size horses become nimble animal travelers themselves under the inspired guidance of trainer Jenny Vidbel working with head groom Emily McGuire. Look for a poodle riding a scooter and a large dog smoothly rolling a hoop bearing a smaller one. Vidbel and McGuire make the Arabian horses formations and ring moves-at times accompanied smartly by the famous title theme of "Lawrence of Arabia"—equally lighthearted and exhilarating. The circus offers (\$10) pony rides for young children (the weight limit is 65 pounds) at each intermission.

Besides the beguiling horses, the second half has other captivating displays. The African Acrobats sequence finds the Zuma Zuma Troupe creating a tower of balance as well as eye-catching flips and handstands. The Dosov Troupe from Belarus—at times with a height-increasing large seat or stilts—accomplish first class take-offs and landings with the teeterboard as the band cleverly plays "Those Magnificent Men on Their Flying Machines." Arguably the most poetic standout in the show is Sergey Akimov's masterful solo on aerial straps. Akimov twirls and flips with gymnastic flair and breathtaking balletic form.

"The Grand Tour" is a stylish one-ring journey and the Big Apple's global ensemble its winning big top guide.

## Will you challenge the BRA extension?

The Boston Redevelopment Authority is asking the Department of Housing and Community Development (DHCD) to approve a six-year extension of 14 expiring Urban Renewal (UR) Plans, which cover 3,000 acres of central Boston and affect hundreds of thousands of residents and property owners in South End, Roxbury, Chinatown, Fenway, Charlestown, Bay Village, and North End/Waterfront.

Per state regulations (760 CMR 12.00: URBAN RENEWAL REGULATIONS Section 12.03: Plan Changes), DHCD is allowed to approve UR Plan extensions only if they have been properly approved by the Boston City Council.

But as DHCD is aware, the Boston City Council no longer has jurisdiction over UR Plan extensions and therefore the DHCD approval of this extension is not in conformance with the statutory regulations.

On December 15, 2004, the City Council

approved a 10-year extension of the UR Plans and "a series of procedural changes with respect to Urban Renewal Plans in Boston." The "procedural changes" consisted of changes in the Council's UR Plan approval powers, leaving the Council with voting power only on proposed creation of new UR Plans and proposed termination of ongoing UR Plans, but not on extension of expiring UR Plans.

The BRA submitted to DHCD the Council-approved UR Plan extensions and changes to the Council's review powers, and DHCD approved in 2005. These changes are still in effect.

The Council's loss of power over extensions has been acknowledged by BRA attorneys, both at the time it was enacted and today. Yet the BRA has advised the Councilors that their vote complies with the law, deliberately misleading them in order to get a vote to take to DHCD for ratification.

But the Boston City Council exceeded its authority in casting this vote, which is therefore not lawful. The same would be true

for a DHCD vote based on such a Council vote. Since the Council could not lawfully vote on this extension, DHCD cannot lawfully consider the proposed change. Therefore, the UR Plans must by law expire as mandated, on April 30, 2016.

DHCD's only lawful course of action is to notify the BRA that DHCD cannot entertain the extension request and that these 14 UR Plans will expire by law on April 30, 2016. However, DHCD, either unaware of or ignoring these facts, seems prepared to approve.

This unlawful decision can be challenged in court. sleep-overs and vacations with their owners and with friends. This is the story of Knox, Bear and Harper, three rescue pups who have found a loving South End home and social-media fame and Jenna Donleavy, the young woman whose dream they fulfilled.

Once she graduated from Lafayette College with a degree in economics, Donleavy was ready for her lifelong dream to come true. Growing up on a spacious property in Vermont, she had always longed for a dog of her own. "I did not grow up with one single dog, one single cat, nothing. My mom always jokes that I came out of the womb asking for a dog." After graduating and moving to Boston to rejoin her family, she set out to acquire a dog. "I always wanted a golden retriever, but after educating myself about breeders, I thought that the best choice was to rescue a dog because there are so many animals out there looking for homes," Donleavy recalled. Browsing Petfinder.com for weeks, Donleavy stumbled upon "Ace," a black Labrador Retriever/border collie mix puppy at a rescue in Arkansas. Smitten, Donleavy completed the adoption application. When her application to adopt Ace was approved, "I was completely and utterly over the moon. That same day I went into every pet boutique in our area and showed every employee (that was willing to listen) a picture of baby Ace's face, while cleaning out their inventory," she wrote on the dogs' web page, [www.knoxandbear.com](http://www.knoxandbear.com). Donleavy picked up the puppy, renamed Bear, about a month later from a transport in Connecticut and joyfully brought him back to her home on Appleton Street. The novice dog owner was not initially surprised by her puppy's calm, sleepy behavior, but soon found out that he was actually critically ill with Parvovirus. An

alert veterinarian at Back Bay Veterinary Clinic kept Bear under observation on an IV and then referred him to Angell Animal Medical Center at the MSPCA on South Huntington Avenue, where he was hospitalized for four days. Donleavy believes that Bear is an "old soul" as a result of his early brush with death.

The second dog, Knox, came Donleavy's way unexpectedly when a neighbor told her of squalid conditions at the breeder from which she obtained her Golden Doodle. Upon visiting the breeder in early 2015, Donleavy found over 60 dogs in various states of abuse and neglect and a breeder who was no longer interested in caring for them. While she wasn't planning on adding another dog to the household at the time, she decided to rescue a purebred English Golden Retriever-American Labrador puppy that she named Knox. "Integrating Knox was interesting for Bear because he was the prince of the house and got all of the attention and all of a sudden there was this little puppy. They hit it off and now they are the best of friends," Donleavy said. Harper, a reddish mixed-breed female puppy at a high-kill shelter in Arkansas, completed the pack when Donleavy was again browsing Petfinder.com and became enchanted with her big eyes and wrinkly face. Harper arrived via transport in June, 2015. Donleavy calls Harper the head of the pack. "She definitely keeps everyone in line," Donleavy observed.

Her passion for dog rescue has extended beyond her own household, spawning the dogs' web site, [www.knoxandbear.com](http://www.knoxandbear.com); their Instagram page, [www.instagram.com/knox\\_and\\_bear/](http://www.instagram.com/knox_and_bear/), which has over 40,000 followers; a Knox and Bear Facebook page; and story and photo coverage in Modern Dog Magazine, Boston.com, TheDogist.com, and People Magazine's Twitter account, @PEOPLEPets. "It just grew out of the whole rescue component. Rescue dogs in the city is a big thing that people love

seeing. We are able to leave the city with them and take them to the parks, on hikes and on vacation. I think that people like seeing a family with this many rescue dogs and that there are options." After becoming aware of Knox, Bear and Harper's on-line presence, photographer Lauren Dobish reached out to Donleavy and offered to snap the dogs gratis in a photo shoot in the Seaport district.

Donleavy originally created the Instagram site in order to post the hundreds of pictures she's taken of the dogs without casting herself as a "crazy dog lady" on her own Instagram feed. Now the Knox\_and\_Bear site has revealed itself to have other applications. "I just started it for fun; I didn't realize it would have this marketing component," Donleavy said. While Donleavy uses the dogs' on-line sites to promote dog- and rescue-related events and groups, her deepening involvement in the animal-lover community has guided her career as well. With a post-graduation stint at the international public relations firm MSL Group under her belt, Donleavy was able to parlay her skills into her current position in marketing and investor relations with Slobbr, an app that will provide information on pet-friendly restaurants and lodgings, services and supplies set to debut shortly in New York and Boston.

With Donleavy's help and PR savvy, Bear, Knox and Harper have lent a paw to a number of causes. For example, a bandanna "autographed" with Bear's paw print will be auctioned off to benefit the MSPCA in conjunction with its Fast and Furriest 5K

fundraiser on Sunday, May 22. "We are just figuring out how we can help all the rescues with all the followers we have," Donleavy said. Her current employer similarly backs rescue fundraisers. Slobbr was co-sponsor with Audrey's Rescue Angels of Rescue to Runway, a benefit fashion show featuring local celebrities and adoptable dogs.

For someone with no previous canine experience to take on three large, young dogs in less than a year's time is quite a challenge, but because she is passionate about her dogs and a quick study, Donleavy has navigated a steep learning curve deftly. Managing the exercise and elimination schedules of three large dogs while living in a Boston apartment with no dedicated outdoor space has been the biggest challenge. She explained, "The biggest thing is not having a yard. The three dogs have their own schedules to go out and that's been challenging because you can't just open the sliding door and let them out. I walk them all separately. We do have the benefit of having parks everywhere but it is a challenge finding time to take them all out." Donleavy, who works mostly from home, sometimes sends the dogs to the Urban Hound for daycare as her work schedule requires and credits her father with helping her both with dog-walking duties and the cost of daycare.

Are there more dogs in the future for the Donleavy household? "I would love to have more but I think we are maxed out at three. I would love to rescue them all," Donleavy said.

front of a 10-foot bronze statue of famed abolitionist and freedom-fighter Harriet Tubman, by artist Fern Cunningham. Important to note is that this particular statue was the first statue on city-owned property honoring a woman in Boston.

Tubman, who had spent the first 28 years of her life toiling in the household and fields of the Maryland plantation where she had been born, she escaped when the plantation's owner died, following the North Star and stopping at various Underground Railroad 'stations' along the 90-mile journey to Pennsylvania.

For her efforts freeing other enslaved people famed Boston abolitionist William Lloyd Garrison called her "Moses" for she, like the Moses of the Old Testament, returned to lead numbers of other people out of bondage, to freedom and the "promised land". 'Mother Moses' is depicted standing erect and out in front of a small group of people of African descent who appear tired and frightened. While she appears steadfast, resolute, and unafraid with a Bible clutched in one hand and her other hand extended outwards gesture in a gesture as if she is pointing the way to freedom to those who surround her.

As I sat in the park last Wednesday afternoon the 20th April, after Jack Lew, Secretary of the Treasury announced to the nation that this same Harriet Tubman, the woman who had escaped her captivity and who time after time would then risk her new found freedom to liberate other enslaved people would replace former President, Andrew Jackson, himself a holder of slaves, on the front of the \$20 bill; making her the first American woman to adorn US paper currency in more than a century. I was reminded of the words of another great foot soldier for justice and freedom Nelson Mandela who once said "There is no easy walk to freedom anywhere, and many of us will have to pass through the valley of the shadow of death again and again before we reach the mountaintop of our desires."

As I sat there in the park I recalled watching Viola Davis, when she won Outstanding Lead Actress In A Drama Series for her role in "How to Get Away with Murder" at the 67th Primetime Emmy Awards show, making her the first black woman to win the award begin her remarks with the following quote by Harriet Tubman:

"In my dreams and visions, I seemed to see a line, and on the other side of that line were green fields, and lovely flowers, and beautiful

white ladies, who stretched out their arms to me over the line, but I couldn't reach them no-how. I always fell before I got to the line"

As a member of the board of Park, whose president is renowned Boston activist Frieda Garcia and as the great grandchild of people who were themselves enslaved, this yearly ritual of reverently and gently washing, waxing and buffing the statue, both in an effort to protect it from the harsh elements of city life, and to also ensure that its majesty is not diminished. The significance of the contribution made by 'Mother Moses' to so many by during her lifetime, and beyond, is certainly not lost on me. I am overwhelmed with gratitude as I wash her feet and outstretched hands and as I gently wash her face find myself saying softly into her ear "thank you"; and that I along with many others remember and are grateful because you dared to take your freedom from those who held you captive and also worked to free so

many others as well.

Over the course of the past week anonymous individuals have visited the park and placed bouquets of flowers at the base of the statue. Someone even placed a dozen long stem roses in Tubman's hand, held high as in a triumphant gesture. As a nation and as a society do we still have much work before us to do – without question, we do – but that Wednesday, for a brief moment Tubman's words echoed in my head as I sat in a park in Boston, dedicated to her legacy of courage and steadfastness: "Every great dream begins with a dreamer. Always remember, you have within you the strength, the patience, and the passion to reach for the stars to change the world."

The decision announced on Wednesday to add Harriet Tubman's face to our nation's most traded piece of currency to some, might seem a mere gesture to some, but to others of us it holds very special meaning and significance.




