Chef Marisa Iocco serves food with love

When Chef Marisa Iocco arrived in Boston from Abruzzo in central Italy in 1989, she spoke no English but quickly discovered she could communicate through her cooking. Cibo con amore (food with

love) is her motto it has permeated her culinary offerings throughout her career. She and partner Rita D'Angelo, also of Abruzzo, hit the ground running, endearing themselves to Bostonians with genuine and delicious renditions of classic Abruzzese fare at their first restaurant, the Theater District's Galleria Italiana in 1990. known as "The Girls", Iocco and D'Angelo, the front-of-the-house personality, branched out into the South End and Italian-fusion cuisine with La Bettola, then the South End Galleria. "Our being called 'The Girls' was from our time at Galleria Italiana, and when we went into the South End, we were already known that way because of the different jobs we'd done together," Iocco explained. While Iocco dazzled the locals with her own culinary creations, she and D'Angelo recruited other great talents to join them. Galleria Italiana is also remembered as a launching pad for chef Barbara Lynch, and "the girls" lured Rene Michelena, an alumnus of Chicago's Charlie Trotter's restaurant to Boston to work magic at La Bettola.

Iocco lived and worked in the South End, and she came to love the neighborhood just as it loved her food. She recalled, "I fell fast for the South End because I always loved it for how it felt like a multicultural neighborhood. And now, the North End has become the same." She continued, "I miss a lot from

the South End; walking in the morning with my dog Tosca and sharing coffee with people who were out doing the same. Sometimes, it was a little overwhelming to see so many people you'd know; but most of the time it was a beautiful way to see friends. I met people, and we'd know each other through the names of our dogs. I loved the fact that the mentality was an open-minded mentality. It worked for me." Ultimately, the South End's rapid development and rising prices made it impossible for her to stay. "Leaving the South End wasn't a choice at all," she said. South End Galleria and Galleria Italiana closed in the early 2000s, and Iocco became executive chef at Bricco in the North End. As chef at the North End's Gennaro's 5 North Square since 2012, Iocco draws upon her Abruzzese heritage as well as Italian-American culinary tradition with her menu, which she calls MangiAmerica (eat, America). MangiAmerica features favorites that every Italian-American boy and girl grew up with at the family table, including sausages and polenta, pork chops with potatoes and vinegar peppers, manicotti and the centerpiece, Sunday gravy with meatballs, sausage and braciole (thinly sliced, rolled, stuffed beef). While some chefs and foodies view

Italian American cooking as Italian cuisine's poor relation, Iocco, who is now an American citizen, embraces it as part of the tradition of her adopted country.

While Iocco's execution is impeccable, as evidenced at a recent lunch at Gennaro's with samplings of ravioli with tomato-basil sauce, butternut squash ravioli and vegan, vegetable-stuffed ravioli with saffron sauce and a Caprese appetizer with fresh mozzarella, ripe tomato slices, basil and balsamic vinegar, her focus on fresh, local produce and other ingredients reminds this writer of visits with relatives in small Italian towns where everything is home-grown and handmade. Lunch at Gennaro's was also reminiscent of my travels and meals with family in Italy in that tutto era squisito (everything was delicious). This emphasis on freshness and artisanal products reflects the food traditions with which she was raised in her hometown of Orsogna. Surprisingly, Gennaro's also has an inventive vegan menu, part of Iocco's ethic of inclusiveness. Iocco served the vegan meatballs at lunch and they were a worthy evocation of the real thing.

Recently, Iocco's drive and restless creativity have spawned her first book, "Every Menu Is a Love Story (Ecco Perché Amore),"

a memoir of life and food from which she previewed at a May 5 reading at Gennaro's as part of ArtWeek Boston; and an intimate new eatery with restaurant owner Gennaro Riccio called Scopa, which will open at 319 Hanover Street in the North End on Thursday, May 26. Named for an Italian card game that is a favorite pastime of retirees in the piazzas of countless small Italian towns, the 25-seat Scopa will have a farm-to-table focus with as many organic and locally grown ingredients as possible as well as specialty ingredients such as imported Italian pasta flours.

Iocco has already climbed many mountains, including coming to the US with not a word of English to authoring an English-language book and becoming the first Italian-born, female chef in Boston, offering both traditional dishes and daring innovations. What peaks does she hope to conquer in the future? "I want to offer my time and my culinary expertise to kids, to teach them and have fun with them, maybe create something that will raise money for children who want to study to become chefs and most important, to enjoy the flavor of foods with young people here, in Italy or in any part of the world. That's one of my dreams."

Dogfight Transforms

What does it mean to be a Marine? At the same time, what does it mean to be a man? The recent award-winning Off-Broadway musical "Dogfight" (the 2013 Lucille Lortel best musical) respects the standards of the former even as it probes the essence of the latter. The lively Benj Pasek-Justin Paul score and the candid Peter Duchan book (based on the 1991 film of the same name) offer a tunelessly disarming answer—the insight that the love of an empowered young woman can turn a clueless young recruit into a man of stature. In a similar manner, SpeakEasy Stage Company has turned the show's area premiere at the Calderwood Pavilion into a transformative experience in its intimate three-quarter round configuration of the Roberts Theatre.

Eddie Birdlace, the transformed youth in question, is one three tough-talking chauvinistic recruits. Very different from the World War II Navy trio of the Bernstein-Comden and Green classic "On the Town," Birdlace, Boland and Bernstein are much closer in their respective emotional situations to the Vietnam War threesome of the gritty Billy Joel scored show "Movin' Out." That kind of grittiness pervades the title first act San Francisco-set Marine contest in which the recruit judged to bring the 'ugliest' date wins the pot. Triumphant Boland looks worse than his equally cocky best friends (the trio are known as the three Bees) in bringing a prostitute named Marcy and later trying to cheat her out of her fair share of the winnings.

Are Birdlace, Boland and Bernstein "The Few the Proud the Marines"? They are certainly not in treating women like pawns in the first act. They have much more to be proud of in the second act combat—where they live up to the Marine ideal of "Semper Fidelis" with total commitment to each other. Ultimately,

though, only Birdlace rises above sexism and stereotyping to attain the soulfulness of unassuming waitress Rose Fenny and champion the inner strengths of a fully tested Marine. Long after leaving the Roberts Theatre, theatergoers

BRA seeks change

In response to this change, which can be done by vote of the BRA Board because this parcel—and the entire South End—is still an Urban Renewal zone, the Boston City Council Committee on Planning and Development, will hold a public hearing this THURSDAY, MAY 26, 2016 at 11 AM in the Council chambers. Members of the public are invited to attend and testify.

The order for the hearing was filed by South End councilors Frank Baker and Bill Linehan following concerns expressed by the South End Forum that nothing has been publicly disclosed about plans for this parcel and that a zoning change affecting this major parcel should not move forward until the neighborhood has had an opportunity to learn what is currently known and planned for the site, including disclosure of the buyer and

their known development plans. Southenders and the press have been unable to learn any of the details about the sale of this parcel due to mutual non-disclosure agreements by the seller and buyer. However, now that a zoning change has been requested, the BRA has indicated that buyer and plans will be disclosed at the public hearing, and neighbors will have an opportunity to comment.

While this zoning change is considered to be a "minor" modification under the statutory Article 80 development provisions, as part of the agreement for extending Urban Renewal authority for an additional 6 years, the BRA agreed to give the City Council formal notice of all major and minor modifications and co-operate in permitting a public hearing process to take place rather than just process changes exclusively through the BRA Board.

Southenders should be aware that this parcel is of unprecedented size in the history

of South End development. Because no public disclosures have been made about potential uses of the parcel, rumors and speculation have naturally appeared in the press and elsewhere ranging from a support, service, and parking facility for a Widdett Circle stadium by the Kraft organization, to a support facility for biomedical research affiliated with the BU biolab. On Thursday at the City Council hearing, the buyer will finally be announced and Southenders will know what is planned by the buyer for this multi-acre site.

Most Southenders are generally hopeful that plans will involve creative mixed use development (commercial/residential) with significant open space/parkland provisions together with careful consideration of and solutions for transportation infrastructure impact and challenges.

will find themselves easily embracing "Dogfight"'s simultaneous validation of women and diversity in a musical with strains of "West Side Story"'s exuberance and "Spring Awakening"'s folk wisdom.

"Dogfight" is as much of a transformative odyssey as a gritty look at diverse views of humanity. SpeakEasy artistic director Paul Daigneault vividly captures the disturbingly sexist first act rite of passage the trio share and the second act blossoming love of Eddie and Rose. With the help of fight choreographer Greg Maraio, he makes Birdlace's remembrance of actual combat properly

disturbing. Choreographer Larry Sousa evokes the spirit and bravado of the focal three (and other recruits) in high-stepping routines and properly expansive stage movement—particularly in numbers like "Some Kinda Time" and the flashy second act-opening "Hometown Hero's Ticker Tape Parade." Jordan J. Ford proves very compelling as initially clueless Eddie who becomes a real man as he falls in love with very engaging Rose. Alejandra M. Parilla's finds all of Rose's sweetness and down-to-earth dignity. Ford and Parilla have the right appealing tentativeness on their affecting duet "First Date, Last Night." Troilo is a standout as Bolland, combining sharp gesturing, strong demeanor and resonant tenor singing—especially as Bolland

flexes his would-be leader muscles rivaling Birdlace in the "Parade" Marine ensemble. Also noteworthy in support are Drew Arisco's plucky Bernstein and McCaela Donovan's unsentimental Marcy. Troilo and Donovan bring no-holes barred tenacity to Bolland and Marcy's riveting face-off. Music director Jose Delgado easily catches the score's eclectic reach-from folk material calling to mind "Spring Awakening" and discordant strains a la "Movin' Out."

At a time of renewed sexism and xenophobia, SpeakEasy Stage's exuberantly disarming "Dogfight"—to borrow from the title of a Rose solo—is nothing short of wonderful.

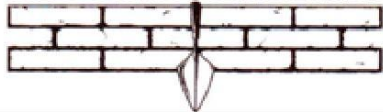
