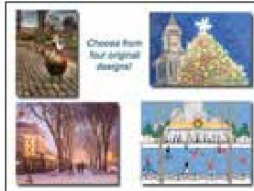

Tenants in Action) began its celebration of its 50th year.

IBA began as the Emergency Tenants Council (ETC) in 1968, when a group of Puerto Rican residents fought the demolition of their homes under the Boston Redevelopment Authority's Urban Renewal plan and, with an alliance of community activists, worked with

## ASK DOG LADY



**Advice on Pets, Life, Love**

Dear Dog Lady,

The woman who wrote to you about traveling with her dog first

needs to contact the country where she's traveling so she can determine the requirements for canine entry. Certain countries require a passport for the dog.

You incorrectly stated the cargo areas of planes are not pressurized. Nearly all planes have a small section in the cargo hold that is pressurized and temperature controlled. This particular section is reserved for a casket returning a deceased person for burial or for a large dog kennel.

The deceased person has priority over the dog. If the space is not available, the dog and owner will

be rebooked.

The size of the dog is not an issue as I have flown with my Irish wolfhound for years. Should a proper flight kennel not be available from Pet Smart, one can be ordered from Amazon.

Depending upon the country of entry - a vet may be present to examine the dog before entry is allowed.

Many airports now have pet parks and the dog can be unloaded between flights for water and a walk; benches are available for the dog's companion.

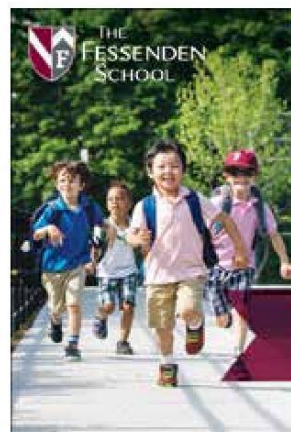

Dear Marjorie,

Thank you so much for clarifying about the comfort and convenience of unloading your precious freight into the hold of major carriers. As you know because it prompted you to write, *Dog Lady* incorrectly stated that all cargo areas in planes are not pressurized for dog travel in steerage.

However, readers, before you blithely book your dog for air travel, please check with your airline about the rules of unloading this living baggage. For example, not all cargo holds are suitable for animal conveyance. The temperature in these spaces of an aircraft is not so keenly monitored as in the human passenger cabin. When it's too

is part of her heritage. A waitress at La Motta's on Washington Street, Kelleher-Palmarin asked her manager about a benefit.

The Aquitaine Group, which operated LaMotta's, went above and beyond that and proposed a fundraiser, Boston Loves Puerto Rico, which took place on October 17 at La Motta's. Partygoers enjoyed Italian-style appetizers, two included drinks and the chance to win raffle prizes.

One hundred per cent of the benefit's proceeds will go to hurricane relief to be delivered through the local, all-volunteer group Boston Mothers Care.

The fundraiser sold out at 125 tickets, with additional donors giving the \$50 ticket price as a donation and more than one benefactor matching a portion of ticket sales. "So many people who couldn't make it donated ahead of time. I can't wait to tally up [the proceeds]," La Motta's manager Joyce Parlapiano said.

Boston Mothers Care continued to accept donations through October 31, raising approximately \$25,000 in addition to donations of supplies that were collected separately. Board members of Boston Mothers Care, which came together 7 years ago to provide support after the massively damaging earthquake in Haiti, will personally take the donations to Puerto Rico, where they will distribute them to communities in the rural northwestern area of the island.

"The community really came together. It would not have been possible if it weren't for every single person who donated items and bought tickets. We sold out in a week," Kelleher-Palmarin said.

Kelleher-Palmarin, whose paternal side is from Aguadilla, PR, is the cousin of Boston Mothers Care founding member and vice president, Inés Palmarin. South End realtor Mary Kelleher, Kelleher-Palmarin's mother, beamed with pride at her daughter's caring. "After the hurricane, Tessie called me up and said, 'Mom, the family in Puerto Rico are suffering. I have to do something.'"

the city to develop Villa Victoria, the affordable housing community that sits in the heart of the South End.

Over its 50 years, IBA has evolved into a complex community development corporation offering cradle-to-grave services to help meet the educational, vocational, cultural and social needs of a predominantly Puerto Rican but increasingly diverse population.

The reception offered a generous buffet of cold appetizers as well as butlered small plates of gnocchi with mushrooms, steak, shrimp and a variety of desserts accompanied by complimentary beer, wine and sparkling water.

Speakers at the early-evening reception included Paul Crogan, president of the Boston Foundation; Micho F. Spring, former aide to Mayor Kevin White and the city's first Latina deputy mayor, now New England president of Weber Shandwick communications group; Thomas Melendez, investment officer at MFS Investment Management; David's CEO Steve DiFilippo and IBA CEO Vanessa Calderón-Rosado.

Spring, who came to the US from Cuba as a small child, worked closely with Jorge Hernandez and other IBA founders and planners as deputy mayor in the White administration. "I got involved because of Jorge Hernandez's involvement with city hall but I stayed involved because of Vanessa's incredible leadership," Spring said.

Guests included state senator Sonia Chang-Diaz, state representative Byron Rushing, who represents a portion of the South End; Rushing's wife, Frieda Garcia, longtime executive director of United South End Settlements; Jay Ash, Secretary of the Massachusetts Executive Office of Housing and Economic Development; and Jabes Rojas, Deputy Chief of the Massachusetts Office of Access and Opportunity.

IBA staff including chief operating officer Mayra Negrón-Rivera, IBA Arts director Elsa Mosquera Sterenberg and senior program director Rafael Medina were also on hand to talk about the anniversary celebration and

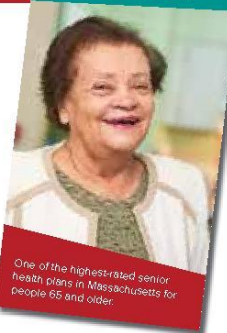
