
major contributions to elevating the health status and health outcomes of the diverse populations in Boston.

NOTICE OF A PUBLIC HEARING

A Design Public Hearing will be held by MassDOT to discuss the proposed Reconstruction of Melnea Cass Boulevard project in Boston, MA.

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed Reconstruction of Melnea Cass Boulevard project. All views and comments made at the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: The mile long Complete Streets focused Reconstruction of Melnea Cass Boulevard project looks to enhance public safety and provide multi-modal travel options for all users while serving the regional traffic demand on the corridor. The project will reconstruct all pedestrian and bicycle facilities, reconstruct roadway pavements, update traffic signal equipment, enhance storm-water management, invest in landscape architecture, and include protected intersections. The proposed typical roadway cross-section will include two 10.5 foot travel lanes in each direction with 10.5 foot turning lanes. Sidewalks ranging from 7 to 8 feet in width will be provided along both sides of the Boulevard. Bicycle accommodations consisting of 6 to 8 feet wide separated bike lanes are provided in accordance with applicable design guides.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The City of Boston is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be discussed at this hearing.

Written views received by MassDOT subsequent to the date of this notice and up to five (5) days prior to the date of the hearing shall be displayed for public inspection and copying at the time and date listed above. Plans will be on display one-half hour before the hearing begins, with an engineer in attendance to answer questions regarding this project. A project handout will be made available on the MassDOT website listed below.

Written statements and other exhibits in place of, or in addition to, oral statements made at the Public Hearing regarding the proposed undertaking are to be submitted to Patricia A. Leavenworth, P.E., Chief Engineer, MassDOT, 10 Park Plaza, Boston, MA 02116, Attention: Highway Design, Project File No. 605789. Such submissions will also be accepted at the hearing. Mailed statements and exhibits intended for inclusion in the public hearing transcript must be postmarked within ten (10) business days of this Public Hearing. Project inquiries may be emailed to dot.feedback.highway@state.ma.us. This location is accessible to people with disabilities. MassDOT provides reasonable accommodations and/or language assistance free of charge upon request (including but not limited to interpreters in American Sign Language and languages other than English, open or closed captioning for videos, assistive listening devices and alternate material formats, such as audio tapes, Braille and large print), as available. Consulting LLC, Old Boston Restorations and Boston University endowed full and half scholarships.

Dozens of residents and businesses donated silent and live auction items to satisfy a wide variety of desires such limited-time memberships and classes at Boston Sports Clubs and Endurance Pilates, an evening of dinner and drama at Kava Restaurant and the Lyric Stage and a pair of Red Sox tickets donated by diehard fan and scholarship supporter Nancy Wall Farrington.

Trumpeter Matt Hull, a Berklee graduate and former B/FSNA scholarship recipient, set a festive musical mood with his trio. Hull's mother, Deborah, a member of the scholarship committee, made a donation to cover college application fees.

Among the ten-member committee are

David Wisholek, who greeted guests at the registration table at Heart of Gold and his husband Christopher McBride. The couple got involved in the scholarship committee early on and have remained active since moving to Winchester in the summer of 2015.

Guests included South End/Bay Village liaison Faiza Sharif, state representatives Byron Rushing and Aaron Michlewitz and Mayor Martin J. Walsh, who was unable to appear at last year's Heart of Gold due to a snow emergency. Walsh congratulated the scholarship committee on the success of its program and, looking around at the room filled with well-educated professionals, exhorted the young adults in the group to share their knowledge and talents with neighborhood youth as mentors.

Rushing echoed that message, inviting guests to visit and become familiar with neighborhood schools and students and to volunteer with local youth to provide inspiration. "I just want to tell the Mayor he stole my speech," Rushing quipped, "but he's absolutely right.

We have public schools in the South End: the Blackstone, the Hurley and the Quincy. Everybody here should visit the public schools in our neighborhood. Just go in and they will take you around. Go and see what it's like and find a space for yourself [to volunteer]."

The 2017 scholarship recipients, Kenny Mei, a freshman at Northeastern University, expressed his gratitude for the scholarship, noting that many things cost more than he expected once he arrived at Northeastern, while Nicholas Antoine, who started out in community college before transferring to Mount Ida College, said that the scholarship will pave the way for him to join his family's funeral home business.

The event brochure and auction-bidding card offered a timeline of the scholarship's growth, starting in 2007 with two scholarships totaling \$550. Shortly before press time, Wisholek reported 2018 proceeds of \$30,775, with additional donations still arriving.

Reflecting on the event, Jenks said in a

follow-up e-mail, "What I love about our Heart of Gold event is that it appeals to South End neighbors from all neighborhoods, all ages and all backgrounds. There were twenty-somethings and eighty-somethings and everything in between. Our friends from United South End Settlements (USES), South End Community Health Center (SECHC), St. Stephens Youth Program (SSYP), IBA, Boston University, Washington Gateway Main Street, South End Soccer, and many local business owners and professionals came out to show support for the B/FSNA Scholarship Program benefitting our young, college bound neighbors.

It feels good to live in a community that cares about young people and enjoys coming together to make a difference in their lives." Scholarship founder and co-chair Andrew Parthum commented, "Every year I'm excited and pleased with the fundraiser. It keeps exceeding my expectations."

and subsequent book co-authored with Pulitzer Prize-winning journalist Kenneth J. Cooper were honored at the event. Through original theater and soul-stirring music, young people in attendance were encouraged to overcome obstacles and work with their schools and communities to help create a city and world with a fair and level playing field for all.

"I'm proud Boston City Hall is hosting this unique event," said Mayor Martin J. Walsh. "Boston is constantly striving to become a more equitable, inclusive city for all, and events like these help lift up our young people, and show them what is possible when we work together to move Boston forward."

The event featured an original theater presentation written and directed by Elaine T. Koury, artist, educator and founder/former director of the legendary Boston Youth Theater and inspired by the Don West's exhibits and book with Kenneth J. Cooper. That exhibit and book capture the images and stories of 110 African-American leaders and their diverse allies who have contributed to the advancement of the Black community in Greater Boston. The catalytic partnership of Eastern Bank made this book possible.

This event focused on "THE NEXT GENERATION," an audience of 120 BPS high school students who have been identified as emerging leaders by their school communities.

"By giving voice and presence to the Black community's struggle to make Boston a more just and equitable city for all, we encourage students to overcome obstacles in the practice of their rights and in pursuit of their dreams," said event producer Libbie Shufro, Director, Portraits of Purpose Educational Initiative and former CEO of The Boston Center for the Arts (2001-2008).


Through projected images, original theater and dramatic storytelling, the event animates a chapter of a people's history and leadership for social change often overshadowed by the racial violence that emerged around court-ordered busing and desegregation of the Boston Public Schools in the 1960's and 70's.

Students received a copy of the book Portraits of Purpose: A Tribute to Leadership signed by co-authors Don West and Kenneth J. Cooper and have the opportunity to meet the cast and the many Portraits of Purpose honorees/guests present. The program booklet offers a resource guide to help students continue the dialogue on issues important to them and get involved to make a positive difference in their schools and communities.

The event was produced by the Portraits of Purpose Educational Initiative whose mission is "to plant the seeds of justice through arts and dialogue," and was made possible by the generous support of Eastern Bank, TJX, Harvard Pilgrim, Seyfarth Shaw LLP and in collaboration with the Boston Public Schools, Mayor's Office of Arts and Culture, DesignLight and the John D. O'Bryen African American Institute at Northeastern University.

Hype is Rousing

For Idris Goodwin, hip-hop has served as a catalyst for wisdom and truth. In his exuberant 2012 "How We Got On," the African-American poet-playwright examines the 1980's coming of age of three black teen rappers.

In Goodwin's affecting 2016 comedy "The Realness: A Break Beat Play," A 1996 African-American romance is tested as much as the authenticity of a novice rapper. Now Goodwin has honed in even more on both the style and the substance of hip-hop in a three-character dramedy called "Hype Man: A Break Beat Play," a rousing Company One world premiere that should have all audience members at the Boston Center for the Arts' intimate Plaza Theatre moving to the infectious beat of its poetic and powerful truths.

"Hype Man" takes its title from the back-up rapper-singer—here memorably named Verb—who supports the primary one with exclamations, interjections and enhancing deliveries that help excite an audience. Intriguingly in Goodwin's disarming play, the primary rapper or front man Pinnacle is a white best friend who has been performing

with Verb since childhood. Pinnacle's name may be ironic since the pair, along with an African-American beatestablisher named Peep One, are preparing for the professional chance of a lifetime—namely, a slated appearance on The Tonight Show.

Up to this point, all seems to be leading toward their highly anticipated success. Goodwin, though, is too sharp a writer to be satisfied with a feel-good, sometimes humorous buddy effort. Instead, he compellingly has Verb and Pinnacle by turns grapple with the challenge of singing out for social justice in their art in the face of an 18-shot police shooting of an African-American 17-year-old named Jerrod. At first Pinnacle resists publicly reacting, but activist Verb daringly reveals a "Justice for Jerrod" T shirt under his shirt at one of their concerts.

The white front man speaks of their unseen agent Ryan trying to keep police unions from picketing their performances and some sponsors backing out. Still, Pinnacle ultimately does take a moral stand in both lyric and performance.

Not stopping here, Goodwin's tight, thematically dense play has Peep One remind both men that women are often maligned in rap lyrics and need the same social justice as African-American men. "Hype Man" stirringly reaches a kind of musical epiphany of solidarity.

Verb warns on megaphone "no justice, no peace," and Pinnacle sings of bringing moral resolve to the populace. At this point,

even the priority of appearing on The Tonight Show gives way to moral principle. Tellingly Verb declares, "Being a hype man is not being a cheerleader. It's about celebrating myself." In a similar vein, Pinnacle counsels, "Grind on with the mind strong."

Under Company One artistic director Shawn LaCount's seamless guidance, all three cast members keep their characterizations just as strong. Michael Knowlton has all of Pinnacle's high energy and volatility, and his funky moves and gesturing have the authenticity of real rapping. Kadahj Bennett is electrifyingly dynamic as Verb. He also doubles effectively as music director and beat maker. Knowlton and Bennett make the friends' volley-like banter fully riveting.

Rachel Cognata finds the perfect bal-

ance as mediating but always strong-willed Peep One. Jen Rock's nuanced lighting and Lee Schuna's vivid sound design match the poetry of the play and its vivid rap sequences. Special kudos go to dramaturg Jesse Baxter and assistant dramaturg Tatiana Isabel Gil for their informative pieces in the highly helpful playbill.

Company One has done yeoman work bringing the music and magic of "How We Got On" and now "Hype Man"—the first and last parts of Goodwin's distinctive break beat trilogy to local theatergoers (with special credit to Lowell's Merrimack Repertory Theatre for having staged "The Realness" in between). To borrow from Verb's own advisory near the end of the play, audience members will want to get up and echo the play's soulful humanity.


