### Bring Back the Funding for Blackstone School

With the new proposed budget for School Year 2019-2020 the Blackstone will be facing yet another big budget gap. If this projected budget is approved it will take away approx. 500,000 from the existing budget, as the school transitions from 'Innovation status to 'Schedule A'.

The following positions will potentially be cut:

- 1.1 Multiple Disability teacher
2. School Counselor

3. 2-3 Inclusion Strand Coordinators

4.1 Family and Community outreach coordinator

5. 2 Community field coordinators

The District's funding formula does not take into account the complex needs at the Blackstone School. Over 90% of the Blackstone's students are designated as "High need" by the district. In addition, the Blackstone has been out of compliance for our English Language Learners (ELLs) for years. The plan

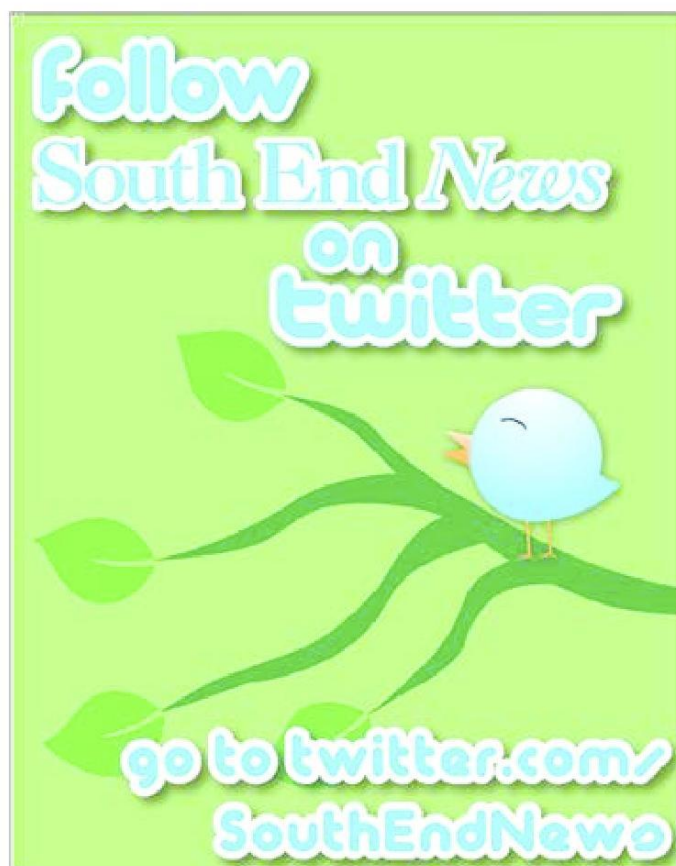

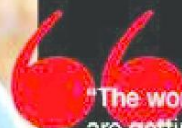

### Parking Permits

You may download the necessary Resident Parking Permit and bring it to City Hall. In addition to the application form, the following two pieces of information must be presented at the Office of the Parking Clerk when applying for a permit:

1. A valid Massachusetts automobile registration showing your car registered and principally garaged in your name from your current Boston address.
2. One of the following proofs of residency bearing your name and Boston address. The

proof of residency must be current-postmarked within the past 30 days: Gas, Electric or Telephone Bill, Cable Television Bill, Monthly Bank Statement (excluding mortgage), Credit Card Bill, Water and Sewer Bill.

### Pet Licenses

You must register your dog using the following guidelines:

- Pit Bulls and Pit Bull Mixes: \$50. Also required: Proof of ownership of home or letter of permission from landlord stating that you are allowed to have a pit bull or pit bull mix; Recent photo of your dog no older than 30 days; Recent photo of the owner no older than 30 days; Proof of rabies vaccination; Proof of spay/neuter.
- Unspayed and/or unneutered dogs \$17. Also required: proof of current rabies vaccination.
- Spayed and/or neutered dogs \$6. Also required: proof of current rabies vaccination; proof of spay/neuter.

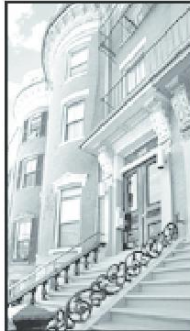

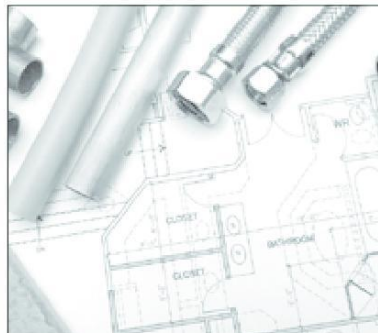
