## Joe "Thailand" Yuvayongdee

South End restaurateur Joe Thailand passed away Sunday November 24th after a sudden illness.

His given name was Banjong Yuvayongdee when he was born in Bangkok in 1952, but in Boston he was known to all as Joe Thailand—owner of House of Siam on Columbus Avenue and House of Siam on Tremont Street. He might easily have

been called Joe South End given his love for the neighborhood. With his ear-to-ear grin and affable personality, Joe has been a beloved fixture in the South End since he opened House of Siam on Columbus Avenue on the auspicious date of April 13, 1998 (Thai New Year).

Dear Alexandra,

Oh yes, neutering a male dog of any age is the responsible thing to do. Spaying and neutering dogs is so important for the animals' health and welfare as functioning members of canine and human society. You're doing the right thing for the toy poodle — both castrating him and providing a new home.

would express such a view. Admittedly, there may be characters in the mystery with humorous touches—notably the great Belgian sleuth Hercule Poirot himself with his signature walk.

Still Agatha Christie buffs (including this critic who read most of her mysteries in his earlier days) might argue that this mystery gem has more in common with film noir. Tellingly, this is the genre which producing artistic director emeritus Spiro Veloudos brought up significantly during the Lyric Stage Company rehearsal period (see his playbill interview with acting artistic director Courtney O'Connor) for the company's striking current staging of "Agatha Christie's Murder on the Orient Express."


With that affinity in mind, Veloudos has ingeniously created a kind of atmospheric symbiosis with Brynna Bloomfield's stylish scenic design and Seaghan McKay's artistic projection design. Bloomfield's strain interiors design calls to mind Art Deco patterns and the cubist styles of Picasso and Leger. McKay provides film noir expository visuals about the pivotal Daisy Armstrong murder case as well as vivid representations of the Express and the areas it passes. Add kudos for Scott Klyve's richly complementary lighting—with poetic moments of shadow—and Gail Astrid Buckley's finely varied costume design for the ethnically diverse suspects—particularly the elegant evening wear of Princess Dragomiroff and Countess Andrenyi.

One can argue about Ludwig calling this mystery a comedy and reducing the book's

suspects to eight (especially the removal of Count Andrenyi), but Veloudos' sharp ensemble make the interrogations by Poirot and the brilliant denouement fully absorbing. Standout Remo Airaldi has all of Poirot's charm, wit and Sherlock Holmes-rivalling smarts. The veteran actor (with notable work at the Lyric Stage Company and American Repertory Theatre among others) turns Poirot to his most difficult case into a tour de force.

The supporting cast members work well with Airaldi and with each other. Kerry A. Dowling captures Helen Hubbard's talkative nature and Midwestern directness; this gifted singer even gets to sing briefly from "The Lullaby of Broadway." Celeste Oliva makes Countess Andrenyi charming and alluring enough to make Poirot wish that he were younger. Rosa Procaccino combines Mary Debenham's vulnerability and nervousness, and Davron Monroe has her lover Colonel Arbuthnot is properly protective as Poirot questions her. Monroe also convinces in the minor but flashy role of murder victim Samuel Ratchett. Sarah de Lima catches Dragomiroff's haughtiness in her voice and her body language, while Marge Dunn finds her maid Greta Ohlsson's diffidence. Will McGarrah is very convincing as Orient Express Wagons Lit director and Poirot former colleague Monsieur Bouc.

Poirot's solution—or 'two' solutions—resembles "a magic trick." Likewise Veloudos' direction of "Agatha Christie's Murder on the Orient Express" itself proves magical.

followed ten years later.

Joe came to the US in 1970 to study. He selected Boston because Thailand's King

Bhumibol Adulyadej was born at Mount Auburn Hospital in Cambridge. After graduation from the Lowell Technological Institute with a degree in Industrial Engineering he was approached by a chef friend to open the first House of Siam in Copley Square in 1985. The chef left but Joe endured.

Joe introduced thousands of Bostonians to iconic Thai dishes like tom yum koong soup, satay, pad Thai, and Massaman curry. His restaurants have been the recipients of multiple Boston magazine Best of Boston awards. His red Toyota smart car—which he

used for his bustling delivery business—was as recognizable as a duck boat. If there was a South End charity event or a death in the neighborhood or a family in need, he was there with his delicious food and his megawatt smile.

Joe leaves behind his partner James Rogers. His nephews Kai and Ped Wongjantit will take over the two restaurants.

Three years ago, I interviewed Joe Thailand for an article I wrote for the Improper Bostonian about the melting pot of international restaurateurs and chefs in the Hub. "I love this country and I love Boston," he told me. "It was my dream to come here, to work here, to open a business here, and become a US citizen. That was my dream and it worked. It worked for me."

## Parking Bans

## Parking In Snowy Weather

It's important for us to keep main roads clear for plows and emergency vehicles during extreme weather. You will be ticketed and towed if you park on a posted snow emergency artery during a declared snow emergency.

## Plows And Emergency Vehicles

Help us keep streets open to plows and emergency vehicles by parking at least 20 feet away from intersections and no further than 1 foot from the curb. Don't block sidewalks, fire hydrants, ramps, driveways, or the street with your vehicle.

## Clear Your Muffler

For your safety, make sure to clear all snow at least one foot around your muffler before starting your engine. Blocked mufflers can cause carbon monoxide poisoning.

## Towed Cars

If you believe your vehicle was towed in Boston, search the towing database or call the

*much from the neutering procedure, not just in terms of health but also as regards his temperament. Uncastrated dogs do not mix well with their neutered brethren. They are more aggressive, jumpier, and, yes, loonier. When they show up at the dog park – and, really, they should be banned from social contact with other dogs – intact dogs are the elephants in the room. They should also be barred from coming indoors to socialize because male intact dogs are inclined to leave their pee marking on everything.*

*Make sure your new poodle is "fixed" and then proudly take him out in public.*

Dear Dog Lady,

My dog Buddy is a great dog and very friendly. When he jumps up on people, I can understand the behavior. However, I I can't wrap my mind around why Buddy pees on his own leg while lying in the hallway as we wait for the elevator. It seems he would rather be punished than wait a few seconds more to make it outside. Maybe he can't control it, but he rarely pees in the apartment. What gives?

—Peter

Dear Peter,

Your first mistake is to claim you understand why Buddy jumps up on people. Do those jumped-upon people utter an expletive as the dog pounces on them? Buddy needs training. In the Ask Dog Lady rule book, jumping up on innocent people is a much worse dog offense than peeing in the hallway.

Is your dog fixed? An unfixed dog would most likely pee in a hallway – or anywhere.

*You should not be punishing for peeing, you should be rewarding for the good behavior of not jumping. If Buddy doesn't jump on people, give him a high-test treat (a piece of cooked chicken, a freeze-dried liver chunk) to reward his restraint – and for following your directive of "no jumping." If Buddy makes it all the way outside without peeing in the hallway, praise him lavishly and slip him a yummy. Dogs understand positive feedback much more than negative yelling. Also, they learn with repetition. You might have to give him the same directive over and over. You might think you're becoming a boring broken record. Your dog, on the other hand, will understand you mean business.*

*Be good to your dog. Being a good owner often means laying down the law and sticking to it.*

### Plow My Street, Please!

We prioritize clearing main routes - like Commonwealth, Hyde Park, and Blue Hill Avenues - so emergency vehicles can get to schools, hospitals, and homes quickly. If you think your street was missed by a plow, let us know by submitting a request to 311.

### Shoveling

Property Owners Must:

clear sidewalks within three hours of snowfall ending or three hours after sunrise if it snows overnight, and clear at least a 42-inch-wide path for wheelchairs and strollers.

Simply put, we're looking for an accessible path of travel. While the rule is three hours, we try to be reasonable for deciding when we start the clock. Our goal isn't to fine you. We just want people - especially youth and seniors - to be able to get around safely.

### Shoveling Fines:

We have information on what you can expect to pay in fines each day your sidewalk is unshoveled, or if you shovel snow onto the street. We fine ourselves for City-owned properties too.

### Things We Could Use Your Help With:

Don't shovel or push snow into the street. If you do, the City may fine you.

Remove ice to bare pavement or make as level as possible and treat with sand, sawdust, or similar material. Every year dozens of people are seriously injured slipping and falling on sidewalks.

Please clear any snow that may be blocking a handicap ramp, fire hydrant, or storm drain. If a hydrant is buried in snow, it takes the fire department time to find it and shovel it out.

Don't leave snow or ice on stairways or fire escapes. All common means of exit must be clear in case of a fire or another emergency.

### Prepare For The Cold

#### Stay Safe During Extreme Cold

When you know severely cold weather is coming, remember to take steps to prepare. Please also check on your elderly or disabled neighbors, and take caution when using portable heating devices like space heaters.

#### Frostbite And Hypothermia

Make sure to cover exposed skin and watch out for frostbite. In extreme cold, frostbite can happen in under a minute. Wind also increases the risk of frostbite.

Hypothermia occurs when your body loses heat faster than it can retain heat. This can create a dangerously low body temperature.

#### Carbon Monoxide

Every year, thousands of people are killed or seriously injured from breathing in carbon monoxide.

Winter is a dangerous time for carbon monoxide poisoning. Make sure the exhaust pipe on your car is clear of snow, as well as your house's heater vent.


