

Boston's Official Tree Arrives Nov. 17

The annual gift of an evergreen Christmas tree from Nova Scotia is scheduled to arrive by police escort at Boston Common at approximately 11 a.m. on Wednesday, November 17. This is the 50th year that a tree has been donated and commemorates 104 years of friendship between Nova Scotia and the people of Boston after our city provided emergency assistance when Halifax, Nova Scotia's capital, was devastated by a maritime munitions explosion in the harbor in 1917. The first Tree for Boston was donated in 1971 by Joseph Slauenwhite from Lunenburg County.

"Nova Scotia and Boston have shared a special bond for a century," said Boston Parks and Recreation Commissioner Ryan Woods. "This year marks 50 years that the province of Nova Scotia has gifted a tree, and it's the 80th year that the City has held a tree lighting event on Boston Common. I'm pleased we will come together after a challenging year to

celebrate the friendship and connections between our two regions."

Boston's official 2021 Christmas tree is a 60-year-old, 48-foot white spruce tree from Orangedale, Municipality of the County of Inverness, Cape Breton. The tree is being donated by the landowner L'Arche Cape Breton Community, a non-profit organization that creates safe, supportive homes and meaningful work for people with disabilities.

"The Tree for Boston has been a symbol of appreciation, friendship and unity for 50 years," said Tory Rushton, Minister of Natural Resources and Renewables. "We will never forget the kindness the people of Boston showed Nova Scotia following the tragedy of the Halifax Explosion."

The tree-cutting ceremony will be held on November 10 on L'Arche Cape Breton's property in Orangedale. Members of the L'Arche community will attend

King for a day and beyond: Mel King Square dedicated

In his 93 years, Mel King has worn many hats: community organizer and activist; elected official; high school and university educator; author and poet; and devoted husband, father, grandfather, great-grandfather and friend to many.

King represented the South End in the Massachusetts House of Representatives (9th Suffolk); was a teacher at Boston Trade High School and Boston Technical High School; was an adjunct professor of urban studies at MIT; spearheaded the affordable housing protests at Tent City; founded

the Massachusetts Rainbow Coalition party; created the South End Technology Center at Tent City; authored "Chain of Change: Struggles for Black Community Development" as well as other articles and poetry; and raised six children with his wife, Joyce.

On Saturday, November 13, his life's work and contributions to the community were honored with the dedication of Melvin H. "Mel" King Square and the proclamation by Acting Mayor Kim Janey of Mel King Day in Boston. The sun shone brightly on the joyous celebration at the newly minted square at the intersection of Yarmouth Street and Columbus Avenue, near the home he and his wife Joyce have shared for many years. Over 100 people gathered for the dedication, including family and friends, neighbors, and elected officials.

Among the crowd were King's long-time friend and one time political opponent, former Boston Mayor Ray Flynn; Jon Santiago, who holds King's 9th Suffolk district seat in the Massachusetts House of Representatives; congressional representative Ayanna Pressley of the 7th district for Massachusetts; state representative (5th Suffolk) Liz Miranda of Boston; and city councilors Ed Flynn, Kenzie Bok, Ricardo Arroyo and Julia Mejia.

King is perhaps best remembered for his activism for affordable housing and community-driven development, which is no surprise given his early history. One of nine children of Watts King of Barbados and his Guyanese wife, Ursula, King and wife Joyce grew up in the long-lost corner of the South End called the New York Streets, which fell to urban renewal redevelopment in the 1950s and 1960s.

The area was working class and very culturally diverse, where recently arrived Italians, Lebanese, Jews, Greeks, and others lived side by side in a close-knit, working-class community.

In her remarks, acting mayor and lifelong friend Kim Janey recited King's accomplishments in her proclamation of Mel King Day and shared personal recollections, including the friendship between King's mother and Janey's grandmother, who used to share recipes.

Priscilla Douglas, the first African American woman cabinet member, under Governor Bill Weld, in Massachusetts history, spoke of the inspiration she drew from King. "At every stage of my life, I've been inspired, lifted up and loved the wisdom of Mel King." Pointing in the direction of King's house, she said, "That's where it started, on Sunday afternoon," referring to King's longstanding tradition of hosting a Sunday brunch open house.

"That's where we learned what community was," Douglas quoted King's famous words, "Love is the question and the answer," adding, "It's our capacity as human beings to love each other, to love the Earth and to love the community."

to help celebrate the annual tradition. Due to the pandemic, the Province is partnering with Port of Halifax, container terminal PSA Halifax and transportation company Emskip Canada to transport the tree on a container vessel. The tree will leave Halifax on November 15 and be delivered to its new home on Boston Common.

Boston Parks Commissioner Ryan

Woods, an official Nova Scotian town crier, Santa Claus, and local school children including students from the Mather Elementary School in Dorchester will greet the tree at its final destination near the Boston Visitors Center at 139 Tremont Street. The tree will be lit at approximately 7:55 p.m. on Thursday, December 2, as the City of Boston's Official Tree Lighting is celebrated on Boston Common from 6 p.m. to 8 p.m. The ceremony will be broadcast live on WCVB Channel 5 starting at 7 p.m.

The 80th annual Tree Lighting on Boston Common is co-sponsored by the Boston Parks and Recreation Department and the title sponsor, The Province of Nova Scotia. Amazon serves as our presenting sponsor while Bank of America and Exelon are supporting the event as key sponsors. Additional support provided by WCVB Channel 5 and the Boston Globe.

In email to advocates, Sudders said the state is buying "18 private lockable sleeping cabins, each with one or two beds, personal climate control and storage for possessions" from a company called Pallet—which says the units can be set up in as little as an hour. And:

The state will also contract with a local health and human service provider to provide immediate onsite services, such as meals, laundry, case management and mental health and addiction services, with the goal of

supporting residents in their transition from the streets to permanent housing and longer-term stability. The provider will also be responsible for general oversight of the community, including 24/7 security, as the safety of the residents as well as hospital staff, patients and the surrounding neighborhoods is paramount. The housing is expected to be operational in December.

Sudders added:

The Temporary Cottage Community, although temporary, represents the first phase of implementation of the longer-term plans for supportive housing and services envisioned on the campus.

Under current plans, the state says it will move all current in-patient medical and psychiatric programs at Shattuck to a building on the Boston Medical Center campus and then lease the Shattuck grounds for creation of "supportive housing" and public- and behavioral health programs.

The plans are opposed by park and open-space advocates, who say the 13-acre site should be re-integrated with the rest of Franklin Park as parkland. They have suggested the state focus its attention on the former MBTA headquarters at nearby Arborway bus yard for social services.
