### Modified Phase 2, Step 2 Of Reopening Plan Extended In Boston

SUBMITTED BY THE CITY OF BOSTON

The following industries in the City of Boston are required to remain closed for at least three weeks (January 27, 2021):

Indoor fitness centers and health clubs, including gyms using alternative spaces. One-on-one personal training sessions are allowed.

- Movie theaters
- Museums

- Aquariums
- Indoor recreational and athletic facilities (except for youth 18 and under)

\*This does not apply to collegiate or professional sports.

\*Indoor pools may remain open for all ages under pre-registration format structure limited to one person per swim lane.

- Indoor recreational venues

### Boston Medical Center, COVID-19 Vaccine Update

We now have a new way to help stop the spread of COVID-19—vaccines.

Vaccination will help protect you and those around you from COVID-19.

By being vaccinated, wearing a mask, and staying at least 6 ft. away from others, we can help end this pandemic.

As COVID infections go up in our communities, your risk of getting COVID-19 goes up too, and you can get seriously sick. But the COVID-19 vaccine prevents infections in about 95 percent of people. And it doesn't just protect you—by getting vaccinated, you'll also help keep your family and your community safe from COVID-19. Currently, Boston Medical

Center is providing the vaccine to hospital employees, based on state guidelines. We plan to begin vaccinating patients in early 2021, based on those guidelines. The vaccine will also be available at other health care organizations and pharmacies as part of the nation-wide vaccination effort. It will be available to different groups in phases. Your overall health and your job will help determine which phase you'll get the vaccine in. We expect that healthy adults will be able to get vaccines later in 2021.

Over" (2019 Lortel best play prize). Antoinette Nuandu's timely play riffs on Beckett and Exodus in a resonant look at the frustrations and difficulties of two African-American young men. Hubens "Bobby" Cius was forceful as Kitch and Kadahj Bennett commanding as Moses. SpeakEasy has since tackled LG-BTQ issues with an audio presentation of M.J. Halberstadt (the deservedly acclaimed "The Launch Prize")'s informative bookstore-set play "The Usual Unusual" — one that the company is likely to stage fully post-COVID.

American Repertory Theater paid tribute to 85 year old activist Gloria Steinem with an exuberant area premiere of the Emily Mann Off-Broadway play "Gloria." Audience members sat on pillows and bean bags as well as regular Loeb Drama Center seats for this informative if overly busy portrait of the Ms. Magazine founder, supporter of gay rights and inspiring contemporary of Shirley Chisholm and Bella Abzug. Patricia Kalember powerfully captured Steinem's fire and feeling.

Spring found the Hub Theatre Company of Boston bringing new zest to "Much Ado about Nothing" in a lively split-screen revival. Jon Vellante was a standout as Benedick in a solid ensemble. Veteran actor Arthur Waldstein — wearing a tallit (Jewish prayer shawl) and yarmulke — proved very affecting as Rabbi Francis (originally, of course, Friar Francis) in director Bryn Boice's persuasive adaptation.

New Repertory Theatre began a project called the Showstopper Virtual Play Series with back to back on-line one person one-act plays. Colombian-American playwright Alexis Scheer's "A Very Herrera Holiday" impressed with a disarming Martha Stewart-like crafts show that eventually darkened via suspicions of the host about the fidelity of her husband. The second work, Miranda ADEkoje's Instagram-employing "[keep-ing]," builds on the worries

of an African-American producer's about the security of her director husband and fellow black film crew members testing for COVID in a virtually all-white community. This smart Zoom duo bodes well for New Rep's commitment to diversity.

Arlekin Players continues to show itself to be an envelope-pushing troupe. If its one-woman trial-based drama "State vs. Natasha Banina" needed stronger development and fuller back story, the company nevertheless deserves kudos for a well-acted, technically imaginative effort.

Three pioneering gay playwrights were lost to America and the world in 2020—Mart Crowley (84), Larry Kramer (84) and Terrence McNally (at 81 from complications from COVID 19).

Crowley's pre-Stonewall "The Boys in the Band" (1968) broke ground for dramatists seeking to focus on the fortunes of gay characters. Theatergoers can catch a film version of the Tony Award-winning 2018 revival (complete with the entire Broadway cast) on Netflix. Kramer's Tony-winning play "The Normal Heart" (powerfully staged on Broadway) combines a touching romance in the age of AIDS, insights about activists like the playwright himself and timely comment about politicians favoring opportunism over courage and caring.

Terrence McNally (whom this critic was privileged to meet at a talkback after a stellar SpeakEasy Stage Company production of his Off-Broadway gem "A Man of No Importance") was rightly known as "the bard of American theater." The multi-talented writer and opera aficionado won Tony's for plays — "Love/Valour/Compassion!" and "Master Class"—as well as the books of musicals — "Kiss of the Spider Woman" and "Ragtime."

Surely the works of all three — particularly the prolific McNally — will remain an essential part of American stage repertoire.

with potential for low-contact (batting cages, driving ranges, bowling alleys, rock-climbing)

- Sightseeing and other organized tours (bus tours, duck tours, harbor cruises, whale watching)

- Indoor historical spaces & sites
- Indoor event spaces (meeting rooms, ballrooms, private party rooms, social clubs)
- Private social clubs may continue to operate, if they serve food, consistent with restaurant guidance.

- Indoor and outdoor gaming arcades associated with gaming devices

The following industries in the City of Boston are allowed to remain open with the following restrictions in place for at least three weeks (January 27, 2021):

- Indoor dining in restaurants may remain in operation with restricted bar seating. The 90 minute limit on seatings to reduce crowding and prevent the spread of COVID-19 will be strictly enforced. No member of any dining party may remain in a restaurant for more than 90 minutes in any calendar day. Ancillary activities such as pool tables, darts, trivia, etc. are prohibited.

- Bar seating is prohibited unless express written approval is issued by Boston's Licensing Board, after licensees submit a Bar Seating Plan for review and approval.

- Indoor non-athletic instructional classes in arts, education & life sciences for persons 18 years and older may continue to operate within the 10-person capacity limit.

- Outdoor event spaces used for gatherings and celebrations within the 25-person capacity limit, including those in parks, reservations, and other outdoor spaces not designated in Phase Four.

- Outdoor theaters and outdoor performance venues may continue to operate within the 25-person capacity limit.

- Motion picture, television and streaming production may continue to operate.

Per State guidance in effect since December 26, 2020, the following industries in

the City of Boston are currently allowed to operate with the following restrictions in place:

- Office spaces may remain open at 25 percent capacity. Employers are strongly encouraged to allow employees to work from home as much as possible.

- Indoor dining in restaurants may remain in operation at 25 percent of seating capacity (calculated by the occupancy load as stated on a licensee's certificate of inspection issued under the State Building Code. Workers and staff are excluded from the occupancy count.)

- Close contact personal services may remain open at 25 percent capacity (workers and staff are excluded from the occupancy count.)

- Places of worship may remain open at 25 percent capacity (workers and staff are excluded from the occupancy count.)

- Retail businesses may remain open at 25 percent capacity (workers and staff are excluded from the occupancy count.)

- Golf facilities may remain open at 25 percent capacity (for indoor spaces)

As a reminder, the following State orders remain in effect to reduce the transmission of the virus:

- Temporary capacity and gathering limits: 10 persons indoors and 25 persons outdoors for both private homes and event venues and public spaces.

- Face coverings order: face masks or cloth face coverings are required in all public places, whether indoors or outdoors, even where they are able to maintain 6 feet of distance from others.

- Travel order: all visitors entering Massachusetts, including returning residents are required to:

- Complete the Massachusetts Travel Form prior to arrival, unless visiting from a lower-risk state designated by the Department of Public Health.

- Quarantine for 10 days or produce a negative COVID-19 test result that has been administered up to 72-hours prior to arrival in Massachusetts.

- Stay-at-Home Advisory: residents of Massachusetts are advised to stay home between the hours of 10 p.m. and 5 a.m.

"The Resisters" by Gish Jen

Gish Jen, the acclaimed author of many novels, short stories and thought-provoking essays, has agreed to return to South End Writes to discuss her widely praised eighth novel, *The Resisters*, on Tuesday, February 2, via ZOOM.

Jen visited the South End library in 2017 to present her earlier work of fiction, *The Girl at the Baggage Claim*. Explaining the East-West Culture Gap.

The first paragraph in the New York Times review of *The Resisters* describes a searing picture of a world we hope we will never see but which conceptually appears increasingly close at hand: *The Resisters* "... imagines a society even more catastrophically divided than our own. In Jen's *AutoAmerica*, almost all of the jobs have been automated and rising seas have swamped large sections of the country. The privileged, known as the "Netted," have "angelfair" skin and live on high ground, while the "Surplus," whose skin is often "coppertoned," suffer on swampland and rickety houseboats..."

HOMELESS SERVICES AND HOSPITAL CAPACITY

On April 2nd, Mayor Walsh announced that construction begins at the Boston Convention and Exhibition Center to add 500 beds for treating homeless adults who have tested positive for COVID-19 and need care, but do not require full hospitalization.

The City has released a Request for Proposals to secure a partner organization to operate the facility. If necessary, the Convention Center beds will be opened up for hospitals to use for sub-acute COVID patients in the general population.

These 500 beds will bring Boston's total number of new beds for homeless individuals to over 1,000. This includes Boston Medical Center's Newton Pavilion facility, which the City and State are working to re-purpose as a medical facility for homeless residents affected by the coronavirus.
