milestone in IBA's commitment to advancing its arts programming and comes as IBA prepares for the opening of its new cultural center La CASA: The Center for Arts, Self-determination, and Activism.

DelValle, 24, is an accomplished artist known for her innovative approach to community-engaged art. Her connection to IBA runs deep. She grew up in Villa Victoria—I BA's affordable housing community—and was a participant in IBA's Youth Development Program. Her grandfather worked as a maintenance worker for the community, and her family has lived in the same apartment on Aguadilla Street in Boston's Historic South End for generations.

"Joining IBA as Artist in Residence feels like coming full circle," said DelValle. "My ties to Villa Victoria are generational, and IBA's Youth Development Program played a crucial role in shaping my artistic journey. From my early days experimenting with Spoken Word Poetry to my studies at NYU's Tisch School of the Arts, I've always strived to create art that connects with our community's shared experiences. It's an honor to now contribute to the rich culture of Boston's South End in this new capacity."

DelValle's multidisciplinary art explores the themes of identity, generational trauma, hidden truths, childhood, culture and heritage. In 2017, she was recognized with MassLEAP's Phyllis Wheatley Award for challenging injustice with work that reflects on the social and political history of the place she is from. In 2018, she represented Boston on the final stage at the international youth poetry slam festival, Brave New Voices, in Houston, Texas, and has performed at David Rockefeller Center for Latin American Studies at Harvard University. She is a graduate of New York University where she received a Bachelor of Fine Arts in Interactive Media Arts, and the School of Museum of Fine Arts where she received a certificate in Illustration.

As Artist in Residence, DelValle will engage IBA's affordable housing community and program participants in an exploration of the intergenerational legacy of Villa Victoria. Her work will take various forms, including educational workshops and seminars, listening sessions, historical research, and collaborative projects across different programs. Recognizing that the world is ever-changing, DelValle believes ongoing dialogue and flexibility around community values, dynamics and aspirations are essential to keeping the legacy relevant and adaptable to contemporary challenges.

The culmination of her residency will be a collaborative art installation with the Villa Victoria community, titled From Protests to Pride: Generations of Villa Victoria. This

project will enhance Latino representation in Boston's art scene and provide creative outlets for residents and youth to explore identity, culture, social issues and well-being through art.

The addition of DelValle to IBA's team is part of a broader expansion of the organization's arts leadership.

Juan Carlos González assumed the full-time role of Arts Program Director this year after serving as interim director since 2020. González leads the Arts team in developing accessible community-building programming, expanding IBA's network of Latinx performers and artists and executing its flagship events, including Festival Betances which drew more than 3,000 attendees from across New England this summer. González, a graduate of the Instituto Tecnológico de Puerto Rico, brings a unique perspective to arts administration through his success as a photojournalist, storyteller, and event and landscape photographer.

Additionally, as of summer 2024 cuatro-player, singer, musician and Berklee graduate, Juan Nieves has joined IBA as the Arts Performance Manager. In this role he will collaborate with González to strengthen the organization's artistic vision and execution capabilities. Nieves is one of the most important artists keeping the folkloric Puerto Rican musical tradition alive. His cuatro, the national instrument of Puerto Rico, has accompanied him to more than 15 countries around the world. His 25-year career includes three albums, singles and many collaborations.

"Tori's appointment, alongside Juan Carlos and Juan's roles, showcases the tremendous growth in IBA's long-standing commitment to promoting Latinx arts and culture," said Vanessa Calderón-Rosado, CEO of IBA. "As we prepare to open La CASA, these strategic additions to our team will be instrumental in elevating our arts programming to new heights. We are thrilled to welcome Tori DelValle back home as our Artist in Residence."

These appointments come at a time of significant growth for IBA. The organization has been steadily expanding in areas like affordable housing, education and financial empowerment. The enhanced focus on arts programming complements these efforts, recognizing the integral role of culture in community development and individual empowerment.

The expansion of IBA's arts leadership team emphasizes the promotion of Latinx arts and culture as a means of community building and heritage celebration. This initiative builds on IBA's legacy of using arts as a tool for social change and community empowerment. Even before its establishment in 1968, the residents that would eventually form Villa Victoria used the Arts as a mechanism of community organizing and cultural cohesiveness.

challenged novice aging surfer in the disarming play "Wipeout" at Gloucester Stage Company with a haunting effort as a dementia-combating critic in the blistering East Coast premiere by SpeakEasy Stage Company of "Pru Payne."

Steve Drukman's visceral 90-minute drama opens at a clinic named Brook Hollow—with a striking state of the art look in Christopher Swader and Justin Swader's scenic design. Here Prudence "Pru" Payne and her son Thomas meet with Dr. Dolan—Marianna Bassham crisply nerdy as a science-guided expert—on memory loss and its treatment. The fictional late-60's "public intellectual" (Drukman's own description) and seminal critic—with shades of the likes of Dorothy Parker and Mary McCarthy—Pru addresses the audience (the unseen other clinic patients) as though they are the American Academy of Arts and Aesthetics (which has given her the organization's coveted Abernathy Award). Masterful MacDonald captures the serious-

ness of the name-dropping critic (for example, Proust, Pinter, Rothko and Johns) and her telling early and increasing confusion and disorientation. Her very caring budding novelist son Thomas—played with strong empathy by De'Lon Grant—is very aware of the condition that found her insulting the likes of attending Norman Mailer at the awards ceremony. Drukman may have Pru over-referencing writers and artists in his ambitious 90-minute no-intermission play, but the insightful dramatist does make a moving case for the difficulties she faces regarding memory—especially as she struggles to write a memoir.

That struggle finds some beautiful solace in an unexpected romance with a fellow late-60's patient named Gus Cudahy. Custodial engineer Gus—attended by his early 30's dog-breeding son Art—senses that Pru would not be drawn to him anywhere else, but eventually the very different patients slow dance to the American Songbook classic "I Don't Want to Set the World on Fire." Gordon Clapp artfully catches Gus' complicated simplicity as Pru embraces his singular combination of style and substance. Anyone who

saw Clapp's virtuosic one-man performance in "Robert Frost: The Verse Business" should find some quiet irony in Gus' disclaimer about poetry even as Pru connects one of his quotes with Ezra Pound.

If there is a connection that some audience members may find too co-incidental it is the contrasting romance between Thomas and "butch" Art. To be fair, Drukman does establish early on Thomas's recognition of Art as they bring their respective parents to Brook Hollow. They do turn out to know each other from Rendigs Academy. While some theatergoers may find the development of their romance convenient, Grant and Greg Maraio—arrestingly agile yet vulnerable as Art—make their evolving intimacy fully convincing.

"Pru Payne," Paul Daigneault's penultimate effort as SpeakEasy's artistic director, is an unquestionable triumph. Pru—a tenacious critic who has battled kitsch throughout her career—has repeatedly counseled that "good enough" is not enough. By contrast, SpeakEasy Stage's riveting "Pru Payne" is much more than enough.

of our graduates remain in Massachusetts, the state's continued investment in public higher education is an investment in our future workforce," said UMass Boston Chancellor Marcelo Suárez-Orozco. "Being the son of schoolteachers and an immigrant myself, I know education's vital role in opening doors for young people. Our Beacon Pledge program will make a four-year degree at Boston's premier public research university not just a dream but an attainable reality."

The Beacon Pledge Program offers high-need students the ability to earn a bachelor's degree for free. It will use federal, state, and institutional aid to cover total tuition and mandatory fees. In-state students from families with an adjusted gross income of \$75,000 or less qualify for the program. University leaders hope the program can support as many as 3,000 students in its first year, more than one-third of whom are expected to come from Suffolk County and a vast majority of whom are expected to be students of color.

"Massachusetts is home to incredible state colleges and universities, including Boston's only public research university, UMass Boston," said Governor Maura Healey. "We have made important progress over the past couple of years to make higher education more affordable and accessible for all students and are glad to see UMass Boston lifting up the historic financial aid available to students at state universities through their Beacon Pledge. I'm grateful for the leadership of Chancellor Suárez-Orozco and look forward to continuing to support the amazing work happening at UMass Boston and campuses across the state."

"We believe the Beacon Pledge, building on existing state and federal support, is a model for other public colleges and universities to ensure a four-year degree is more attainable for all learners, regardless of their background or income," Suárez-Orozco said.

Chancellor Suárez-Orozco expressed

gratitude for the support from other UMass campuses for the Beacon Pledge program. "I applaud the leadership of my Chancellor colleagues, Drs. Chen, Fuller, and Reyes, for shortly preparing to announce similar initiatives adapted to each of their campuses," said Suárez-Orozco.

Since its founding 60 years ago, UMass Boston has been committed to providing high-quality education to underrepresented and underserved students. The Beacon Pledge program seeks to remove financial barriers and demystify the cost of college for the Commonwealth's most need-based students and families. It is an extension of the generous aid policies that UMass Boston has employed for years—awarding \$45 million in institutional funds annually and resulting in the lowest average debt upon graduation per student of any of the UMass campuses.

"Here in Massachusetts, we pride ourselves on being leaders in education—not only because we're home to world-class institutions but also because we've taken major steps to make higher education more accessible and more affordable," said Lieutenant Governor Kim Driscoll. "The Beacon Pledge highlights how the administration, Legislature, and colleges continue to break down barriers and grant more people an opportunity to pursue higher education, which is good for our students, schools, businesses, and economy. We're thankful to the leadership at UMass Boston and look forward to welcoming students to campus!"

"UMass Boston's Beacon Pledge program highlights how truly affordable a UMass degree is, and I applaud Chancellor Suárez-Orozco and the other UMass chancellors for their efforts to ensure students and families are aware of that fact," said UMass President Marty Meehan. 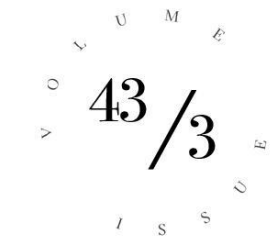

South End Officers Arrest Suspect Following a Stabbing Incident

At about 2:48 PM, on Friday, October 25, 2024, officers assigned to District D-4 (South End) arrested Nathaniel Almeida, 46, of New Bedford, after a stabbing incident.

Officers responded to the area of 474 Mas-

sachusetts Avenue for a report of a person stabbed. Boston Police Operations provided officers with a description of the suspect and his direction of flight.

Upon arrival, officers observed an adult male victim suffering from multiple stab wounds. Officers immediately began to render medical aid, and requested Boston

EMS to respond to the scene. The victim was transported to a local hospital with life threatening injuries. The victim is expected to survive his injuries.

Officers began to canvass the area for the suspect, and observed a male matching the description in the area of Gage Street and Northampton Street. Officers observed that

the suspect had a laceration on his arm, and was transported to the hospital.

Almeida was placed under arrest and charged with Assault and Battery with a Dangerous Weapon, Assault and Battery, Threat to Commit a Crime, and Intimidation of a Witness. He is expected to be arraigned in Boston Municipal Court.

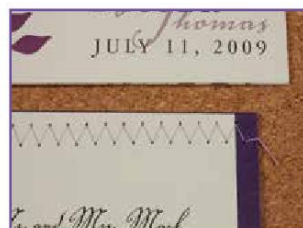
