At a time when a dictatorial president is targeting millions of Hispanic-Americans—undocumented and even native-born—for deportation, a 2022 dramedy by now 30 year old black playwright Jordan Cooper is taking off at the Calderwood Pavilion. Cooper's blistering satire—a Roberts Studio Theatre 100 minute non-stop flight—revs to timely resonance about racism and hate. The 2023 Tony-nominated "Ain't No Mo"—in a riveting SpeakEasy Stage-Front Porch Arts Collective area premiere—provocatively imagines a U.S. government arrangement for all people of African descent to return to the mother continent.

South End Murder Suspect Pleads Not Guilty

Court Documents Reveal History of Violence

A Boston man accused of killing the mother of his three children in a South End luxury apartment entered a not guilty plea Wednesday in connection with the December death of Shantel Gillespie, 30.

Eric McPhail, 37, was ordered held without bail. Court documents show Gillespie died from suffocation and head trauma, with her body discovered December 12 at her Harrison Avenue residence.

The criminal complaint details surveillance footage showing

complex concepts.

Ellis also recently hired an educator Ana Davis who leads the STEM exploration program, which resulted from funding from National Grid and PwC.

"We are tremendously grateful for Amazon, National Grid and PwC's support of our STEM program as we strive to set students up for success in school and throughout their lives," said Ellis Early Learning CEO Lauren Cook. "These additional resources, particularly an educator dedicated to STEM-related learning, will enable our initiative to flourish for the benefit of our young learners."

Ellis opened a pair of STEM Exploration Labs for toddlers and preschoolers, respectively, at its South End centers in September 2023. The STEM labs are separate classrooms designed to look like children's playhouses and outfitted with engaging, age-appropriate equipment, supplies and materials to encourage children's natural curiosity. They were funded by the Boston Public Schools in addition to individual and family foundation donors.

One objective of the STEM lab initiative is to teach preschoolers the basics of (screen-free) coding to enhance their problem-solving and logical thinking skills. The Ellis STEM program offers targeted equipment like a magnet wall where children can explore gravity and the many ways a path can be created and redirected, and a multi-directional wind tunnel demonstrating the relationship that wind and direction share.

Studies show that STEM in early education can lead to later success in school and in the workplace; however, children who live in poverty and children who are members of linguistic and ethnic minority groups, have fewer opportunities to engage in STEM learning than their fellow learners. Additionally, many early childhood teachers are not prepared to engage children in high-quality STEM education.

Ellis is committed to helping all children develop the social, emotional and academic skills they need to be successful in school and in life. The nonprofit stands out for being among the most socio-economically, racially and culturally diverse organizations serving the children of Boston. Over 60% of Ellis families receive child care subsidies from the government and 65% of participants are people of color.

"Ain't No Mo" is a no-holds-barred tragicomedy about race

Numerous Back-to-Africa movements in the U.S. have sought to return enslaved Africans to the Motherland to resolve the problem of racism. Jordan E. Cooper's tragicomedy "Ain't No Mo" brilliantly highlights the urgency of the idea, especially in light of this present moment. With the premise that the United States government offers Black Americans who are descended from enslaved people a one-way reparations plane tickets to Africa, Cooper, a young black queer male playwright, unashamedly shows the ongoing struggle with America's Original Sin.

Cooper grew up during a rash of police killings of black males, which was the impetus for his play, especially the 2016 killings of Philando Castile and Alton Sterling. In a 2023 interview with the Huffington Post, Cooper said he started writing the play "as a cathartic way to deal with the onslaught of police killings of unarmed Black folks."

As the youngest Black American playwright ever nominated for a Tony Award, Cooper began writing "Ain't No Mo" while a high schooler. Cooper imagines a place where Blacks live unencumbered from the yoke of racism and police violence. However, before we depart, Cooper's vignettes of all too familiar scenes in black life highlight why it's not safe in the U.S.—physically and mentally — to stay. To some, his no-holds-barred approach might appear brash and gratuitous, but Flight 1619, taking the entire African diaspora back to her homeland after 400-plus years, is a glaring reminder of how long the struggle has been.

The play begins in 2008, celebrating Obama's election as the first black president with the hopes of his election ushering in a "post-racial" America. It ends with Flight 1619 taking off in 2016, with Trump and MAGA America storming into power. Although we're in 2025, ironically, you'll feel stuck in a time warp, a continued nightmare that makes the play a profound message about the endurance and persistence of both institutional and individual racism.

There are several vignettes: a funeral inside a Black church with Brother Right-to-complain, the embodiment of protest and injustice, being eulogized; the home of a wealthy "bougie" Black family whose black servants left to catch Flight 1619; a woman's abortion clinic (Sister Girl We Slay All Day Cause Beyonce Say Community Center) showing a black woman's fear of bringing a black male child into the world; a female incarcerated for 15 years realizing the profound loss of time, and a taping of "Real Baby Mamas of the South Side," an outrageous "Real Housewives"-style reality TV show with a transracial woman named Rachonda in black drag-white woman passing as black (remember Rachel Dolezal?).

The vignettes are disparate but smart, with searing, in-your-face moments that you can't glance askance at. The undeniable experiences of black life and a drag queen named Peaches tie the disparate vignettes together. Peaches, a flight attendant, is tasked with welcoming and ushering the entire U.S. black population onto Flight 1619. Each vignette concludes with Peaches's announcement on the airport's PA system to hurry and board the

final flight to Africa. "The powers that be have reassured me there's room for everyone." Each character, however, must make their choice to stay or leave.

The humor buffers the blows. The humor keeps you from crying or swelling with anger with its over-the-top satirical dramatizations. "I love finding the humor in those situations because I believe that's how you get through it," Cooper told the Boston Globe. "That's the thing about 'Ain't No Mo'. It punches at all sides."

"Ain't No Mo" is both "a loathe and a love letter to America," Cooper reminds his audience. The play's complexity raises difficult questions for African Americans, especially with the government offering every Black American a one-way free plane ticket to Africa. If we board Flight 1619, are we willing to leave behind the 400-plus years of building and contributing to the DNA of what makes this country the U.S.?

"Ain't No Mo" director Dawn M. Simmons shared her response: "So much of Black culture is so uniquely American, so uniquely about what happened and was created on this soil—the good, the bad, the ugly about our tragedy and our triumph. If we go somewhere else, it can come with us, but it changes and morphs."

McPhail entering Gillespie's apartment shortly before her on December 11. He briefly left after midnight before departing with their children the following morning. He returned at 9 a.m. for approximately 90 minutes, marking his final visit to the apartment. Gillespie was

never seen leaving.

According to investigators, McPhail dropped the children at a Dorchester residence that evening, stating he was "going away for a long time." He allegedly abandoned Gillespie's car and debit card at a garage near Boston Children's Hospital, where she worked.

Court records reveal a history of domestic violence, with restraining orders issued against McPhail in 2021 and 2022.

Gillespie had recently completed nursing coursework at Laboure College of Healthcare. Boston Children's Hospital remembered her as "a valued and committed member of the team," expressing "deepest sympathies to her family."



The ‘passengers’ for the African American Airlines one-way travel in question are reporting to the tellingly named gate 1619 (the year when black slaves were brought by British colonists to Virginia). Drag gate attendant Peaches—actually played by Cooper in 2022 and here portrayed with an arresting combination of comic timing and poignancy by Grant Evan—introduces the audience to the mysterious Miss Bag. This metaphorical prop—Cooper submits—“carries all the legacy, history, joy and pain, the triumph and the perseverance of the Black race in America.”

Via very different but vivid vignettes—here under Dawn M. Simmon’s appropriately driving direction, Cooper insightfully examines the impressively heavy Black contribution to America that the Bag contains. One of the most exuberantly presented vignettes involves a church sermon—delivered with wonderful authority by De’Lon Grant—in which the preacher eulogizes the deceased known as Brother Right to Complain. The overly optimistic sermonizer invokes the play’s ironic title in claiming that the election of Black President Obama means that there “ain’t no mo’ discrimination” and “no more waiting on FEMa” in Louisiana.


While Cooper peppers some of the following vignettes with comic exchanges, his timely play never loses sight of the formi-

dable and often demeaning challenges continuing to confront Black Americans. A take-off on reality shows called “Real Baby Mamas of the South-Side” finds black women in eye-catching attire—kudos to designer Rachel Padula Shufelt—initially hyping for the camera at the request of an unseen director only to engage in bickering and wig-tossing. Here Kiera Prusmark sharply captures a self-serving white Rachel masquerading as a ‘transracial’ with the name Rachonda. Schanaya Barrows finds all of the bluntness with which Tracy exposes her. Dru Sky Berrian brings touching vulnerability to a pregnant woman suffering along with other unattended Black patients.

Especially revealing is an alternately amusing and disturbing vignette focused on an affluent Black family shaken up by the emergence of a basement stowaway known as Black. MaConnia Chesser has all of Black’s fury and intensity as she powerfully reminds the smug family members that they must not deny the authenticity and true soulfulness she represents. Cooper also observes—via Grant Evan’s strikingly complex Peaches that black people sometimes hate fellow blacks worse than whites do.

“Ain’t No Mo” proves as much of a theatrically satisfying play as it is a vital cautionary voyage to combat stereotypes and racism. Cooper has insisted cogently that “there’s still so much work to do.” The SpeakEasy Stage-Front Porch Arts Collaborative flight at the Calderwood Pavilion is an important part of that work.




