

## Developer Proposes 44-Unit Building with Artist Spaces on Plympton Street

A South Boston developer has filed plans to replace two aging buildings at 52 Plympton Street in the South End with a seven-story residential building containing 44 condominiums and dedicated artist spaces.

Joshua Brandt submitted the proposal to the Boston Planning Department last week calling for demolition of a three-story warehouse built in 1895 and an adjacent garage from the 1920s on

## Woman Faces 23 Charges After Police Chase Through Boston

A woman is facing nearly two dozen criminal charges after allegedly dragging a police officer and leading authorities on a chase through downtown Boston and the South End on Tuesday afternoon.

The incident began around 2 p.m. near 120 Tremont Street at the Park Street MBTA station, where police attempted to stop the woman for pos-

sible automotive violations. According to Boston police, the woman fled in a Honda Passport SUV, dragging a female officer approximately 20 feet. A second officer was also injured while attempting to stop the vehicle. Both officers are expected to recover.

The chase continued for nearly two miles through city streets. Police report the driver struck several cars at Tremont and Stuart streets and hit a utility pole at Herald and Shawmut

streets before finally being stopped at Plympton and Albany streets in the South End.

The woman was taken to a city hospital with non-life-threatening injuries and remains under police guard. Her name has not been released. Police said she had a suspended driver's license, and officers allegedly found fentanyl and crack

## City Councilor Proposes Regional Fund to Address Mass & Cass Crisis

Boston City Councilor John FitzGerald has filed a hearing order calling for the creation of a regional fund to tackle the ongoing substance abuse and mental health crisis at Mass & Cass, shifting the financial burden from Boston alone to surrounding municipalities that benefit from the city's services.

FitzGerald, who chairs the city council's public health committee,

filed the order on July 7th for a "Regional Substance Use Disorder and Mental Health Fund" that would require Boston and neighboring cities and towns to contribute proportionally to a shared pool supporting addiction recovery, housing, and public health infrastructure.

"This isn't just a Boston crisis—it's a regional one," FitzGerald said

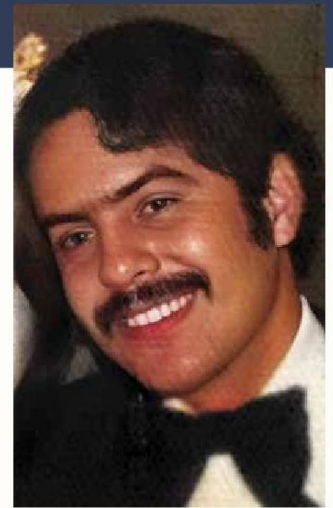

in a statement. "Many of the individuals at Mass & Cass aren't from Boston, yet it's Boston taxpayers who are bearing the full financial burden. That's not sustainable, it's not fair, and it's not working."

The proposed fund would be structured similarly to existing regional collaborations like MBTA assessments, with contributions

based on population, need, and usage of Boston-based services. Money would go toward expanding housing options, mobile outreach teams, harm-reduction services, and long-term recovery programs.

Data from the Boston Public Health Commission and Boston Medical Center shows that a substantial percentage of people receiving services around Mass & Cass come from municipalities outside Boston, according to the hearing order.

The hearing would bring together city officials, public health leaders, municipal representatives, and regional planning partners to design the fund's structure and scope. Representatives from the Boston Public Health Commission, Mayor's Coordinated Response Team, Metropolitan Area Planning Council, and Massachusetts Municipal Association would be invited to testify.

The order was filed in City Council on July 9th.

Newton Street). Known for her work with the legendary all-female orchestra Anacaona, Vargas will perform a mix of bolero, salsa, and traditional Cuban son.

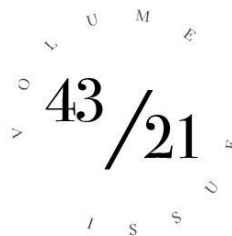

the roughly 3,000-square-foot lot off Albany Street.

The new building would include eight artist live/work units on the first floor, along with a gallery and workshop space. These one-bedroom artist units would be sold as affordable housing to buyers earning 80 to 100 percent of the Boston area median income. The remaining 36 units would range from studios to three-bedroom condos sold at market rates. Plans include 19 parking spaces in an un-

derground garage equipped with systems to allow rainwater to recharge groundwater and protect against potential flooding from the nearby Fort Point Channel area.

Brandt must obtain permission from the South End Landmark District Commission to demolish the existing structures. According to the filing, architects determined that restoring the current buildings would be too expensive and difficult due to modern building and seismic code requirements.

The developer stated the new construction would be "a thoughtfully designed building that will enhance the character of the district."

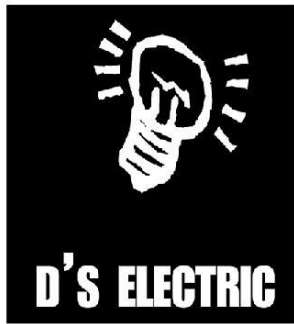
