

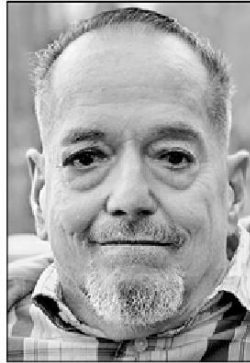

Larry Basile

Age 75, passed away peacefully on June 14, 2025, on Gay Pride Day in Boston, a city he loved deeply.

Born February 26, 1950, at Fort Belvoir, VA, to Colonel Anthony L. and Marion F. (Heaney) Basile, Larry was raised in West Roxbury and graduated from Xavierian Brothers High School in 1968. He briefly attended St. John's Seminary before earning an MBA from William & Mary in 1975 and completing graduate studies at NYU Business

Boston Sees Overall Crime Reduction Despite Some Challenges

Massachusetts reported a 6.53% decrease in overall crime in 2024, with Boston and Suffolk County contributing to statewide improvements in serious crimes, according to preliminary state data released this month.

The state saw significant drops in homicides (down 11.4%), robberies (down 8.6%), and motor vehicle thefts (down 16.1%). Firearm-related crimes also declined substantially, with gun homicides down nearly 22% and firearm robberies down 16%.

Boston has been part of these positive trends while addressing ongoing public safety concerns in the downtown area.

Like many urban areas nationwide, Boston has seen an increase in shoplifting incidents,

with Suffolk County reporting higher numbers compared to pre-pandemic levels. Boston police note that some of the reported increase may reflect businesses becoming more comfortable reporting incidents to law enforcement.

The data comes as Boston prepares for this fall's mayoral election, with public safety remaining a key issue for voters. City officials point to the overall decline in serious crimes as evidence of effective public safety strategies while acknowledging the need to address quality-of-life concerns in downtown areas.

Massachusetts' crime rate of 3,301.9 per 100,000 people remains well below this century's peak in 2008, though slightly higher than pre-pandemic levels.

Are sanitation workers modern day archaeologists? Think of the famous idiom that "One man's trash is another man's treasure." Many audience members at Gloucester Stage Company's veritable trove of a regional premiere of "The Garbologists" by Lindsay Joelle ("Tray") are

likely to take this insight seriously. Moreover, artistic director Rebecca Bradshaw's smartly you-are-there staging should make Joelle's affecting and informative play a delightful eighty minute dig.

In making the GSC production a real experience, scenic designer Kristin Loeffler has placed bags of refuse not only onstage but also at the edges of the audience. Adding

to the authenticity, Costume designer Jen Greeke has production stage manager Marsha Smith and assistant stage manager Colby Hairston dressed in sanitation worker uniforms that match those of Paul Melendy as veteran garbage collector Danny and Thomika Marie Bridwell as newbie Marlowe.

John F. Kelly

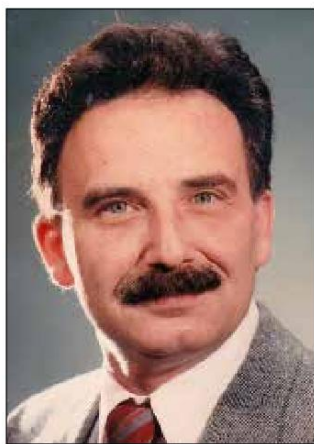
September 4, 1942 to July 4, 2025

For John Kelly, service to others was central to how he interacted in the world. No matter who he encountered, he was determined to find something he could like about the person. He understood how much each of us needs love, respect, and support. Perhaps his great sensitivity to others came from his having been given up for adoption by his birth mother. When she left him with the Kelly's who later adopted him, she said she was going to get him an ice cream cone, but she never returned.

In his early years, he lived with James Kelly and Bridget Kelly in South Boston, MA. After graduating high school, he enlisted in the Air Force and served for five years.

He attended Northeastern University in Boston, MA and subsequently built a career at Arthur D. Little, heading their Graphics and Printing department of thirty staff who admired him.

At St. Cecilia's Catholic Church in Boston, he served at Masses helping people receive Holy Communion, and was instrumental in establishing the Rainbow Ministry, which welcomes and celebrates the LGBTQ+ community. John was always seeing what he could do to help. He was a President of GBBC (Greater Boston Business Community) and an active contributor. When he was part of the retirement community

at Fenno House, he organized yard sales, auctions, fund raisers, Halloween parties and all sorts of events to liven up the place.

He was a loyal, generous, and thoughtful friend to so many and how he loved his Chloe (Apricot toy poodle) and other pets.

A great and happy shock in his life was being discovered and warmly embraced by his half-sisters, Bernice Navin, Florida and Patricia and Peter Brun, of Burlington and his niece, Sarah Buhler of Tewksbury, and his nephew Alan Brun of Salem. This was the treat, the ice cream cone, promised and the unexpected union of two parts of his life.

School.

A visionary entrepreneur and LGBTQ+ pioneer, Larry founded Dial Info Services in the 1970s, the first phone platform for gay men to connect, and later launched Online Buddies, which created Manhunt.net, the first gay hookup website. He also owned The Chandelier Inn Hotel and co-founded beloved Boston gay bars Fritz and Cathedral Station.

Larry was a fierce advocate for civil rights and AIDS awareness, working with Act Up!, the Human Rights Campaign, and the National Gay & Lesbian Task Force. He founded

the Grass Roots Gay Rights Fund and the Boston Gay Pride Street Dance, raising over \$800,000 for community organizations. His compassion extended to causes supporting the homeless and underserved, including Rosie's Place and Pine Street Inn.

In his final years, Larry found peace tending gardens at his 44-acre Stonewall Farm in Douglas.

He is survived by his brother Matthew Basile and wife Charlene of Danvers; sister Joanne Harrington of Hanover; nephews Joseph, Michael, and John Basile, and Matthew Harrington; nieces Kelly Dedeo and Leah Harrington Dexter; his Stonewall Farm community; and devoted caretaker Sidney Alves.

Larry was predeceased by his beloved husband, Clement "Clem" Pepe.

Boston 2025 Election Guide: What You Need to Know

Boston voters will head to the polls this fall to vote for mayor and city council seats. Here's your essential South End guide to the races and key dates.

The Mayor's Race

Incumbent Mayor Michelle Wu faces three challengers in the September 9 preliminary election: retired police officer Robert Capucci, community organizer Domingos DaRosa, and Josh Kraft, business and non-profit executive.

South End City Council Races

At-Large Seats (4 available)

All four incumbents are running for re-election: Council President Ruthzee Louijeune, Julia Mejia, Erin Murphy, and Henry Santana. They face several challengers including: Frank Baker, Yves Mary Jean, Marvin Mathelier, Rachel Nicole Miselman, Will Onuoha, and Alexandra Valdez. More than eight candidates qualified for the ballot, triggering a preliminary election where the top eight vote-getters will advance to the November general election.

District 7 - The Race to Watch

Eleven candidates are vying to replace Tania Fernandes Anderson, who resigned after pleading guilty to federal corruption charges: Said Abdikarim, Mavrick Afonso, Said Ahmed, Wawa Bell, Tchad Cort, Miniard Culpepper, Samuel Hurtado, Natalie Juba-Sutherland, Jerome King, Shawn Nelson, and Roy Owens.

District 2

Incumbent Ed Flynn faces two challengers

in the preliminary election: Charles Delaney and Brian Foley.

Key Election Dates

Preliminary Election

- **Voter Registration Deadline:** Saturday, August 30, 2025
- **Early Voting:** August 30-31 and September 2-5, 2025
- **Election Day:** Tuesday, September 9, 2025 (7 AM - 8 PM)

General Election

- **Voter Registration Deadline:** Saturday, October 25, 2025
- **Early Voting:** Approximately October 18-31, 2025
- **Election Day:** Tuesday, November 4, 2025 (7 AM - 8 PM)

How to Vote Registration: You can register online until 11:59 PM on the deadline, in-person until 5 PM, or by mail (must be postmarked by the deadline).

Mail-in Voting: All registered Boston voters can vote by mail in 2025 elections. Mail ballots must be received by 8 PM on Election Day.

Early Voting: You can vote early at any designated location in the city - you don't need to vote at your assigned polling place during early voting.

Flynn, along with Boston Police and the Wu administration's response team, conducted a public safety assessment Friday, July 18, following resident complaints about increasing rat infestations.

Neighbors and businesses say the problems have escalated since the city removed the Atkinson Street encampment in late 2023. Displaced individuals are creating conditions that attract rats by rummaging through garbage bags and leaving trash scattered on sidewalks, as well as using home-made grills that leave behind food waste.

"One woman talked at length about a

homeless person constantly opening her garbage and throwing it on the sidewalk and on the street, and seeing huge rats as well," Flynn told the Boston Herald.

Steve Fox, chair of the South End forum, described more destructive behavior, telling the Boston Herald: "What we have seen at Mass and Cass is a willingness on the part of people who are just willing to rip the trash apart for no apparent reason, not looking for returnables, but to just seemingly cause destruction."

Flynn filed an ordinance with the City Council last week pushing for the city to create a standalone pest control office led by a "rat czar," citing a Tufts University study showing Boston rats are spreading leptospirosis, a potentially deadly bacterial disease.

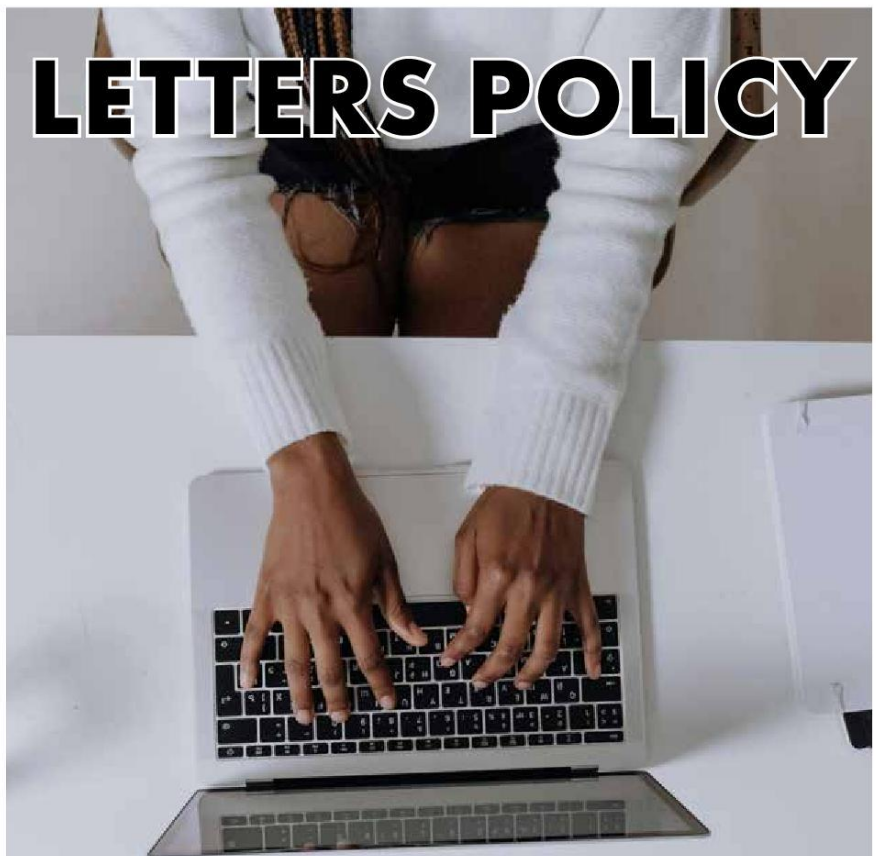

Smith and Colby rate kudos for their smooth movement of the two-part garbage truck — the front where the workers sometimes sit and the back where the bags are actually collected.

Do not be fooled. “The Garbologists” is much more than a visually and verbally precise look at the title pair’s profession. Danny and Marlowe dig into each other’s back story, goals and points of view as much as the intricacies of their work. Initially the two characters could not be more different. Danny reads a Staten Island newspaper while Marlowe reads the New York Times. Danny speaks of each garbage truck having its own personality while Marlowe, a summa cum laude graduate of Columbia University, who studied art history, is prepared to rely on her knowledge and self-confidence. Danny vents about his wife Tiffany’s brief restraining order and his difficulty spending time with his son. Marlowe eventually reveals that her son died of cancer at the age of four.

Playwright Joelle is astute enough to make her characters complex and never stereotypical. Danny may call Marlowe “a Shakespeare on my route,” but he surprises her by speaking of the fiction of significant African American writer Zadie Smith. For her part, Marlowe turns out to favor the New

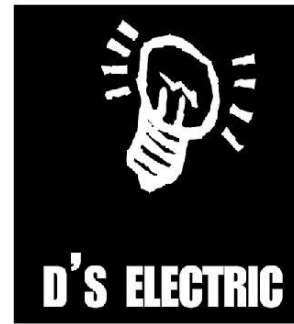
York Rangers — Danny’s favorite hockey team. Marlowe may act as though she does not really want to be Danny’s partner, but the two sanitation workers ultimately realize that they have a lot in common as human beings struggling with personal challenges as well as the demands of their jobs.

Melendy and Bridwell skillfully capture both the conflicts and the growing understanding between their characters. Melendy has all of Danny’s authority as he advises Marlowe about how to judge the content of the garbage bags (especially avoiding dangerous items), lifting only one bag at a time to avoid backaches and learning about a person “from what they throw away.” The comically gifted actor makes the most of a moment when Danny invites Marlowe to look at the dildos in a box put out for collection. Bridwell catches Marlowe’s inner strength volleying responses to sharp comments from Danny and her vulnerability as she speaks about her late son. Theatergoers should find a surprise revelation near the end, tying the characters together properly.

Marlowe introduces the title word for sanitation workers. After seeing Joelle’s disarming play, audience members may agree that ‘garbologists’ are refuse scientists. On the strength of GSC’s beautifully bagged premiere, theatergoers should find the invitation at the end of “The Garbologists” to “share some trash” exhilaratingly understandable.
