Louis Corner to Open in the South End

A neighborhood American gastropub concept by MAZÍ Food Group

On August 6, MAZÍ Food Group (Desnuda Cocina & Bar, Gigi, Ilona, Kava Neo-Taverna) debuted the newest addition in its growing restaurant collection: Louis Corner. Situated on an iconic corner in the South End, on Tremont and Waltham streets, Louis (pronounced Lou-ee) Corner will be an elevated yet timeless American gastropub concept.

With expansive windows lining two sides and exposed brick along the rear wall, Louis Corner has a relaxed and inviting setting enveloped in warm golden tones with plush materials. Using a blend of seating options to encourage a lively social imbibing experience, the 48 seats are a mix of bar settings, brown leather banquettes and mid-top tables flanked with bronze-studded chairs. The bar, topped with gold-flecked black marble, is backlit to display three decorative gold leaf arched plates while rectangular-paneled pearlescent glass and brass chandeliers shimmer above. The bar seats, atop an intricate mosaic tiled floor, are covered in dark blue leather while the seatbacks

are dressed in turquoise and gold velvet. There is distressed oak-planked flooring throughout the dining space, a stunning contrast to the luxe fabrics seen elsewhere.

MAZÍ Food Group's executive chef and owner Jesus Preciado has reimagined a menu rooted in core American cuisine with occasional Irish influences. Designed for sharing, guests can expect a collection of starters like pickables, Rockefeller oysters, fried cauliflower, deviled eggs, and a variety of local oysters. Spanning regional specialties from the Northeast to the south, highlights from the dinner menu include a smashburger, mac and cheese, fish and chips, and jambalaya while classic sandwiches preparations – from a lobster roll to roast beef and a Cubano – grace the menu at lunchtime.

Louis Corner's beverage program will encompass cordials, beer and wine while paying tribute to classic American cocktails. The wine program has been curated to celebrate American vintners, with endeavors based both stateside and overseas, while the beer selections will showcase local and craft offerings available by the can and bottle.

Louis Corner is located at 552 Tremont Street in Boston's South End neighborhood. Louis Corner will be open weekdays beginning at 11:00am with brunch service available weekends beginning at 9:00am.

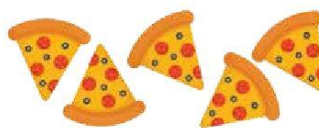

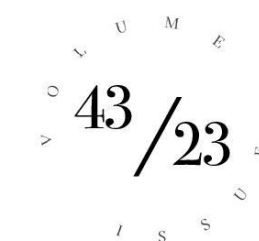
tion—they're about transformation," says OriginNation founder Shaumba-Yandje wa Dibinga. "Through service, cultural exchange, and the performing arts, we open our students to a wider world and a deeper understanding of their own identity and values."

This represents OriginNation's 11th international youth tour since 2009, with previous destinations including Ghana, South Africa, and Jamaica. Students participate in hands-on service projects that teach humility, patience, and global citizenship.

Each student must raise \$1,000 for airfare through community fundraising. Two upcoming performance events will support the effort:

a Conscious Cafe featuring family-friendly spoken word and karaoke performances at Black Market Nubian Square in Roxbury on August 15th at 7pm, and a Line Dancing Workshop at MAMLEO headquarters in Dorchester on August 17th from 2-3:30pm.

The incident took place at approximately 6:55 PM on Saturday, July 26, 2025, in the area of Ruggles Street and Leon Street. During the encounter, the suspect reportedly lifted his shirt and gestured as if armed before stealing the victim's electric scooter and fleeing the scene.

Boston Police Investigate String of South End Break-Ins

Boston police are investigating multiple burglaries in the South End neighborhood, including a break-in at a fire-damaged restaurant and several residential properties.

The Banyan Bar + Refuge was targeted despite being closed since a June fire, with the burglar forcing open the front door that dis-

played a "closed due to fire" sign. It is believed the break-in occurred the last weekend in July, as the business was working to reopen.

A Boston woman has been charged in a break-in of a street-level Worcester Square apartment on the night of July 19. The suspect allegedly ate food, bathed, and stole jewelry from a resident's apartment while they were away.

Police found the apartment in disarray with "multiple food/beverage items opened all over" and various areas rearranged. Surveillance cameras on East Concord Street captured footage of the intrusion.

The suspect was arrested that day for trespassing and again Tuesday on active warrants. She remains in custody.

Death Investigation in the Area of 289 Dudley Street, Roxbury

At approximately 11:57 PM, on Sunday, August 3, 2025, officers assigned to District B-2 responded to a radio call for a person shot in the area of 289 Dudley Street.

Upon arrival, officers located an adult male victim suffering from multiple gunshot wounds. The victim was transported to a local hospital where he was pronounced deceased.

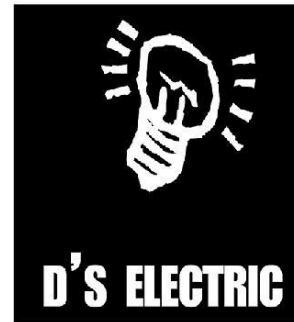

tor's judgment.

After all, this love-focused work often centers on quick-witted Rosalind, arguably the finest heroine in Shakespeare's comedies (Beatrice of "Much Ado About Nothing" notwithstanding). As Maler announced opening night, CSC intends to celebrate its 30th anniversary next year with a return to "A Midsummer Night's Dream."

If fairies and magic dust help to create the enchantment of "Dream," caring, kindness and character transformation make the disarming "As You Like It" a spellbinding achievement. Under Maler's loving direction, the CSC revival should be instantly likeable for the most demanding Shakespeare buffs.

Much of the production's likeability begins with a striking opening set from designer Riw Rakkulchon that immediately establishes the contrast between kind Duke Senior and initially tyrannical usurping brother Duke Frederick. Downstage and backdrop posters signal Senior's commitment to peace and liberty and Frederick's ongoing determination to control and surveil his citizens.

Fight choreographer Ryan Winkles turns the early wrestling match between young hero Orlando and expert competitor Charles—favored by court-based Frederick—into a riveting bout. Once Rosalind—Senior's banished daughter—and her loyal best friend and cousin Celia—Frederick's daughter—head for the Forest of Arden, the CSC stage transforms into a greenery—rich haven with a striking backdrop tableau inspired by the art of French painter Henri Rousseau. This smart scenic contrast mirrors the multiple transformations throughout the play—ranging from the eventual changing fortunes of the Dukes and Orlando and his tough-minded brother Oliver to the 'happy ending' pairings brought to full resolution thanks to the resilience and cleverness of Rosalind.

Equally happy at the Boston Common is the pairing of Maler's inspired direction and a stellar cast with many gifted local actors. Nora Eschenheimer is transcendent as Rosalind. Her portrayal proves definitive in its breathtaking combination of verbal wizardry, playfulness and heartfelt earnestness. Eschenheimer and Michael Underhill—wonderfully impulsive and agile as Orlando—display the kind of singular chemistry that distinguished their work as Miranda and Ferdinand in the CSC 'S memorable earlier staging of "The Tempest."

Paul Michael Valley captures enigmatic outsider Jaques thoughtfulness as well as his cynicism. Valley delivers Jaques' iconic Seven Ages speech with expressiveness and notable phrasing. John Kuntz—vividly attired in argyle and checked outfits by costumer Miranda Giurleo—makes his very good most of Touchstone's braininess and whimsy—especially in the insightful clown's difficult and rewarding seven degrees of lying speech.

Gifted Maurice Emmanuel Parent easily moves from cold Duke Frederick—who emotionally abuses both Rosalind and Celia (whom he calls a "fool")—to the warm Duke Senior (a traditional double portrayal). Clara Hevia is properly understated but discerning as loyal Celia. Joshua Olumide proves very convincing as initially harsh Oliver praises and supports Orlando in the later going and proves a fitting match for Celia. Brooks Reeves has all of sage Adam's wisdom and moral clarity. Vocally gifted Jared Troilo is a repeat scene stealer as forest community rallying Amiens, and David Reiffel punctuates moments of pastoral rapture with affecting music composition and sharp music direction.

Rosalind—uniquely the epilogue here—speaks of her way as a conjuring and hopes the play may please both men and women. Eschenheimer conjures brilliantly throughout as does the summer's outstanding Hub ensemble. Likewise, the CSC's exuberant "As You Like It" is an equal opportunity pleaser.
