The Animal Rescue League of Boston received the largest single donation in its 126-year history — a \$2 million gift from longtime supporters Arthur and Paula Rabe

of Chestnut Hill, the organization announced this week.

The contribution supports ARL's capital campaign for a new three-story, 35,000-square-foot facility at the organization's current South End location. ARL broke ground on

South End Claims Boston's First Michelin Star as Historic Guide Debuts

The South End made history Tuesday night as 311 Omakase became Boston's first-ever restaurant to receive a Michelin star, marking a milestone moment for the neighborhood's dining scene in the prestigious guide's inaugural Boston

edition.

311 Omakase in the South End received one star during the Michelin Guide Northeast Cities ceremony held at Philadelphia's Kimmel Center for the Performing Arts on November 18, according to multiple news outlets covering the announcement. The intimate chef's counter is lo-

cated on the ground floor of a South End rowhouse and features Chef Wei Fa Chen's seasonal omakase with impressive nigiri showcasing high-quality product, much of it imported from Japan, according to the official Michelin Guide description.

Four Arrested in South End Shoplifting Incidents

Boston police arrested four people on shoplifting charges Friday following a series of thefts at retail stores in the South End and Back Bay, according to police reports.

Officers first responded to reports of shoplifting at the Alo store on Boylston Street and later at a nearby

Lululemon location, according to police. A 15-year-old female was arrested with merchandise valued at approximately \$516 taken from both stores, according to police reports.

Later Friday evening, officers were alerted to two known shoplifters inside another store, according to police. Kayla Harris, 31, of Boston,

and Demetrius Little, 31, of Roxbury, were arrested as they left the store with stolen goods worth \$1,422, according to police reports. Both face charges of larceny over \$1,200 and conspiracy, according to police.

In a separate incident, officers stopped a group of individuals

mour co-hosted the afternoon, which featured Rachel Louise Snyder, an award-winning investigative journalist and author whose memoir, *Women We Buried*, explores her own experiences with loss and survival.

Special guests included Governor Maura Healey, Lieutenant Governor Kim Driscoll, Mayor Michelle Wu, and local media personalities from NBC10 Boston, Boston 25 News, Encuentro Latino, and 7News WHDH/WLVI.

Funds raised will support Rosie's Place emergency services including shelter, meals, and a food pantry, as well as long-term programs offering education, legal aid, mental health ser-

vices, recovery support, employment assistance, and housing stabilization, according to the announcement.

"While we do not accept government funding and therefore are not subject to the cuts being made by our federal administration, we still feel their dire impacts," said President/CEO Leemarie Mosca in her remarks. "Because the women who count on us do. And when other programs are cut... that means more women come to Rosie's Place for the help they need to survive."

Founded in 1974, Rosie's Place was the first shelter for women in the United States.

near Huntington Avenue, according to police. A 14-year-old male attempted to flee but was apprehended after a struggle, according to police reports. He was found with \$296 in stolen merchan-

dise and faces charges of shoplifting by concealing merchandise and resisting arrest, according to police.

The 15-year-old female is expected to be arraigned in Boston Municipal Court, while the 14-year-old male will be arraigned in Boston Juvenile Court, according to police.

The restaurant, which opened in summer 2023, offers an 18-course menu starting at \$250 per person, according to CBS Boston's reporting. Chef Wei Fa Chen worked at Masa in New York when it had three stars, The Boston Globe reported.

While 311 Omakase took the spotlight with Boston's sole star, another South End institution also earned Michelin recognition. Toro, which has been a mainstay of Boston's South End for well over 20 years, was named a Recommended restaurant, according to the Michelin Guide. The Spanish tapas restaurant was recognized for being fun and well-run, with highlights

including crisp croquetas with creamy bacalao and roasted bone marrow with oxtail, according to the guide's official description.

Boston and Cambridge tourist officials negotiated a three-year deal to bring the guide to the region, though the exact price tag has not been disclosed, NBC10 Boston reported. The guide included 26 restaurants total from Greater Boston, with six restaurants receiving Bib Gourmand awards and 20 more named Recommended Restaurants.

Martha Sheridan, president and CEO of Meet Boston, said in a statement that the new guide "reflects our work to spotlight the culinary excellence of Boston, Cambridge, and the surrounding region" and that visitors "will travel here specifically to experience our MICHELIN-recognized restaurants."

the \$48 million project in June 2025.

After surpassing its initial \$10 million goal, the campaign has set a new target of \$12 million and is now 96% funded. Thanks to a gift from the Estate of Barbara Loke, donations to the campaign will be matched up to \$715,000, according to the announcement.

"Our Boston shelter is the heart and soul of the ARL, but it is outdated and no longer meets the standard of care that animals deserve," said Dr. Edward Schettino, ARL's president and CEO, in a statement.

The need for a modern facility stems from increasing demand for services

amid the housing crisis, food insecurity, and rising veterinary costs. Over the past five years, ARL has seen a 104% increase in low-cost wellness exams and a 100% increase in pet meals provided to owners facing financial barriers.

The current Boston facility, built in 1956, serves the most animals and people of any ARL location. The new building will include an adoption center, veterinary hospital, dog training center, and community support services hub.

Arthur and Paula Rabe began their relationship with ARL in 2007 when they adopted their cat, Jill.
