Paul W. Duffy

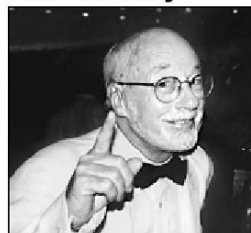

Paul W. Duffy, a lifelong resident of Boston's South End known to friends and neighbors simply as "Duffy," died Dec. 14, 2025, at his home surrounded by family and friends. He was 86.

Duffy was widely known in the neighborhood for his involvement in community and business organizations, including the Ellis South End Neighborhood Association and the South End Business Alliance. He was also a member of the Greater

Police release photo of person of interest in South End shooting

Boston police are asking for the public's help identifying a person of interest connected to a shooting earlier this month along one of the South End's busiest commercial corridors.

Officers assigned to District D-4 responded about 7:45 p.m. March 15 to a report of a person shot near Washington Street and East Berkeley Street, according to a Boston Police Department community alert. Police found a victim suffering from multiple gunshot wounds. The victim was transported by Boston EMS to a hospital and was reported to be in serious but stable condition.

Investigators released a surveillance image of a person of interest seen leaving the area following the shooting and asked the public for help identifying the individual, the department said in the alert.

The intersection of Washington and East Berkeley streets sits in a busy South End stretch lined with restaurants, bars and retail shops. Residents and business owners have periodically raised concerns about safety in the area late at night as the neighborhood's nightlife activity has grown.

Two injured in South End shooting near Shawmut Avenue

Boston police are investigating after two people were injured in a shooting in the South End late Sunday.

Officers responded shortly after 7 p.m. March 29 to reports of gunfire near Shawmut Avenue and Kendall Street and found two people suffering from gunshot wounds and applied tourniquets before Boston EMS transported both victims to local hospitals. Authorities said the injuries were believed to be non-life-threatening, according to NBC10 Boston.

Investigators recovered ballistic evidence at the scene. As of March 30, no arrests had been reported and the investigation remained ongoing.

Croft School

Update: Parents raise emergency funds

Parents connected to the Croft School say they are working to keep the private school network operating after allegations of financial misconduct involving its founder triggered a leadership shake-up and raised concerns about the school's future.

The school's board suspended co-founder Julian Croft earlier in March after discovering what it described as significant financial irregularities and previously undisclosed debt. School leaders warned families that the network had limited cash on hand and could face payroll shortfalls within days if emergency funding was not secured.

Parents and supporters quickly organized a fundraising effort to keep the schools

operating through the end of the academic year, according to GBH news. The effort is intended to stabilize the network while the board investigates the financial situation and determines long-term plans for the schools.

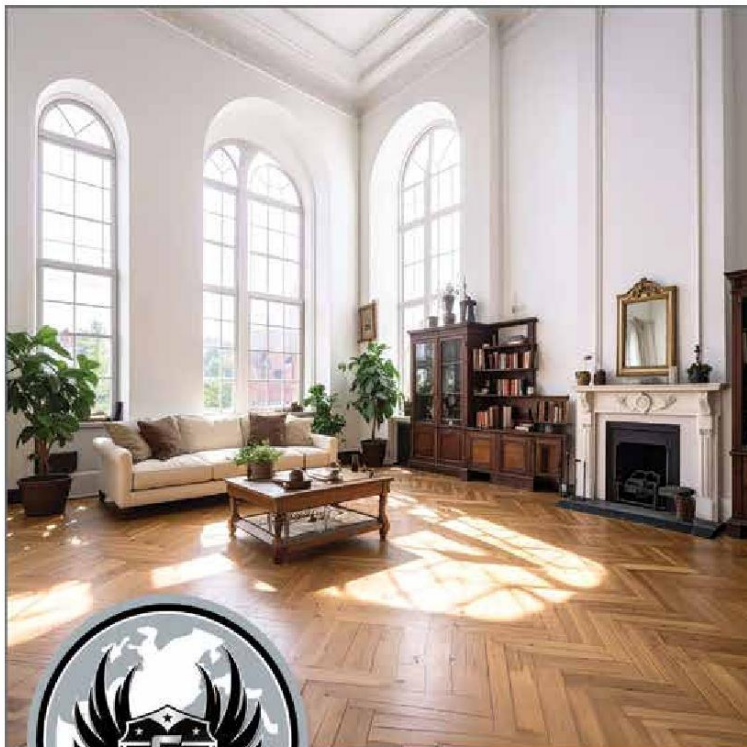
The network includes a campus in Boston's South End, where families have been closely monitoring developments. Some parents told GBH News their immediate priority is ensuring students can finish the school year with minimal disruption.

The crisis has also spilled into the courts. A landlord who owns a South End building tied to a planned Croft campus has filed a lawsuit alleging the founder used falsified financial documents during lease negotiations, according to Universal Hub.

School officials have said they are continuing to assess the network's finances and working with families on next steps.

the closed South End library branch is ready to move forward but still requires the city to release capital funds.

In written testimony submitted to the committee, Yvette Jarreau, president of the Friends of the South End Library, said the project has been included in the city's capital plan for \$32.5 million, with a proposal before the council to increase that allocation to

\$35 million. Jarreau urged the city's Office of Budget Management to release the funds so the project can move into the construction bidding phase, according to testimony published by the Friends of the South End Library.

The neighborhood branch has been closed for several years after severe flooding damaged the building shortly after the start of the COVID-19 pandemic, Jarreau said in her testimony. The closure has left the South End without a local library while the city plans a

replacement facility.

Architectural plans for the new branch, designed by the Boston firm Utile, have recently been updated to address concerns from nearby residents about alley access for vehicles, Jarreau said.

Supporters told councilors the project is ready to proceed once the city authorizes the funding.

Crossley, host of GBH Radio's Under the Radar, according to Pine Street Inn.

Home Remedy is one of Pine Street Inn's major annual fundraising events and supports the organization's work providing emergency shelter, permanent supportive housing, workforce development and street outreach services. The nonprofit says it assists more

than 2,400 people each day as they move from homelessness to stable housing.

More than 500 supporters attended the 2026 breakfast, according to the organization, which described the event as a gathering focused on helping people move "from homeless to hopeful."

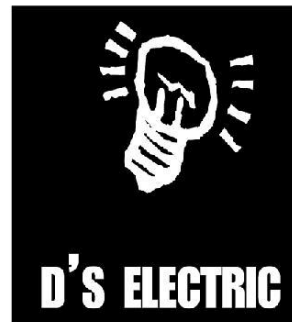
