

## South End Crash That Injured Four Children Renews Pedestrian Safety Debate

Four children and one adult were struck by a vehicle at the intersection of Harrison Avenue and East Brookline Street in the South End on the morning of April 23, according to the Boston Police Department.

Officers responding to a radio call around 10:29 a.m. found the group had been hit while crossing the street. Boston EMS treated all five at the scene before transporting them to a local hospital for evaluation of possible minor injuries, police

said. The driver remained at the scene and is cooperating with the investigation. No charges have been announced.

The crash renewed concerns about pedestrian safety at one of the South End's busiest intersections and revived debate over Boston's use of "concurrent" traffic signals, where pedestrians and turning drivers may receive a green signal at the same time. Police have not publicly identified the cause of the

## City Council Presses Wu Admin Over Stalled Street Safety Projects

Pedestrian advocates and residents packed a Boston City Council hearing April 23 seeking answers from the Michelle Wu administration on the status of road safety projects across Boston, according to reporting from the Boston Globe and Universal Hub.

About 50 people testified during the lengthy hearing, with many citing the mayor's reported policy requiring her personal approval for nearly all street projects involving major redesigns, including lane removals, parking changes and traffic flow adjustments — a change first

## South End Bids Farewell to Cathedral's Msgr. O'Leary After 18 Years

Monsignor Kevin J. O'Leary celebrated his final Mass as rector of the Cathedral of the Holy Cross on Sunday, April 26, after 18 years leading the mother church of the Archdiocese of Boston.

The Mass at 1400 Washington St. was attended by parishioners, clergy and public officials, including Mayor Michelle Wu and former Mayor Raymond Flynn. An outdoor reception followed at the Cathedral entrance on Washington Street.

Archbishop Richard G. Henning, who announced the transition last month, credited O'Leary with overseeing the Cathedral's major restoration and expanding its

## Croft School: London Buyer Emerges After Fraud Scandal

London-based education company Dukes Education has emerged as the lead bidder in a court-supervised sale of The Croft School's two Boston campuses in the South End and Jamaica Plain, GBH News reported April 22.

The development comes after weeks of turmoil following the school board's March 17 disclosure that founder and executive director Scott Given had hidden roughly \$13 million in debt by keeping two sets of financial records, according to the Boston Globe and GBH.

Given was suspended without

pay on March 13 after the owner of a South End building sought to cash a \$500,000 letter of credit tied to a planned Croft expansion into the former Foodie's Market space on Washington Street. Bank employees identified the document as fraudulent.

The mayor expressed her commitment to getting the new building constructed and addressed concerns about city service vehicles being able to access homes adjacent to the proposed new branch between West Newton and Rutland Streets. A physical vehicle test has been

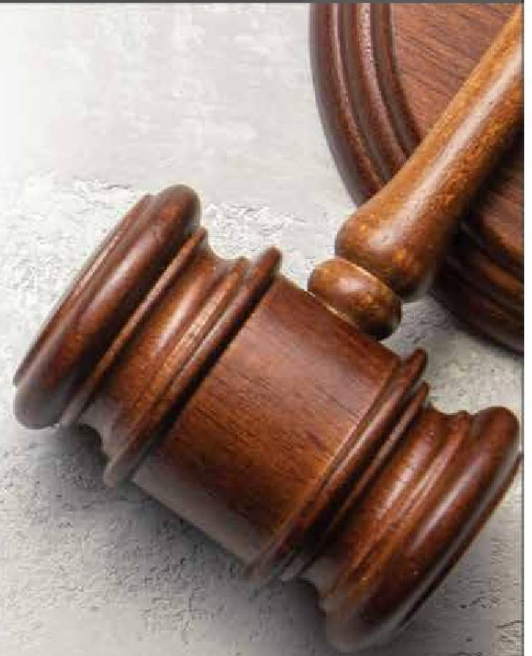

# 'Love Your Block' Cleanups Set for May 2 in South End and Across Boston

Boston's annual "Love Your Block" neighborhood cleanup initiative will return this spring, with local events scheduled for Saturday, May 2, including sites in the South End.

Organized by the city's Office of Civic Organizing, the program invites residents, community groups and volunteers to take part in neighborhood cleanups aimed at improving streets, parks and public spaces.

Participants can either join an existing cleanup site or organize their own. City officials encourage groups to register early, as supplies and support are distributed on a

rolling basis. Cleanup tools will be available for pickup at designated neighborhood locations on the morning of the event and must be returned later that day.

The initiative, formerly known as Boston Shines, has grown into a citywide effort drawing thousands of volunteers each year. In 2025, more than 3,000 participants worked at over 150 cleanup sites across Boston.

Registration for both site organizers and volunteers opened March 10. Individuals and small groups without a designated site can sign up to be matched with a local cleanup.

crash, and city officials have not said whether signal timing played a role.

City Councilor Ed Flynn, whose district includes the South End, has for years pushed the city to move away from concurrent signals in high-foot-traffic neighborhoods, arguing

they create unnecessary risks for pedestrians, particularly near schools and family centers.

Residents also raised concerns through 311 and neighborhood forums following the crash, calling on the city to reevaluate the signal configuration at Harrison Avenue and East Brookline Street. NBC10 Boston first reported the incident. The police investigation remains ongoing.

role in the community. “Under his leadership, the cathedral has become a beacon of hope in the community providing a pastoral

home to Catholics and a place that serves the neediest and people from every walk of life,” Henning said in a statement published by The Boston Pilot.

O'Leary, a South Boston native, was ordained in 1995 and was named Monsignor

by Pope Francis in 2019. He will transition to Senior Priest of the Archdiocese of Boston. Father Christopher K. O'Connor has been appointed the next rector of the Cathedral and is expected to assume the role this summer.

### YARD WASTE

Large yard waste paper bags or open barrel with City issued Yard Waste sticker.

No Plastic Bags inside recycling or compost bins.



### HOUSEHOLD TRASH

Barrels larger than 32 gallons must have wheels and grab bar.



### SPECIAL ITEMS

Not all items can go in the trash. Check the **Trash Day App** to learn how to properly dispose of materials.

- Place leaves and yard debris in large paper bags or open barrels with City issued Yard Waste sticker.

reported by the Boston Globe last month. Among the projects of direct concern to South End residents, the city's spring construction list released the morning of the hearing included plans to redesign Harrison Avenue between Herald Street and East Berkeley Street. City Councilor Sharon Durkan, who chaired the hearing, said pedestrian deaths are rising and that Boston is falling behind its Vision Zero goal of eliminating traffic fatalities. She noted that eight pedestrians were killed in Boston last year and said the number of serious crashes has stopped declining.

conducted, and City Operations has developed two options for the use of Alleys 510 and 529, which will be presented at community meetings scheduled for early May — one in person at Library Park and one virtual. The South End branch has been closed since April 2022 due to severe flooding damage. Rather than reopening the old building, the city plans to replace it with a new facility.

The administration's Neighborhood Services director told councilors that "nothing is on pause," arguing that projects were still moving through review rather than being canceled. That characterization drew sharp pushback from advocates and residents. Reggie Ramos, executive director of Transportation for Massachusetts, called it "the most inaccurate and disingenuous" statement he had heard. The hearing underscored growing frustration over whether Boston's Vision Zero commitments are translating into visible street safety improvements, particularly in neighborhoods like the South End where residents say dangerous intersections remain unresolved.

Parent groups at the South End campus then organized a nonprofit, South End Village Academy, and raised funds to keep the school open through the end of the academic year, according to GBH. The Croft School serves approximately 370 students across its two Boston campuses. The proposed sale to Dukes would not include the Providence campus, which serves an additional 220 students and whose future remains unclear. GBH reported the Boston sale is expected to close in conjunction with the end of the school year.

A full reopening is not expected until at least 2027, leaving the neighborhood without a branch library for years as residents continue pressing City Hall for progress. The Boston City Council took up the issue in February, urging faster action on reopening plans and recognizing neighborhood advocates who have continued pushing for the project. Mayor Wu's FY26–30 Capital Plan includes \$283 million for libraries citywide, with funding to advance a new South End branch among several neighborhood library projects.
