

## Mass and Cass update

### More than half of Mass/Cass tenters moved into new housing

Mayor Wu said Monday that 83 people who had been living in tents along Methadone Mile have been placed in new, "low-threshold" housing - with heat, hot water and

ready access to counseling and health services.

At a City Hall press conference Monday, she said the remaining 62 or so people will be moved by Wednesday, January 12, when the city plans to remove any tents or other structures, a task that could take more than a day

because some are "very large fortified structures."

Wu said answering the "humanitarian crisis" in the area centered around the intersection of Massachusetts Avenue and Melnea Cass

### Helen Bohn Jordan, 89

Jordan, Helen Bohn, died peacefully January 5, 2022. Born August 21, 1932 to Harriet Bohn, Helen's childhood included many strong, loving motherly influences from her grandmother Leila Stevens (Vanderhoof) and her aunts Leila (Adams) and Gladys.

Helen graduated Smith College in 1954. Armed with her sharp mind, a love of language, and a precise eye,

Helen became a freelance writer in New York City; her assignments focused on television and the arts. The interviews she conducted of many contemporary theater and TV stars were published in The Christian Science Monitor and other outlets. It was her journalism assignments for BBC that ignited and satisfied

## News from South End Community Board

### Multiple Day No Mail deliveries reported throughout South End

While the USPS website (as of this Tuesday morning) reflects no delivery problems/delays (for 02118 and others), neighbors from Mass Ave. to Pilot Block and beyond are reporting multiple days of no mail deliveries.

While last week's snow may have played a part in recent delivery delays, we also know that staffing (due to Covid, retirements, personnel cutbacks at the Postmaster's direction, together

with planned mail delivery delays as part of PG&E's new budget model) impacts have become routine for South End zip codes.

About 10 years ago, due primarily to a postal management realignment, the South End saw multiple incidents of missed mail (mostly delays) but repetitive successive days without mail delivery was rare and pretty much weather related. Not so rare any more.

The South End gathered a group

of neighbors who wanted to work on this and created a South End Postal Service Committee and following 6 months of meetings with senior USPS regional folks together with local PO managers, and staff from our congressional delegation, we were able to get significant improvements (including reducing on-going heavy reliance on temporary or fill-in staff and a new

# Mayor Wu Announces Call To Artists

For Year Five Of Boston Artists-in-residence

Mayor Michelle Wu and the Mayor's Office of Arts and Culture announced on Tuesday applications are open for the fifth cohort of Boston Artists-in-Residence (Boston AIR). Through Boston AIR, a group of six artists will spend 15 months collaborating with a parallel group of City of Boston partners to co-design projects that imagine and test new approaches to challenges the City faces.

"Elevating and investing in Boston's artists by bringing them into City Hall and embedding them in our departments' work is crucial to addressing the challenges we're facing as a city in new, creative ways," said Mayor Michelle Wu. "In this moment, arts and culture will help us recover, heal, connect, and thrive."

Through Boston AIR, artists bring their expertise and experience with creative approaches while City partners provide policy expertise and knowledge of City systems. Through the collaboration, artists learn more about government, while City departments practice creative problem solving.

Participants of Boston AIR are asked to co-design projects that consider the needs of Boston's diverse communities, examine City policies with a lens of resilience and racial equity, help residents understand how local government impacts them, support a collaborative creation of City policies and processes, and provide a model for civic practice that departments can use going forward.

"As an artist concerned with the potential of the creative process to positively impact communities, being a Boston AIR was a transformative experience," said former Boston Artist-in-Residence Erin Genia. "It allowed me to think deeply about how my practice might be of service, to develop my ideas within a supportive cohort and to learn how to enact them directly through city processes. It has changed how I see my own contributions to society through art by connecting me with amazing people around the city who are working to address deep disparities and create positive change."

This year, five artists will work with Boston Parks and Recreation, the Boston Planning & Development Agency (BPDA)'s Planning and Research Divisions, the Environment Department, and Boston Transportation Department. An additional artist will be selected to conduct participatory action research with the Mayor's Office of Arts and Culture as part of the program.

"Over the past several years, we've worked with so many talented artists and have seen the continued impact of their projects on City processes," said Kara Elliott-Ortega, Chief of Arts and Culture. "We're excited to work with a new cohort of artists this year, and think creatively with them to break down some of the barriers between communities and government."

This Call to Artists is open to all artists, organizers, and cultural workers aged 18 and over with demonstrated experience working on civic issues, whether through community organizing, cultural work, or social artistic practice. Individuals working in any and all media are encouraged to apply. Each artist receives a \$37,000 artist stipend and up to \$10,000 for project materials.

"A focus of the BPDA in the past few years has been to promote and provide spaces for art in the community through projects like the PLAN: Mattapan Public Art Project," said Director of Planning Lauren Shurtleff. "Now, with Boston AIR, we are excited to bring that artist perspective in, to be applied directly to our work."

"There is an undeniable connection between humans, nature, and Mayor Wu's call to action to build a better future for our children and our planet— and art is a critical vehicle to educate, connect with, and mobilize our communities," said Kathleen Hart, Environment Department Communications Manager. "Through Boston AIR, the Environment Department is eager to welcome an artist to share their unique creative thinking and enhance our work to achieve carbon-neutrality, environmental justice, and resilience."

A virtual info session for interested applicants will be held on Wednesday, January 26 at 12 p.m. ET. The deadline to apply is Friday, February 18, 2022 at 5 p.m. More information about the program can be found at [boston.gov/boston-air](http://boston.gov/boston-air).

and live performance efforts.

### Virtual Theater:

*Black Beans Project* (Huntington Theatre Company). Gifted actress-playwright Melinda Lopez whipped up a rich Hispanic sibling entrée.

*chekhovOS/an Experimental Game* (Arlekin Players). Mikhail Baryshnikov richly played the great Russian writer in artistic director Igor Golyak's interactive look at his greatest plays.

*Much Ado about Nothing* (Hub Theater Company of Boston). Veteran actor Arthur Waldstein was an expressive joy as this clever split-screen zoom—exuberantly directed by gifted Bryn Boice—tuned Friar Francis into Rabbi Francis, complete with tallit and yarmulke.

*Solitaire Suite* (Hub Theater Company of Boston). Marital and parenting dynamics came together intriguingly in this Twilight Zonish odyssey with a wife-mother's perspective.

*Witness* (Arlekin Players, digitally through January 23). Is America different? This 90-minute, unflinchingly probing documentary theater work calls on actors and zoom participants to identify with the nearly 1000 Jewish passengers on the S.S. St. Louis who were refused haven in Cuba, America and many other countries in 1939. There are telling references to anti-Semitic acts in Pittsburgh and Brighton. Gene Ravvin is a standout as an initially cheery onboard talent show host and eventually despairing Jewish Everyman (the "Cabaret" Emcee may somewhat come to mind). Look for good work from Anne Gottlieb as a kippah-wearing rabbi looking for a coming together of Jews, Christians and Moslems and Lauren Elias as an American Zionist.

#### Honorable Mention:

*TJ Loves Sally 4 Ever* (SpeakEasy Stage Company and Boston Conservatory at Berklee).

### Live Theater:

*All Is Calm* (Greater Boston Stage Company)—Inspired choreographer-director Ilyse Robbins helmed this moving history-based musical look at an all too brief World War I holiday ceasefire.

*The Half Life of Marie Curie* (Nora Theater at Central Square Theater)—Lauren Gunderson's stirring play paid tribute to

both the title two-time Nobel Prize winner and her Jewish best friend Hertha Ayrton—a pioneer engineer and Curie's strongest supporter. Lee Mikeska Gardner captured Curie's insecurity, while Debra Wise caught Ayrton's feistiness.

*The Importance of Being Earnest* (Apolinaire Theatre Company). Four versatile actors played the parts in this delightful gender-bending revival of the greatest modern English language comedy—sharply helmed by artistic director Danielle Fauteux Jacques.

*The Last Five Years* (Lyric Stage Company of Boston)—Happily married Jared and Kyra Troilo very convincingly played a couple on marital rocks in this unusual Jason Robert Brown musical. Jared Troilo's portrayal of Jewish writer Jamie Wellerstein—in robust voice and nimble stage movement—was Broadway worthy.

*Macbeth in Stride* (American Repertory Theater)—Lady Macbeth took center stage in this bewitching musical riff on the Scottish play—created by powerhouse talent Whitney White, who will give voice to four other Shakespearean heroines in this A.R.T. series.

*The Merchant of Venice* (Actors' Shakespeare Project)—Was Shakespeare anti-Semitic and did plays like this one contribute in some way to the Holocaust? Igor Golyak turned this very different revival into a powerful if sometimes satiric commentary on these disturbing questions—with Nael Nacer brilliantly intense as Shylock.

*Passing Strange* (Moonbox Productions)—Stew and Heidi Rodewald shared a well-deserved Tony Award for the vivid book of this lively rite of passage musical. Under Arthur Gomez's strong direction, Ivan C. Walks smartly captures both the adventurous artistic impulses and the complex insecurities of hero Youth about love, life and family. Davron S. Monroe has the vocal power and acting chops of a young Ben Vereen as the pivotal Narrator in his best work thus far.

*The Rocky Horror Show* (Moonbox Productions)—A stellar cast brought Richard O'Brien's devilish musical to campy life—especially the iconic Time Warp ensemble.

*The Sound Inside* (SpeakEasy Stage)—Director Bryn Boice sharply voiced the professor-student dynamics of Adam Rapp's wise 2020 Tony-nominated drama. Nathan Malin was riveting as the conflicted budding novelist.

*Teenage Dick* (Huntington Theatre, available digitally through January 16.617-

*Places & Things* tells the story of Emma, a thirty-something actress who thinks she is having the time of her life, until she finds herself in rehab. Though her first step is to admit she has a problem, Emma just wants to escape—through drugs, alcohol, performing—anything that allows her to avoid her own reality. To fighting ticket holders will be contacted by the Calderwood box office later this week about rescheduling their tickets for the run.

"The decision to delay *People, Places & Things* was not an easy one," said SpeakEasy founder and Producing Artistic Dir for her recovery, though, Emma will need to face

Playwright Mike Lew smartly laces his 2018 play-commission by Mozgala himself—with Shakespearean language and parallels. Moritz von Stuelpnagel directs tautly.

*The Tempest* (Commonwealth Shakespeare Company)—John Douglas Thompson was commandingly forceful and feeling as Prospero in one of the company's best revivals.

#### Honorable Mention:

*Gone Nowhere* (Boston Playwrights Theater)

### Visiting Productions:

*A Christmas Story: The Musical* (National tour at Boch Center for the Arts)—Talented young actors stood out—especially in a tap dance ensemble. This affecting musical based on radio raconteur Jean Shepherd's reminiscence focused on spunky Ralphie with some attention to his good friend Schwartz.

*Fiddler on the Roof* (National tour at Emerson Colonial Theater)—Director Bartlett Sher (Oslo) gave this landmark celebration of Jewish tradition and universal family dynamics a special resonance for America by having Tevye seem to look back on life in Anatevka as an émigré. To borrow from activist Perchik, this fine revival had everything.

*Hadestown* (National tour presented by Broadway in Boston at Citizen Bank Opera House; March 7, 2023 at Mortensen Hall, The Bushnell, Hartford, Connecticut; the original Broadway run continues at the Walter Kerr Theater)—The superb tour of this tuneful Tony Award-winning musical called Gershwin to mind and joined climate change subtext to its clever take on the Orpheus-Eurydice myth.

### Special Theatrical Event:

*Och & Oy! A Considered Cabaret* (presented by Celebrity Series of Boston at Symphony Hall; tour includes March 18, 2022 at Ridgefield Playhouse, Ridgefield, Connecticut) Tony Award winner Alan Cumming (Cabaret) and NPR journalist Ari Shapiro—who sings as well as he reports—were the top in a very entertaining and eclectic show mixing talk and song. Look for conversation about their respective comings out and marriages and their close friendship as well as American songbook selections and an affecting duo on "Nowadays" ("Chicago").

Boulevard has required daily work by both city departments and outside agencies, such as the Pine Street Inn, to find housing that gives the people who lived in tents, sometimes for years, a respite from the increasingly harsh winters and help to begin to get them out of the conditions that led them there in the first place.

She added that work will continue at Mass and Cass because the people helped into new housing are only those who have

lived there for a long time, that the city will continue to try to help the people who flit in and out of the area but who don't live in tents there. However, she said that after Wednesday, tents will simply not be allowed back.

"They are not a safe or healthy place for anyone to be living," she said, pointing to the lack of heat and water and a recent spate of fires as tent dwellers turn to propane tanks to try to stay warm.

Wu and Dr. Monica Bharel, who is coordinating the city's overall effort, emphasized they are dealing with the problem from a public-health and housing angle, to try to get what Bharel called "a fragile population"

on the road to recovery, rather than simply having police round them up. Still, Wu emphasized that police will continue to go after people dealing drugs and committing crimes in the area.

Sheila Dillon, the city's chief of housing, said the city has identified a total of 200 units that will be used for Mass and Cass housing, including at the Roundhouse Hotel right at the intersection. She added that the opening of modular, temporary one- and two-person units at Shattuck Hospital has been delayed until next week because of delays in getting electrical service to the area where the shelters have been put up.
