Thomas Wright Waller accomplished a lot as both a composer and performer during his far too short life (39, from pneumonia in 1943). Best known as "Fats," the multi-

talented musician (piano, organ and other instruments) established the Harlem Stride piano style, wrote well over 400 songs and influenced such modern jazz pianists as Errol

It is hard to believe that Tchaikovsky's "Swan Lake" (1875-76) was

initially regarded as a failure after its original Russian staging (1877). Only when French choreographer Marius Petipa and Lev Ivanov collaborated on a new edition two years after the composer's death (1893) did the now internationally popular ballet begin to receive recognition as a truly great work.

Gamer and Count Basie. The internationally busy performer was also known to flavor his performances with humor. Richard Maltby, Jr. and Murray Horwitz beautifully captured Waller's world in their snappy tribute show "Ain't Misbehavin': The Fats Waller Musical." Now a kind of theater triumvirate—Nora Theatre, The Front Porch Arts Collective and the Greater Boston Stage Company—is bringing fresh and high-stepping expression to the deserving 1978 Tony Award winner.

Under the smart guidance of Front Porch co-producing artistic director Maurice Emmanuel Parent—himself a gifted actor (Norton and IRNE Awards) and multi-talent, the current revival beautifully evokes the jazzy ambience of this revue. Designer Elisabetta

Polito has dressed the two men in sharp period suits and the three women in colorful evening wear. At the same time art deco band identifiers precede the upstage musicians, with the piano at stage left. Large wall murals by Harlem Renaissance painter Archibald Motley Jr. encase the cabaret setting with vivid images of enthusiastic aficionados.

The talented quintet are equally enthusiastic—both on the ample selection of Waller classics and songs not written by Waller but recorded by him (all thoroughly identified in the playbill song list). Anthony Pires, Jr. captures the trademark Waller humor that enriches many numbers and makes the most of the devilishly suggestive Andy Razaf lyrics on "Honeysuckle Rose." Lovely Hoffman brings plaintive drama to "Mean to Me." Big-voiced Sheree Marcelle (who alternates with Becky Bass) delivers "That Ain't Right" with riveting forcefulness.

Kira Sarai Helper (who sometimes substitutes for Christina Jones) proves very expressive on "I've Got My Fingers Crossed" in the fast-paced five-number finale.

Remarkably agile Jackson Jirard amazes with the stylish and quick moves of a Bojangles and even mid-air splits. His sardonic phrasing and wonderful elusiveness make "The Viper's Drag" an eye-catching stand-out and stamps this charismatic performer as a large talent with a big future. Parent's snappy choreography (with co-choreography by Ilyse Robbins) keeps the performers' moves as expressive as their renditions. Throughout the versatile band members—under pianist-conductor Catherine Stornetta (subbing for co-music directors David Freeman Coleman and Dan Rodriguez)—capture the diverse demands of both Waller's repertoire and the other mate-

rial he recorded.

If the Waller musical largely comes across as light-hearted and free-wheeling—particularly the strongly choreographed first act-closing winner "The Joint Is Jumpin'," the second act-finale closer "Black and Blue" serves as a timely reminder of the pain that African-Americans suffered (and in some-times subtler ways continue to suffer) at the hands of racists. The first-rate quintet builds this iconic number from a kind of subdued sadness to a powerfully full-voiced harmony.

Parent, in his playbill notes, points to this show as a rarity asking performers "to embody joy and freedom onstage in response to the racial oppression that songs like 'Black and Blue' point to." This collaborative revival of "Ain't Misbehavin'" so joyously celebrates Waller's genius that audiences will want to dance in their seats.

# More housing, services as Boston tries to shrink Mass and Cass

Plan will include new 'day centers' in other neighborhoods

Mayor Michelle Wu announced the city's "warm weather" plan to deal with "Mass and Cass" last week. Basically, more services decentralized across the city, with transportation to get people from the troubled intersection to new "day centers" in other neighborhoods.

At a City Hall press conference, Wu said an earlier program to remove tents at the heart of Mass and Cass has gotten some 200 people into safe "low threshold" housing.

She said the city will continue to remove tents—from both Mass and Cass and elsewhere in the city—but that this would be coupled with outreach efforts to get people into care and safer spaces. This will include 24/7 outreach work in areas where encampments might otherwise spring up. At the same time, the city is stepping up street cleaning in the Mass/Cass area and taking other steps, even down to new crosswalk striping, to improve Mass and Cass—along

with increased police patrols.

Wu said the city will use vans to transport people to centers in other parts of the city where they can get help away from the Mass and Cass environment.

Boston Public Health Commission Executive Director Bisola Ojikutu said this would both help decrease the number of people at Mass and Cass and better reach people near where they live. She added that an existing "engagement center" at Mass and Cass will be expanded from its current medical services to outreach programs to help get people into programs. However, she added it will not become a place for people to congregate.

The centers will be staffed by a variety of clinical and social workers specializing in harm reduction, case management, legal issues related to probation and re-entry to society and some medical issues. She said the city recently issued an RFP to providers, so she does not yet know where these new centers would be. She said she expects to have proposed sites in about a month.

She said that Shattuck Hospital, where the state installed a number of temporary housing units, will continue to be important

to efforts to help get people out of addiction, both through the addition of acute-care services and through the creation of "low threshold" housing.

She added that the city is continuing to maintain and repair buildings on Long Island so that it can eventually be reopened as a treatment services campus once the city can figure out how to get people to and from the site. The city wants to rebuild the former bridge to the island; a plan that the city of Quincy, through which the roads to the bridge run, has fought tooth and nail.

BPD Deputy Superintendent Peter Messina said that along with added services, police have stepped up patrols in Mass and Cass to try to crack down on drug dealers and human traffickers. He said that between May 17 and yesterday afternoon, BPD made 16 arrests and issued 24 court summonses for drug sales and sex for fee. But he acknowledge it's challenging: He said one arrest was of a man found with 131 grams of fentanyl, five bags of amphetamines, two bags of crack and a realistic-looking pellet gun, whom he said told officers he was homeless and a drug addict himself and had tried recovery once, but didn't like it.

Now Boston Ballet has returned to the Petipa-Levanov conception; it premiered in 2014 in a grand revival with additional choreography by company artistic director Mikko Nissinen. The result—exquisitely danced at the Citizen Bank Opera House by the corps as well as the leads—is hauntingly breathtaking.

Nissinen may feel that the ballet's scenario is as mysterious as the evil sorcerer Von Rothbart. Theories abound about what may have originally been a folk tale with supernatural elements. Could Bavarian King Ludwig II (whose life was thought to be marked by the sign of the swan) have been the prototype for focal young Prince Siegfried?

Such questions aside, choreographer Nissinen has strikingly established Von Rothbart's hold on the swans very early on and given him his due as a pivotal character—particularly as danced with slithering moves by Tigran Mkrtchyan opening night (casts alternate throughout the run).

Of course the essential story begins as disarmingly as ever with Siegfried relatively

carefree at the castle gardens. Ji Young Chae, Chisako Oga and especially quick-turning Derek Dunn bring fine form and sweet jauntiness to the pas de trois. Lasha Khozashvili, properly love-struck with Odette, has the right day-dreaming demeanor here.

Corps members are exuberant in the goblet dance and lantern sequence. Khozashvili makes expressive turns with the crossbow given to him by the Queen Mother (properly regal Kathleen Mitchell).

As Siegfried meets Odette at the lake, she understandably reacts with reserve. Still, their romance begins. Even so, the prince must endure the well-meant match-making attempts of the Queen Mother. Khozashvili's non-committal partnering with six princesses quickly establishes the futility of those efforts.

Before the dramatic entrance of Von Rothbart and his daughter Odile, there are high energy ethnic groupings—Spanish dance, Czardas, Neapolitan and Mazurka (sporting designer Robert Perdziola's colorful outfits).

Traditionally the ballerina who dances the role of white swan Odette also dances the role of black swan Odile. Viktorina Kapitonova

demonstrates the expressiveness of an actress as well as the technique of a superb prima ballerina. She has all of Odette's vulnerability and Odile's seductiveness. That seductiveness is all the more stunning when Siegfried appears to be spellbound by Odile's enticing solo dance. Kapitonova's electrifying turns and amazing form make the deception instantly convincing.

With the final return to the title lake in the fourth act, a humbled Siegfried seeks redemption. Music director Mischa Santora—powerfully leading the Boston Ballet orchestra in the softer and louder passages of Tchaikovsky's entrancing score—captures the dominant if sometimes soaring sadness of Siegfried and Odette's reunion.

As riveting as that reunion is the movingly synchronized ensemble of the corps members dancing as Odette's fellow swans. Their strong work on pointe and their sharp hand and arm gesturing demonstrate the high caliber of the company as much as the work of the leads.

In Nissinen's playbill letter, the artistic director refers to the Boston Ballet's "Swan Lake" as the season's "grand finale." Considering the beauty of this revival, that designation is unquestionably an understatement.

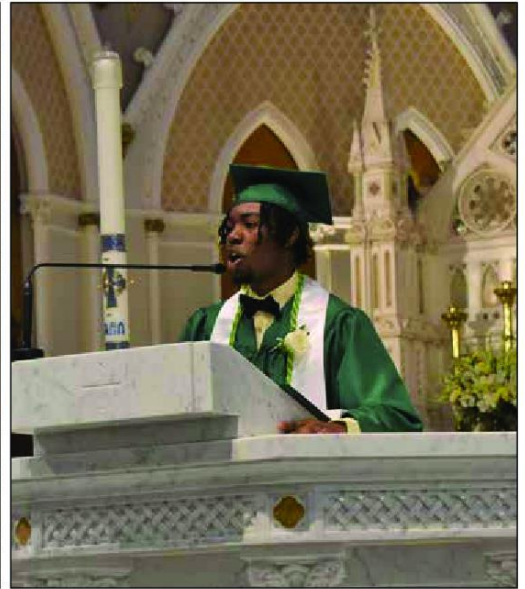

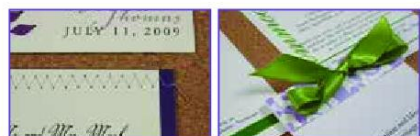
