Two developers have filed plans with the BPDA for their proposed

five-story life-sciences building at 65-69 Wareham Street in the South End, in what would be the latest outpost in a life-sciences corridor along Albany Street.

The new building, which would replace a warren of smaller buildings that started going up around 1875 in

## **Developers win approval for plans to convert what's left of historic Alexandra Hotel**

The Zoning Board of Appeal today unanimously approved developers' plans to retain the shell of the former Alexandra Hotel on the Roxbury/South End line at 1767-1769 Washington Street as cladding for a new 13-story condo building.

Under the latest proposal by developers Jas Bhogal and Thomas Calus for both the old hotel and the neighboring parcel where the Ivory

a then industrial section of the South End. extends to Plympton Street.

Transom Realty-itself based at the corner of Wareham and Albany streets - and Camber Development, headquartered downtown, say their proposed 79,600-square-foot building would have a 44-space underground garage.

In their filing, the developers say they will pay homage to the area's industrial past by retaining the facade of the old buildings for their new one.

#### From the filing:

"The Project represents a unique opportunity to preserve and enhance the historic character of Wareham and Plympton Streets as a light industrial area, as contemplated in the Harrison Albany Corridor Strategic Plan and memorialized in Article 64 of the [Boston zoning] Code. The existing facades along Wareham Street will be preserved, with the new building incorporated seamlessly into this preserved facade. Furthermore, the Project continues the integration of previously approved public realm improvements along Wareham Street, creates the only throughblock connection between Plympton and Wareham Streets on this block, and provides for an activated and engaging ground floor on Wareham Street through retail and publicly accessible lobby areas.

The project would be just across Albany Street from the under-construction Exchange South End complex, which will include life-sciences lab space next to Boston University's National Emerging Infectious Diseases Laboratory, which in turn is next to BU Medical School's campus and research facilities, which lead into the campus of Boston Medical Center.

The Wareham Street developers hope to begin two years of demolition and construction in mid-2023.

Beane building used to be, the new structure will have 70 condos, rather than the 76 they had earlier proposed. They reduced the number of "compact" units-smaller than normally allowed under city zoning codes-from 33 to 19. The number of units they'll sell as affordable will remain at 10.

When Bhogal and Calus bought the long abandoned building from the Church of Scientology in 2018, they proposed using the facade as a shell for a boutique hotel. But those plans foundered with the arrival of the pandemic and they proposed condos instead.

City Councilors Frank Baker, Tania Fernandes Anderson and Michael Flaherty supported the latest iteration of the condo plans today, as did state Rep. Jon Santiago of the South End. Santiago said more housing is just what the area needs and that the new Alexandra would be the herald of a revived Washington Street into Nubian Square.

Also supporting the proposal: Steve Fox of the South End Forum, who agreed with Santiago: "This will bring residential ownership opportunities to the South End, which are really missing, which we desperately, desperately need.

However, several Roxbury residents opposed the proposal, saying that besides being an example of the South End claiming something that is really in Roxbury - which they said meant Roxbury residents were not included in earlier discussions-the building would tower over the area. And they noted it would have no parking. They called for the whole project to go back before the BPDA for a new public-hearing process, because the change from hotel rooms to condos was not a minor change.

Board Chairwoman Christine Araujo addressed the neighborhood line issue: You should take up the conversation with the BPDA and the Mayor's Office of Neighborhood Services about what is Roxbury and what is the South End and what is that middle area," but it's not a matter for the zoning board, she said.

Then) sharing armchairs and reflections with a therapist simply called Doctor. This is the striking frame structure of author Anthony McCarten's book for "A Beautiful Noise," a high energy pre-Broadway tryout at the Emerson Colonial Theatre. Diamond fans will not be disappointed as gifted Will Swenson ("Hair," "Waitress" among others) portraying Neil Diamond-Then captures the vocal distinctiveness and performance intensity of the deep-voiced singer-songwriter. Notwithstanding Michael Mayer's sharp direction of a first-rate cast, "A Beautiful Noise" is currently a very entertaining if not fully satisfying musical.

Admittedly, "A Beautiful Noise"—which takes its title from a Diamond 1976 albumdoes not shortchange theatergoers when it comes to the legend's iconic hits. Swenson catches the edginess of "Solitary Man" and the spiritual feel of "Holly Holy." His "Cherry, Cherry" is properly exuberant, and his strong build-up on the first act-closing "Sweet Caroline" leads to rousing audience responses of "so good" in what has become a kind of Fenway Park anthem. Swenson captures all of the heart and immigrant promise of "America." He delivers Diamond's tender and more thunderous songs with such authority and passion that he becomes the 'Jewish Elvis' (as some referred to the sequined performer)-losing himself in a performance for the ages.

At the same time, the armchair sequences that run throughout the musical do allow for a self-examination of sorts by Neil Diamond-Now. Veteran talent Mark Jacoby ("Showboat" and many others) does as much justice to (now 81) Diamond's wide-ranging misgivings about himself as a husband and parent as Swenson does to the performer's perseverance and determination with regard to his career. Jacoby has the right reluctance totalkabout himself with Doctor, played with a convincing combination of patience and persistence by Linda Powell. Revealing to the therapist that he puts everything he has into his songs, Diamond-Now — forcefully self-

critical in Jacoby's rich portrayal — proceeds to look back at his rise from Flatbush, Brooklyn poverty and difficult years in 'Tin Pan Alley to a talent gaining recognition writing songs made famous by others—"I'm a Believer" for example—and ultimately performing his own material before large audiences.

Along the way, McCarten's fairly informative book gives proper emphasis to the pivotal guidance and support of singer/songwriter/ record producer Ellie Greenwich and the contrasting perilous association with Bang Records. Bri Sudia brings an appealing balance of sardonic wit and good natured caring to Greenwich. There are very different depictions of Diamond's first and second marriages. Jewish first wife Jayne Posner could do with more complexity in the book, though Jessie Fisher provides affecting vulnerability and understanding. Second wife Marcia Murphey, admittedly married much longer to Diamond before their divorce, still receives a fuller treatment-particularly as a strong-willed mate. Robyn Harder finds all of Marcia's earthiness and tenacity. She also displays vocal appeal on "Forever in Blue Jeans," a number that needs better moves for the ensemble tellingly known as "The Beautiful Noise."

The choreography for that ensemble is an ongoing issue. While the ten dancers are hardworking and talented, Steven Hoggett—an Olivier choreography award notwithstanding—often seems to give them repetitive configurations—though a number where they sport transistor radios to hear a Diamond song proves vivid. Another problem involves several numbers where the ensemble distracts from Swenson's charismatic deliveries. Admittedly, audience members did not seem to mind this kind of ensemble overkill as they cheered on dynamic Swenson.

Near the end of "A Beautiful Noise," Jacoby and Swenson come together in a very moving "I Am...I Said" duo after which Diamond-Now speaks of counting all his blessings. Count Swenson and Jacoby two terrific blessings. Diamond-Now notes that Brooklyn was not built in a day. So it goes with "A Beautiful Noise." With the right changes, this enjoyable tryout will make everyone a believer.
