

## Election Results

As South End News went to press, Associated Press projected that interim Suffolk District Attorney will defeat Boston City Councilor Ricardo Arroyo in their Democratic primary for District Attorney. Arroyo declined to concede, saying his campaign was still waiting for more than 15,000 ballots — largely early, mail-in ballots — to be counted.

The state-wide general election will be held on Tuesday,

November 8. The deadline to register to vote is October 29. The vote by mail application deadline is November 1. Early voting will be October 22 - November 4.

On Ballot: Representative in Congress, Governor, Lieutenant Governor, Attorney General, Secretary of State, State Treasurer, State Auditor, Governor's Council, State Senator, State Representative, District Attorney, Sheriff, County Commissioner (only in certain counties), statewide ballot questions.

## Two councilors say part of the answer to Mass and Cass might be locking people up for treatment

Boston City Councilors Erin Murphy (At Large) and Frank Baker (District 3), both of whom have had close relatives deal with drug problems, say one solution to the resurgence of drug problems at Mass and Cass could be to force

people into locked treatment facilities.

As was par for the course at the Aug. 31 contentious council meeting, the proposal sparked outrage among other councilors. Still, Council President Ed Flynn (District 2) assigned the entire issue of Mass and Cass—and the possible use of involuntary commitment

orders brought by close relatives of Mass and Cass denizens—to a council committee for a hearing.

Introducing the request for a hearing on the "humanitarian crisis" at Mass and Cass, Murphy said that despite efforts of the Mayor Michelle Wu's administration and



# Household Hazardous Waste Day

Household Hazardous Waste, Paper Shredding, Textiles, And Electronics



Boston's next drop-off day for household hazardous waste will be Saturday, September 24, 2022, 9:00 AM - 2:00 PM, at the Central DPW Facility, 400 Frontage Road. Boston residents can safely dispose of hazardous waste, shred unwanted documents, get rid of textiles and clothing, and recycle electronics for free.

You must be a Boston resident to drop unwanted materials at our Household Hazardous Waste Days. You need to provide a photo ID, utility bill, or lease as proof of residency. We will not accept any waste from businesses. We also reserve the right to reject any materials that do not meet our regulations.

- You will need to stay in your car at all times during our dropoff events.
- To limit contact, we will not return containers back to you.
- All waste must be in the trunk of your car or in the bed of your truck.
- If your waste is inside your car when you arrive — instead of your trunk or the bed of your truck — you will be given the option to leave the line of cars, place your waste in the trunk or bed, and then come back through the line.
- Pedestrians and cyclists are welcome to attend. We just ask that you check in with City staff upon entering the property.
- We only take waste from Boston residents.

You need to show us proof of your residency. We will not take any waste from businesses.

- Latex and acrylic paint are NOT hazardous. Just let the paint dry out in the can and put it out on your trash day.
- We offer paper shredding at all of our events. We will shred up to 10 copy paper size boxes or containers of your personal documents.
- We accept all clothing and textiles, including pants, coats, hats, and suits. As long as it's dry and not moldy, we want it. But, there are certain items that we can't accept.
- You can also recycle electronics at this event. We don't take commercial material from businesses.

nation, unfair employment, gentrification and deferred dreams. Area theatergoers may remember her strong play "Skeleton Crew" (the third play in the cycle and a 2022 Tony Award nominee) rivetingly staged by the Huntington Theatre. "Paradise Blue", the middle work ("Detroit '67," the first play, as yet unseen by this critic), may not be as thematically focused as auto plant-centered "Skeleton Crew," but a fine Gloucester Stage Company cast is making Morisseau's often poignant dialogue and affecting characters continuously involving.

"Paradise Blue" opens promisingly enough at the appealingly funky late 1940's Paradise Club—kudos to Janie Howland's well-detailed scenic design and Toni Sterling's evocative lighting—in the Black Bottom area of Detroit. Trumpeter Blue means to keep "the only jazz spot in town" open and thriving despite the racism-driven gentrification push of the (unseen) mayor at the expense of the area's blacks. His girlfriend Pumpkin, who cleans the club, gains inspiration as a reflective woman from the poetry of Harlem Renaissance poetess Georgia Douglas Johnson (1880-1966)—especially her 1918 collection "The Heart of a Woman" in which she finds

particular validation.

P-Sam, the strong-willed drummer of Blue's band, heartily endorses Pumpkin's independent thinking even though his love for her is unrequited. At the same time, he seeks the solo time that Blue refused to give the quartet's now departed bassist and questions the obstinate trumpeter's seriousness about the band and the club. Pianist Com, Blue's best friend, observes that people may not be able to afford the club's ticket prices but tries to be a kind of peacemaker between Blue and P-Sam.

That fragile peace receives a serious jolt with the entrance of an alluring woman named Silver, who rents a room above the club. A very self-confident woman with her own agenda, she looks into the possibility of acquiring the Paradise. Still, Silver does encourage Pumpkin to fulfill herself. Complicating that fulfillment are bruises apparently at the hand of Blue and the "demons" plaguing the trumpeter who as a child saw his father kill his mother.

Eventually the play's conflicts reach a fever pitch, but Morisseau opts for an ending that does not seem convincing. By contrast, her "Skeleton Crew" delivers a kind of knockout punch of resolution for its strikingly vulnerable characters. At the same time, the latter play does more with the threat of its plant's foreclosure than "Paradise Blue" does with the perils of gentrification.

Fortunately, co-directors Elise Joyner and Logan Pitts dodge the perils of the play's unresolved second act tensions with satisfying pacing and the contributions of the stellar cast. Destiny Deshuan Washington is commandingly heartfelt and conflicted as Pumpkin. Her affecting declamation of Johnson's pre-feminist poetry will have many audience members searching out the Harlem Renaissance spokeswoman's collections. Durrell Lyons captures Blue's ambition and Alpha male demeanor and does his best with dialogue that needs to do more with the trumpeter's inner torment.

By contrast, Darian Michael Garey has all of P-Sam's understandable rage as well as his tenderness with Pumpkin. Dereks Thomas moves from singular restraint with Blue to telling openness with enticing Silver. Alexandria Danielle King balances Silver's slither with her no-nonsense candor. A particular highpoint is the unusual mentoring Silver provides Pumpkin about dealing with men—here a dynamic virtuoso turn for King and Washington.

Blue seeks 'love supreme,' a moment of perfect harmony. Morisseau achieves such a moment in "Skeleton Crew" if not in "Paradise Blue." Even so, the superb Gloucester Stage cast members—to borrow from Com—do play for their souls.

the Boston Public Health Commission, Mass and Cass has returned to its role as a disease-spreading open-air drug market with rampant drug sales, prostitution, rapes and never ending piles of trash, human waste and needles that re-appear as soon as city crews remove them.

"There are rats there," she said. "We have monkeypox, we have Covid, we have pregnant women falling into the street, we have people who are in need of help."

Murphy, who says she regularly drives through the area, said a couple of weekends ago, she stopped to help a woman just lying there. "I had to get out of the car and I had to Narcan a woman who was almost dead on the ground," she said, adding that once firefighters and EMTs arrived and the woman revived, she simply walked away, rebuffing efforts by her and first responders to get treatment. She was younger than my daughter," she said. "It's just heartbreaking."

Murphy, who says she knows the pain of addiction firsthand—her son was in treatment on Long Island the night it was suddenly shut in 2014—says more needs to be done to protect area residents, business owners and workers, such as the "older Asian women" who have to wend their way through the area to and from their jobs at a Newmarket Square noodle factory.

She pointed to people who go to Mass and Cass in a desperate search to find their loved ones and try to get them out. And that, she said is where "Section 35," the legal shorthand for involuntary commitment, could come in, she said. Perhaps the city could work with families to convince them to go into court and try to have a judge order their loved ones into treatment—and to stay there until they are finished—and that would help reduce the number of substance abusers in the area.

She said she's not saying "we can arrest our way out of this," but said that forcing somebody into treatment can be another option the city needs to try.

"Many times they don't know better," she said of people using drugs. "Sometimes you need someone to step into your life and guide you into a better place."

She concluded, "We need to set aside our feelings to know that if we save one, if we save ten if we save however many, that we have to do better for the neighbors, for the business owners for us, for the city."

Baker, whose brother Ricky died of a heroin overdose 30 years ago, said the city is now wasting \$20 million to \$30 million a year putting Mass-and-Cass denizens up at the former Roundhouse Hotel—only to release them back onto the streets of Mass and Cass.

"Nothing changes, nothing changes," he said, and the addicts, back in the middle of a drug den, "don't have a prayer."

Instead, he said the state Department of Public Health should set up a locked treatment facility at the Nashua Street jail, where families could have their addict relatives committed for serious treatment, as part of an effort that includes more treatment and intervention programs. Last fall, Suffolk County Sheriff Steve Tompkins proposed set up part of the South Bay House of Corrections for use for involuntarily committed people with substance abuse issues, but Mayor Wu rejected the idea in favor of expanding housing and other programs at Mass and Cass and in other parts of the city.

"If we don't start doing things different, all our parks are going to be taken over, all our streets are going to be taken over," Baker said of addicts. "They're in the parks, they're in the playgrounds, they're using our parks for their toilets."

Although both councilors mentioned "Section 35" several times during their discussion, neither detailed exactly what it is. City Councilor Kendra Lara (District 6) asked them to clarify.

"Could I ask Councilor Lara why she's asking for that clarification?" Murphy asked, then added Lara could find out by coming to the hearing on the proposal. At the request of Council President Ed Flynn, she then gave a brief answer.

Councilors Ruthzee Louijeune (At Large), Ricardo Arroyo (District 5) and Julia Mejia (At Large) voiced strong objection to any expansion of involuntary commitment; Arroyo said he was opposed to the use of involuntary commitment in Boston altogether.

Louijeune, herself a lawyer, acknowledged the technique is allowed under state law, but called it "an extreme reaction" that involves depriving somebody of their civil liberties when they haven't been convicted of a crime, so something that should be used only sparingly, not expanded.

"Just because something is legal does not make it just," she said.

Arroyo, also a lawyer, said that in his time as a public defender, he had several clients overdose after being involuntarily committed and that some of his clients who thought they would be put in medical treatment programs were instead sent to jails.

"Section 35s can operate as a death sentence," he said, referring to it as "forced involuntary detoxification." He said he did agree with Baker that the city needs more mental-health programs and an increase in the number of beds in treatment facilities.

City Councilor Julia Mejia, said that, like Baker, she has lost somebody to addiction and added her niece is currently on the streets dealing with addiction.

"Who am I to say I have any right to force her into any sort of environment she's not ready to go into?" she asked. "There is no justice in the way we're moving in this space if we are imposing our own beliefs on others."




