South End Library Services During Closure

The following letter has been sent to BPL staff, Boston elected officials, local organizations, and is for public release

The South End has been without a branch library since a flood closed the building in April 2021, and a second flood in February 2022

forced the permanent closure and replacement of the library building. No alarm systems were installed before the first flood, despite a complete renovation of the interior in 2019. And no alarm system was put in place after the first flood, either. As a result, the South End has not had library services since April 2021, and will not have full library services until three + years from now, when a new building is

estimated to be opened.

Here is a reflection on the loss of five years of library services to our neighborhood:

- By its own numbers, in the first quarter of 2019 the South End branch had 94 programs; it

ZONING HEARING

The Zoning Commission of the City of Boston hereby gives notice, in accordance with Chapter 665 of the Acts of 1956, as amended, that a virtual public hearing will be held on October 11, 2023, at 9:00 A.M., in connection with the Second Amendment to the Development Plan for Planned Development Area No. 106, 1000 Washington Street/321 Harrison Avenue, Boston, filed by the Boston Redevelopment Authority d/b/a the Boston Planning & Development Agency.

Said Second Amendment consists of the conversion of the existing 1000 Washington office building to accommodate new life science uses. The property at 1000 Washington currently comprises approximately 234,809 sf of the currently existing 540,192 sf Gross Floor Area ("GFA") on the Site. The proposed changes will primarily be interior to the building; however, some exterior changes are proposed, including new thermally efficient windows, substantial changes to the exterior envelope at the eleventh floor and expanded mechanical penthouse and rooftop mechanicals; increased energy efficiency measures; and minor changes to the loading dock. The Second PDA Amendment is required for the Revised Project in order to (i) clarify the measurement of building height and (ii) clarify the process for approval under applicable provisions of the Groundwater Conservation Overlay District in the existing PDA.

This meeting will only be held virtually and not in person. You can participate in this meeting by going to https://bit.ly/BZC_Oct2023. Copies of the petitions and a map of the area involved may be obtained from the Zoning Commission electronically, and you may also submit written comments or questions to zoningcommission@boston.gov.

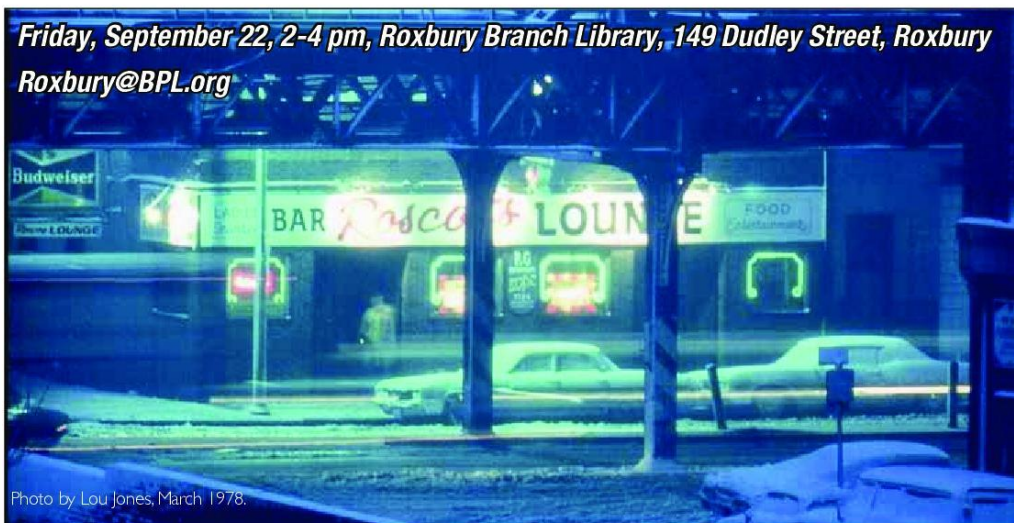

Fund Walk teams to give participants an opportunity to connect with patients. Tianna was diagnosed with B-cell acute lymphoblastic leukemia and is matched with CFS Inc.

"The Jimmy Fund means me feeling better and getting to play with my friends and family," Tianna says. "I want to be a doctor when I grow up."

"Throughout the past 34 years, the Jimmy Fund Walk has continuously supported life-saving research and cancer care at Dana-Farber. The 2023 Walk will be held during the Jimmy Fund's 75th anniversary year and will aim to raise \$9 million in the effort to prevent, treat, and defy cancer," said Zack Blackburn, Director of the Jimmy Fund Walk. "This year also marks the 35th annual Jimmy Fund Walk. We

are eager to get out on the course and see all our outstanding walkers and teams come together to support this great cause."

The Jimmy Fund Walk is the only organized walk permitted on the famed Boston Marathon course, and participants have the flexibility to choose from four distance options: 5K walk (from Dana-Farber Cancer Institute's Longwood Medical Campus), 10K walk (from Newton), Half Marathon walk (from Wellesley), and Marathon walk (from Hopkinton).

Whatever route walkers choose, participants will be treated to 10 refueling stations as well as poster-sized photographs of patients – Jimmy Fund Walk Heroes – displayed at each mile and half-mile marker as inspiration. All four routes of the Jimmy Fund Walk will culminate at the Jimmy Fund Walk Finish Line Powered by Schneider Electric. Due to construction in Copley Square, the Jimmy Fund Walk Finish Line location has been

moved to the Fenway neighborhood for 2023. Walkers should know that distances may be slightly shorter as we finish the walk in front of Fenway Park. The finish line will include a celebration complete with food, music, and a speaking program.

If walkers wish to participate a bit closer to home, the Jimmy Fund Walk has flexible opportunities. Participants can also join the event virtually by "walking their way" from wherever they are most comfortable—in their neighborhood, on a favorite hiking trail, or on a treadmill at home. Materials to support Virtual Walkers are available.

ing alongside the brilliant Nina Yoshida Nelsen (BLO artistic advisor and dramaturg), we grafted Puccini's score onto a new setting but consistent story that re-centers an Asian-American experience in the 1940's." So-called 'purists' notwithstanding, Puccini's masterful score (1904, revised by the composer in 1907) soars in the gloriously sung and acted BLO production. Just as importantly, the envelope-pushing current effort does full justice to Asian Americans as well as opera lovers.

Tellingly, Japanese-American mezzo-soprano Nelsen (who has often sung the role of maid-confidante Suzuki in the opera) is the descendant of grandparents who experienced the indignities of the Poston, Arizona incarceration camp during World War II. In the BLO staging, that incarceration camp—a fittingly stark construct from inspired designer Yu Shibagaki—takes over the Colonial stage for the 1944 second and third acts. Archival images—some found in the very informative playbill—give historical context as well as true dignity to the more than 100,000 incarcerated Japanese-Americans. For much of the contrastingly colorful Club Shangri-La setting of the 1941 first act, the title singer Cio-Cio-San—eye-catchingly attired by costume designer Sara Ryung Clement—pretends to be Chinese to avoid discrimination for being Japanese. Once her irate Uncle Bonzo reveals her true identity and curses her, falling in love with navy lieutenant B. F. Pinkerton will not keep her from being incarcerated after the bombing of Pearl Harbor. Butterfly takes on full tragic dimension as their child Dolore contracts tuberculosis and she holds on to the hope that Pinkerton will return to help him. When the now married Pinkerton returns with his wife Kate, that hope is dashed at the heart-breaking close.

Under the strong conducting of BLO music director David Angus, Karen Chia-Ling Ho richly captures the hopes, dreams and growing despair of Butterfly. She delivers her role's grand arias—particularly the famed "Un bel di, vederemo"—with fully sustained high notes and dramatic intensity. Her scenes with Dominick Chenes—properly dashing and conflicted as Pinkerton—possess superb duets, convincing chemistry and moving conflict.

Alice Chung is a touching standout as caring and supportive Suzuki. Chung and Ho have moments of pure poetry celebrating the joy of springtime and decorating with a rainbow of paper flowers in the flowerless camp. Troy Cook captures American consul Sharpless' concern for Butterfly and her son. There are moments, though, when this robust voiced-singer could do with more projection. Rodell Rosel has all of Goro's impresario expansion in the early going as Butterfly sings with an equally snappy entourage. Some musical theater buffs may find his dynamic efforts bringing together navy men and dancers calling to mind the over-the-top efforts of the Engineer in the admittedly seedy showplaces of "Miss Saigon" (a work inspired by the opera). Hyungjin Son makes the most of Uncle Bonzo's fury. Neko Umphenour has the right vulnerability as Dolore. With Michael Sakimoto's stylish choreography, Cassie Wang proves a graceful solo dancer.

Chang closes his playbill notes with the hope that audiences will find themselves "swept into the story of a mother's unbreakable love." The BLO's sublime "Madama Butterfly" honors the magic of Puccini's music and brings real authenticity to the opera's iconic Japanese mother.

had 20,632 visitors; it had 22,303 items in circulation; there were 738 wireless sessions and 2,845 computer sessions.

- Children and day care groups have lost their branch library, including those from Chinatown Access, Ellis Memorial, Castle Square and Pine Village Preschool, as well as from St. Stephens and the Blackstone Community Center.
- Children also don't have access to the SE branch for the Summer Reading Club or the Read Your Way to Fenway contest; Read Boston won't come by for programs and book distribution; Countdown to Kindergarten won't be there, either.
- A whole cohort of young children miss the rich experience and exposure to a library that builds lifelong learners in the formative years.
- Staff cannot provide traditional and modern services, such as reference; readers' advisory; photocopying; or printing.
- No meeting space for small or large groups, or just a place for people to be. Libraries are free, non-sectarian community centers that offer a safe space, with access to bathrooms, water, and air-conditioning. In the BPL's 2012 Strategic Plan a branch library's significance as a Community Gathering Place is the second most important goal listed.

In late 2022, Friends of the South End Library conducted a survey of South End residents to assess the need for temporary library services. Those results have been widely circulated and highlighted a consistent anchor space for temporary services. A Working Group of some two dozen South End stakeholders was established in November 2022 to explore temporary library services with BPL leadership. It has been meeting every 1-2 months. Several locations and options have been discussed, most prominently a community space available at 566 Columbus Avenue, the location of the former USES headquarters. In addition, a comfortable, temporary, accessible mobile vehicle was considered, as well as a construction trailer that, like an accessible vehicle mentioned above, could be placed either inside in Library Park or on Tremont Street, at the cost of a few parking spaces, or on the sidewalk next to Library Park.

Despite numerous sessions to seriously explore how to meet the devastating loss to the community of library services, the BPL has just informed the community they will merely offer once-a-week programming at Rutland Street's USES's facility, on Thursdays from 10-12:30 starting October 5.

Given the loss of important library services for so many people in the South End, this once per week space does not come anywhere near our expectations or needs. We need consistent, available, accessible, and adequate library services from now until the new building is opened, minimally 3-4 days per week and hours from 10-2 and 3-6, accommodating children and adults for programs and visits.

Important programs and services urgently needed in the South End include:

- Computer access with WIFI
- Children's story hour
- Tax preparation assistance
- Workforce development programs
- Book club discussions
- Children's music programs
- Homework help workshops
- Technical help appointments
- ESOL groups

A library of BPL's stature and reach into the community should always be open to improve and enhance its services. A core principle stated on the BPL website says, "the BPL is a user-centered institution with services that anticipate and respond to neighborhood interests and the changing demographics of the City and Commonwealth." This principle does not seem to be guiding the BPL's approach to the South End Library.

We insist that the BPL's leadership up its game and provide adequate temporary space and services to the community of a closed library. This may require a shift in its approach from Capital Projects focused solely on completing 5 major branch projects to a focus of Capital Projects and Temporary Replacement of Library Services. In other words, a citywide plan to build no more than 3 capital library projects and at the same time replace critically needed library services in a temporary location while a branch is closed for reconstruction. We strongly recommend using the South End Library Branch project to create and implement a citywide template for temporary services during a library's closure for reconstruction or repair.
