

## South Ender Gene Bolinger appointed to Boston Parks and Recreation Commission

South End resident Gene Bolinger was welcomed on October 20 to the Boston Parks and Recreation Commission, a seven-person review body appointed by the Mayor and created by a legislative act and a vote of the people of Boston in 1875.

The Commission oversees the Boston Parks and Recreation De-

partment and has authority over the properties in its inventory. The Commission also reviews projects that are within 100 feet of a park or parkway. The Commission typically meets on the last Monday of the month.

"I am honored to have been named to the Boston Parks and Recreation Commission," Bolinger said at the



Asian immigration to America and eventual citizenship increased significantly thanks to the Hart-Celler Act (though LGBTQ+ immigrants were excluded until the Immigration Act of 1990). Korean playwright Leo Suh ("The Chinese Lady," strongly staged recently at Central Square Theatre) cleverly references this 1965 relative breakthrough for Asian immigrants in the title of his new work "The Heart Sellers," now in an affecting Huntington Theatre

area premiere at the Calderwood Pavilion.

While the 90-minute, no-intermission play could do with more back story about its very different characters—Filipino Luna and Korean Jane, Suh does make their journey from grocery shoppers to real friends engaging, humorous and generally convincing.

Set in an unspecified U.S. city on November 22, 1973, "The Heart Sellers" finds Jane joining Luna at

The Boston Parks and Recreation Department is teaming up with coaches from the Boston Ultimate Disc Alliance (BUDA) to offer free co-ed youth Ultimate disc clinics at the Carter Playground Bubble, 709 Columbus Avenue. The clinics are open to youth ages 7 to 14 for four weeks on Sundays from January 7 to January 28 from 9 a.m. to 10 a.m.

Ultimate, originally known as Ultimate Frisbee, is a non-contact team sport played with a disc flung by hand. Points are scored by passing the disc to a teammate in the opposing endzone. Ultimate is played across the world in pickup games and by recreational, school, club, professional, and national teams at various

age levels and with open, women's, and mixed divisions. BUDA fosters the sport by providing opportunities to learn, play, and teach spirited Ultimate in the greater Boston area.

the latter's unassuming apartment—one well detailed by designer Junghyun Georgia Lee (a first generation Korean-American herself)—for company and conversation that becomes inviting for them as they might hope Thanksgiving would be. While Luna and Jane struggle to make a go of the former's frozen turkey—at which time Jane humorously reveals that she watches Julia Child's cooking show, they soon discover that they have a lot in common.

Both wear coats purchased at K-Mart. More importantly, they are married to workaholic husbands who regularly work very late. Additional information about their respective marriages would add considerably to the play's partial focus on the wives' loneliness.

Eventually they even pour out their hearts about the dreams they have yet to fulfill. Extrovert Luna, remarkably talkative in the early going, loves to sing and eventually does so briefly—here sweet-voiced Jenna Agbayani—at the bidding of Jane. Jane, as she proverbially lets her hair down, speaks of liking “Soul Train” and dances energetically—kudos to actress Judy Song. Song artfully takes Jane from early diffidence to an exuberant embrace of life and friendship.


For her part, Jane—who admires the work of such artists as Chagall and Monet—speaks of art school and wanting to be a painter. As Luna empathizes with Joan, she speaks of a possible visit to Paris and the Louvre. In this light, Henry Mancini fans will welcome a background bit of “Moon River,” which speaks of two drifters off to see the world.

Most important of all, both immigrants come to the realization that their K-Mart clothes and Americanization are metaphorically a ‘costume’—something that does not reflect their inner ‘real heart,’ their respective ethnic heritages.

Under May Adrales' attentive direction, Agbayani and Song capture the beauty of Luna and Jane's Thanksgiving exploration and mutual understanding. At the same time, the very talented actresses sing out the exhilarating enjoyment the new friends share as they humorously speak of such possible adventures as visiting a nightclub or seeing a pornographic movie.

Playwright Suh has chronicled both the manipulation of a token title Asian in “The Chinese Lady” and the full expressiveness of two strong-willed Asian women in “The Heart Sellers.” Do not be put off by quick accent-rich exchanges in his new play. Suh's heartfelt insights are well-seasoned.

## LETTER TO THE EDITOR

**Dear Owners of the present  
Alexandra Hotel,**

Our family has been residents of the South End since 1986. My paternal great grandparents arrived from Baden Baden Germany in 1870 and called this area their home. So I guess my roots and dedication to this area has been in my blood for a very long time.

As a community activist for most of my life, former president of Blackstone Franklin Neighborhood Association, was chair of the Washington Street Task Force under the late Mayor Thomas M. Menino, was the Deputy Director of Community Planning at the Boston Redevelopment Authority for 16.5 years now called the Boston Planning and Development Agency, was chair and board member of Washington Gateway Main Street for 17 years and now a board member of the South End Business Alliance. No one else understands Washington Street area and the importance of the corner of Washington Street and Massachusetts Avenue.

I have dedicated my personal and professional career to the redevelopment of the Washington Street area.

The present site of the vacant Alexandra Hotel is a disgrace. Repeated attempts to develop this building have been attempted by many developers and been vacant for over 50 years as you are aware. Also thousands of hours have been dedicated to improving this corner by many volunteers over the years.

The present condition is an embarrassment since this truly is a gateway coming into the South End and the City of Boston. You've allowed the graffiti to grow, expanded to other properties in the area, the graffiti is now on the boarded up plywood on the hotel, the present scrim on the front has graffiti on it and is torn in many places. The graffiti grows since this building is covered with graffiti and unwanted advertisements, continue to deface this historic building.


It's your responsibility to take down all the unwanted posters and paint over the graffiti on the plywood and doors etc with a dark color.

Post "no advertising" on the plywood. Put up a new scrim on the front of the Alexandra Hotel on Washington Street. Hire a company to power wash the sidewalks around this site and in the alleyway. The present condition of the building is making the area feel very unsafe for our businesses, nonprofits and residents of the area. I understand taking off the graffiti on the stone surfaces is problematic, however the rest can be removed by simply painting off the graffiti and spending some money to improve this site.

I also understand that your investment is once again for sale, however why would a buyer purchase this building in this condition? As I tell my clients that when you are going through an approval process and after, you need to be good neighbors and keep the building and the perimeter in good condition.

This site is a blight on the area. Action and commitment to this historic building needs to be taken NOW.

time of the announcement. "To my core, I believe that public parks are essential. Having spent my professional career as a landscape architect, working to improve public parks and open space assets in Boston and elsewhere, I now have a chance to contribute in a new way."

A Massachusetts native, Bolinger and his wife Sharon reside in the South End, and their two adult daughters are also Boston residents. Gene joined the Massachusetts-based environmental engineering firm Weston & Sampson in 1999 as the first landscape architect and established a vibrant landscape architecture practice. He helped the firm grow various business lines, and led, at times, the transportation, architecture, and municipal facilities practices in addition to landscape architecture.

For 38 years, Gene worked to improve public parks, playgrounds, recreational facilities, athletic fields, and civic spaces through the capital planning and construction process. This included approximately 150 projects in the Boston Parks and Recreation system since 1984, the first being the reconstruction of the first pedestrian path on Boston Common, Railroad Mall, and the recently completed Master Plan for Boston Common.

Gene retired from professional practice as a registered landscape architect in July 2022.

"We are pleased to welcome Gene Bolinger as an Associate Commissioner," Boston Parks Commissioner Ryan Woods said upon his appointment to the Commission.

"Gene's history of participation in the protection, enhancement, and expansion of Boston's amazing park and open space system aligns with our goals to help provide safe, compelling, equitable and essential park and recreation facilities to all residents of our great city."


