## A provocative Villain

Re-reading a classic drama can change a playwright's perception of the male protagonist and the work itself. So it goes for North Georgia-bred Kimberly Belflower and the 1953 Arthur Miller work "The Crucible." As the Huntington Theatre playbill for the area premiere of her 2018 play "John Proctor Is the Villain" notes, Belflower was taught in high school that "John Proctor is the beacon of goodness and the girls are hysterical."

With her re-reading, she arrived at the title of her play. Under the driving direction of Margot Bordelon, a strong Huntington cast empowers that provocative conclusion with #MeToo era immediacy.

Inspired by her own experience,

Belflower has fittingly set her "John Proctor Is the Villain" in a current-day Appalachian Georgia high school classroom. English teacher Carter Smith—explaining that 200 were charged and 20 executed in the 1692 Salem witch trials in a time of mass hysteria—describes the drama unit choice "The Crucible" as an "allegory for McCarthyism."

Smith submits that Proctor is "one of the best characters ever" and considers him a "great hero." Conflicted student Shelby Holcomb counters that married Proctor is a villain and never apologized to Abigail Williams, with whom he had an affair. Tellingly, female classmates, whose feminism club has been rejected by the school, find themselves defending Abigail

part and parcel of gospel music.

Moreover, what would gospel music be without the boys in the choir loft and gay church musicians?

There is an undeniable queerness to gospel music, a particular interpretation, and expressiveness by LGBTQIAs—churched and unchurched. As repressive as the Black church is around openly LGBTQIAs, many of us nonetheless are drawn to its gospel music.

"It's Black folks' prayer and lamentation. It's our language and expression as a people that cannot be taken away. It speaks to times of great joy and sorrow. It mirrors my breath and the beating of my heart. It is soul-stirring, and a meditation with your spirit with whoever and whatever is your God," Gary Bailey waxed poetically.

Bailey is a professor of practice and assistant dean for community engagement and social justice at Simmons School of Social Work and is a member of Union United Methodist Church, the first "open and affirming" Black church in New England.

The Black church applauds its LGBTQIA congregants in the choir pews yet excoriates us

from the pulpits. It pimps our talent yet damns our souls with the theological qualifier of "love the sinner but hate the sin." Our connections and contributions to the larger Black religious cosmos are desecrated every time homophobic pronouncements go unchecked in these holy places of worship. However, our pull to gospel music is seen as a calling, a distinctive gift to the church, and an expression of queer pain and hardship.

For Charles Evans, "Gospel music is tied to suffering, black suffering and certainly black gay suffering. It communicates our trials and tribulations through song that a better day will come." Both Evans, former vice president of Cape Cod Pride, and his spouse, is Program Coordinator for the LGBT Elders of Color at the MAC.

Donell Patterson told me his "entire life has been gospel music," and he has the resume to prove it. Patterson is chair of the Gospel Music department in New England Conservatory's School of Preparatory conducts three renowned Gospel Choirs in the Boston Area. Patterson has observed through the years that some Black church denominations are queerer than others. "Those denominations are more open to gays without announcing it, because of its liturgy and organizational structure like Pentecostal churches," Patterson shared.

The Church of God in Christ (COGIC) is the largest Black and Pentecostal church in the United States. Many of the gospel music industry mega-stars are from COGIC. The church, however, is conflicted with itself. These Black gay male mega-stars are always forced to go back into the closet, publicly denouncing their sexual orientation at the church's annual convocation.

Toxic masculinity contributed to the early years of AIDS, ravaging the gospel industry. The effects of AIDS were widely discussed but rarely publicly acknowledged until the death of James Cleveland, the King of Gospel, in 1991. Cleveland was influential in bringing gay men into the industry. He was a fixture at gay parties in cities he toured, and it was an open secret. However, the most devastating

news following Cleveland's death was when a male member of Cleveland's choir sued his estate, alleging he contracted HIV during their five-year sexual relationship.

Homophobia and hypermasculinity are rebuked by many openly gay men in gospel music. They see it as a complex welcome space, allowing enough wiggle room to be themselves. "Gospel music allows you to emote where you can be openly expressive in public with your emotions that you can't be with your sexuality. In gospel music, you don't have to suppress either," Glass states. "Women and gay men can allow the music to take them where heterosexual men cannot go."

For me, gospel music is an embodied musical extravaganza. It reminds me that our bodies are our temples, housing the most sacred and scariest truth about us: our sexuality. Through gospel music, I learned that sexuality is an essential part of being human. It is an expression of who we are, a language, and a means to communicate our spiritual need for intimate communion—human and divine. When we embrace the Christian mind-body dualism, we lose our bodies, sexualities, and spirit.

Gospel music helps me not to forget that our sexuality is a spiritual site of revelation, an intimation of the holy unavailable in any other experience, and a source of our capacity for transcendence. However, the church and school truncate that ability to experience an embodied spirituality and homophobic peers.

Gospel music is theater and dramatics rolled up in song. With its overtly gay overtones, Gospel music is in the DNA of both Black sacred and secular cultures. It cannot be overlooked in its influence in Aretha's songs, Little Richard's flamboyant performances, Alvin Ailey's signature dance piece "Revelations," or the public fire and brimstone exhortations of James Baldwin, whether at the pulpit or in his writings. "You can't listen to them and not hear the gospel influence or hear the music of the church in them," Bailey stated. "And, as for Black gay men, well, it allows us to be peacocks with our multicolored feathers on display."

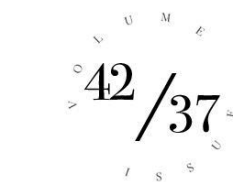

Public Schools, and his wife, a member of the Lincoln METCO Parent Board, he joined the METCO Board of Directors in 2017.

and young girls accused of dancing naked and consorting with the devil.

As Belflower's clever play develops, the class, especially female students, relate the claims about various characters in Miller's frequently staged and very admired play to accusations and suspicions about the people in their own lives. Classmates wonder about the reason why Shelby was away for six months. Standout student Beth Powell feels that Smith is the best teacher, but troubling questions arise about his own actions outside of class.

Ivy Watkins struggles to cope with accusations brought against her father by his former secretary. At the same time, Raelynn Nix resists efforts by inappropriate ex-boyfriend Lee

Turner to persuade her that he has changed.

While a serious play with striking extrapolations to modern day issues, as was true of Miller's own play, "John Proctor Is the Villain" does balance dramatic situations with humorous and lighter moments and embrace the growing independence of its young characters, particularly the female ones. Early on female students speak of Smith as "hot" and comment suggestively about him. Mason Adams, seemingly sincere, calls Nell Shaw 'cool', who states "I'm super not cool" and asks her to hang out. There is an amusing confusion of 'sabbatical' and (Jewish) 'Sabbath.' When four of the female classmates scream and jump, entering Lee and Mason facetiously ask if there is "actual witchcraft in here?"

Belflower's play, neither strident nor didactic, does compel attention for the troubling

questions it poses. In designer Kristen Robinson's well-detailed classroom, Huntington's stellar cast deliver vivid answers in both dialogue and movement, the latter most notably in a kind of closing dance of empowerment.

Jules Talbot captures Beth's early reticence and eventual openness. Isabel Van Natta is riveting as outspoken yet vulnerable Shelby. Brianna Martinez has all of Ivy's earnestness and insecurity. Haley Wong catches Raelynn's self-validation and inner strength. Victoria Omoregie smartly balances Nell's engaging personality and insightfulness. Benjamin Izaak finds Lee's clueless moments, while Maanav Aryan Goyal captures Mason's growing understanding of fellow female classmates. Olivia Hebert has school counselor Bailey Gallagher's real attempts at guidance. Japhet Balaban has all of Smith's complex-

ity as an admired teacher and an enigmatic personality.

Belflower, in a playbill conversation, speaks of "examining cycles of power, cycles of abuse, how cycles of teaching 'The Crucible' the same way over and over again leads to one rigid interpretation." In his own way Miller was examining cycles in the 1950's, and the play's warning about naming names and guilt by association do relate to Nixon's 1970's enemies list and Trump's ongoing threats to those who oppose his election denial and dictatorship dreams.

Fans of the Miller play will have to decide how the Belflower play responds to "The Crucible." The dazzling staging of "John Proctor Is the Villain" should have all theatergoers studying both plays for their respective timely insights.

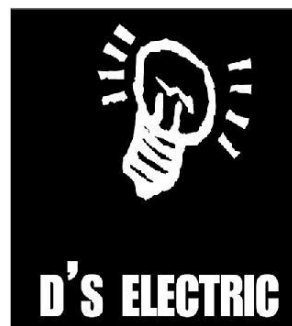
