

51st Festival Betances Celebrates Vibrant Sounds and Soul of Latinx Culture

New England's longest-running Latino cultural festival draws over 3,000 attendees

On Saturday, July 20th, Inquilinos Boricuas en Acción (IBA) hosted Festival Betances: Un Verano en Betances, a day-long celebration of Latinx culture, soul and sound, which brought the vibrant energy of summer in Puerto Rico, the Caribbean and South America to the heart of Boston. The festival, which took place in the South End's Plaza Betances, marked over 50 years of community, music, and joy.

The event, which is New England's longest-running Latino cultural festival, featured a star-stud-

Medicare Savings Program, Property Tax Workoff & City Savings for Older Adults

I'm excited to let you know about two important programs that help our older residents save more money:

The first is the Medicare Savings Program (MSP)—which now offers more savings to more residents. Thanks to changes that went into effect earlier this year, assets are no longer counted against your eligibility for this program, eliminating a major barrier for access. And, on top

of that, the amount of money you could save on Medicare-related costs like premiums, copays, and prescriptions has increased as well—from \$2,500 a year to \$3,000.

The second program I want to tell you about is Age Strong's Property Tax Workoff Program (PTWOP). The PTWOP invites Boston homeowners age 60 and older to volunteer with the City in order to work money off of their property taxes. PTWOP

D-4 Officers Arrested Armed Robbery Suspect In The South End

At about 5:02 PM, on Friday, July 12, 2024, officers assigned to District D-4 (South End) arrested a 29 year-old man, of Boston, on robbery and assault charges.

Officers responded to the area of Massachusetts Avenue and Shawmut Avenue for a report of an armed robbery in progress. Boston Police Operations advised officers that someone was

getting robbed and a male suspect had a knife.

"Festival Betances has been New England's premiere Latino cultural festival highlighting the need for Latinx-focused programming. We're dedicated to ensuring the Latino communities of Massachusetts are celebrated and empowered through arts and community development," said IBA CEO Vanessa Calderón-Rosado. "Festival Betances is a declaration that Latinx culture is integral to Boston's diverse tapestry and it's heartening to see a growing diverse audience, including non-Spanish speakers, and strong corporate and donor support, signaling a shared commitment to inclusivity and cultural celebration."

In addition to the musical performances, Festival Betances highlighted the diversity

of Latinx culture through a lively parade, a variety of food trucks and vendors offering traditional cuisine, and arts, crafts and children's activities like face painting and inflatables. The festival drew a multicultural audience of over 3,000 people from across Boston, the Commonwealth and beyond.

The event also featured guest emcees Rubi Tiburcio from Mega 96.5 FM, and Abimael Castro from Telemundo Nueva Inglaterra. Notable attendees included Luz Gladys Oliveros, Latinx Cultural Advisor for the Office of Mayor Michelle Wu, Boston City Council President Ruthzee Louijeune, Boston City Councilor Ed Flynn, Boston City Councilor At-Large Julia Mejia, and more.

Festival Betances is IBA's flagship arts event, in addition to year-round programming encompassing the Tito Puente Latin Music Series, Holiday Concert, jazz concerts, and gallery exhibitions. public high school graduates will receive a \$4,700 award toward post-secondary STEM education.

The scholarship is named for Paula Apsell, Senior Executive Producer Emerita of the science series NOVA, which is produced by GBH and seen nationally on PBS. The scholarship application process is open to all Boston public high school seniors planning post-secondary education in the fields of science, technology, engineering, and mathematics.

"GBH is proud to support the 2024 cohort of Paula Apsell/GBH STEM Scholars as they pursue careers in STEM," said GBH President and CEO Susan Goldberg. "With a growing demand for a talented and diverse STEM workforce, we honor and support this remarkable group as they enter college and equip themselves with

the skills needed to succeed."

The scholarship winners represent five Boston public schools: Boston Latin, John D. O'Bryen School of Math & Science, New Mission, Boston International Newcomers Academy, and Boston Arts Academy. They plan to study STEM related fields at colleges and universities across the country this fall, including Brown University, Massachusetts College of Pharmacy and Health Sciences, Simmons University, Boston University, and Cornell University.

The scholarship, which launched in 2020, is underwritten by GBH for 10 years. To date, 61 students representing high schools from across the city have been awarded the Paula S. Apsell/GBH STEM Boston Public Schools Scholarship for their future studies. More about the students can be found here:

The founder and the continuing inspiration of the Campaign for Catholic Schools, Jack drew a broad range of talented women and men together in the service of providing quality education for children of all faiths and from all social strata of our civil society.

He is widely praised for his commitment and leadership involving many important organizations that serve the common good. Here I feel particularly privileged to be able to acknowledge his impact on Catholic education

in an Archdiocese where schools have been the pathway in the past and continuing today for children of citizens and immigrants to become successful members of our society.

Jack brought his widely esteemed business acumen to his life as a citizen and a Catholic. I use this tribute to particularly emphasize his commitment to build a better American society one marked by social justice and fairness. Jack's faith and Jesuit education grounded his conviction to honor the human dignity of every person of every faith and every ethnic or racial community which make up the mosaic of the United States. His position and role in Boston offered him the opportunity to enhance human dignity, to foster human equality and to provide a model for others who joined him in so many endeavors across several decades.

We have lost a great friend and a great leader of our common life in Greater Boston, but we are a better community of neighbors, friends, and citizens because he lived and worked among us for so long.

distribution of free air-conditioning units to Boston families.

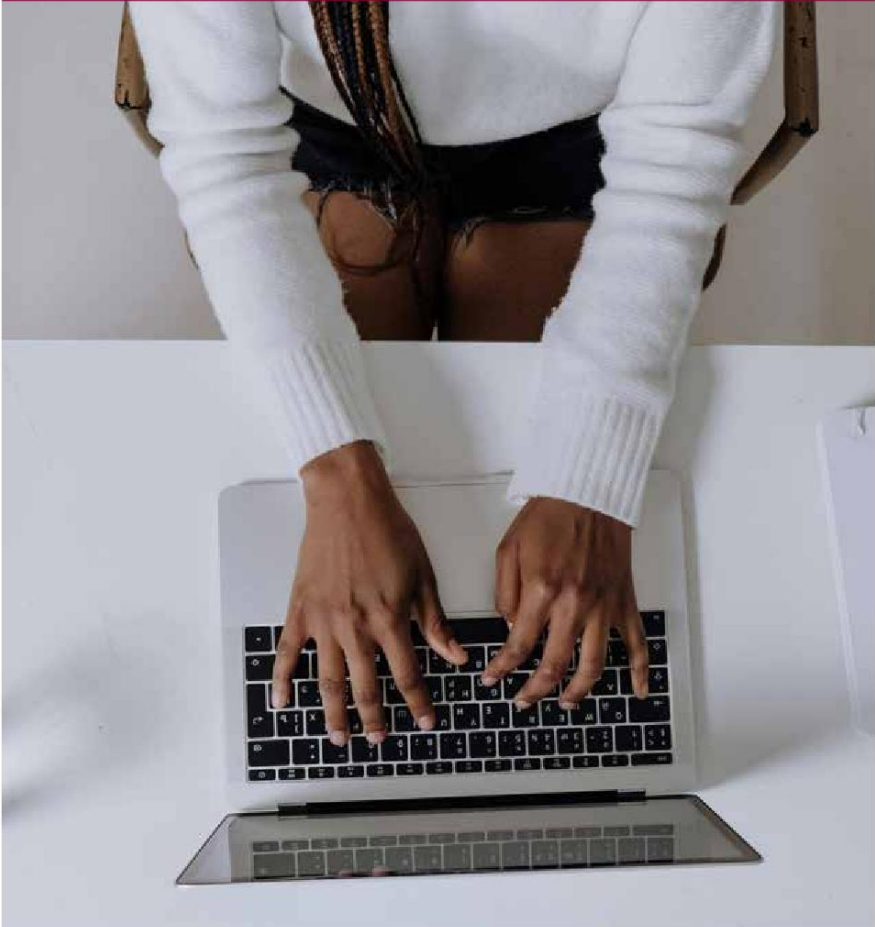
