### Arrests made in shooting of police officer

Shortly before 2 p.m. on Sunday at West Springfield Street between Shawmut Avenue and Washington Street a Boston Police officer was shot.

One suspect for the shooting

of the gang-unit officer was quickly arrested. The second holed up at 89 West Springfield St. After SWAT officers surrounded the building, he surrendered peacefully shortly after 3:20 p.m.

Boston Police report Requan Martin, 21, of Boston, and Antoine Mack, 35, of Pawtucket, RI, were arrested on charges of armed assault to murder, assault and battery with a dangerous weapon, unlawful pos-

tape, and paint to be used in their coursework throughout the rest of the fall. They'll spend six weeks with the handmade violin learning different pieces of their instrument including strings and tuning pegs, among other parts.

Each week they earn a new part to learn

about until the instrument is finally complete. After its completion, they will have a ceremony where the kids trade in their handmade violin, and it "magically" turns real. In reality, the students are each gifted with their own violin, which they will use throughout their time at Bridge Boston, a public charter school in Roxbury.

session of a firearm, unlawful possession of ammunition, unlawful possession of a loaded firearm and discharging a firearm within 500 feet of a building.

Police did not say which suspect was arrested first and which surrendered only after the building was surrounded by SWAT team members. Both are scheduled for arraignment tomorrow in Boston Municipal Court.

### Roxbury shooting suspect sent to Bridgewater for evaluation after police say they found an arsenal in his apartment

Ismail Abdurrahid-McCullum, 50, was ordered sent to Bridgewater State Hospital for 20 days for observation at his arraignment today

on charges he shot a man on Shawmut Avenue early Monday, September 24, with what police now say was only one of several weapons he kept at his apartment and in his car.


Abdurashid-McCallum was originally arrested on charges of assault with intent to murder, assault and battery by means of a dangerous weapon, unlawful possession of a firearm and discharging a firearm within 500 feet of a dwelling.

But Suffolk County prosecutors added additional charges - ten counts of improper storage of a firearm, nine counts of unlawful possession of a firearm, two counts of unlawful possession of a large-capacity feeding device, and one count of unlawful possession of a sawed-off shotgun - after police obtained search warrants for his 95 Munroe St. apartment and car that they say turned up "six revolvers, two semi-automatic pistols, a sawed-off shotgun, a bolt action rifle, a silencer, shotgun ammunition, rifle ammunition, pistol ammunition, as well as an empty pistol holster" in his apartment and an additional pistol, holster and rifle ammunition in his car.

first one, *The Queen of Saba*, received a glowing write-up from Boston Classic Review; the next, *The Doctor In Spite of Himself* will be at the Huntington Theatre on November 9 and 11. *Odyssey's* three spring 2019 operas are inspired by "the face that launched a thousand ships," *Helen of Troy*; *Paris and Helen* by Christoph Willibald Gluck (2/15 and 2/17); *The Egyptian Helen* by Richard Strauss (4/19); and *The Beautiful Helen* by Jacques Offenbach (6/14 and 6/16). Each year, Rose and Fuller come up with a new theme to carry their eclectic and adventurous programming. Last year's *Trial by Fire*, saw five operas by different composers inspired by the life and times of Joan of Arc. What's up for the next season, or how that is decided, is one of the questions you may want to ask Gil Rose.

### Local/Focus

The displays are installed regularly, depending on time and availability of participants and volunteers. Timelines are flexible.

### Library Renovation

Mayor Marty Walsh spent more than an hour at the South End branch on September 11 for a South End Forum neighborhood meeting to talk about a range of issues, including the opioid crisis, homelessness, lack of affordable housing, parking issues and rising sea levels. FOSEL thanked Walsh for his extraordinary support earlier this year to fund short-term and long-term library and park renovation plans, for which he received a round of applause.

Walsh commented the South End library's long-term renovation might not take as long as the seven to ten years that are anticipated. The Mayor has committed \$145.5 million in capital dollars for Boston public library renovation over the next five years, as per this link. Among earlier such outlays by the Walsh administration are more than \$80 million for the Central Library's transformative renovation and \$10 million for the Jamaica Plain branch, which reopened two years ago.

### Renovation of Library Park

The Parks Department is still waiting for back-ordered furniture to be installed; this includes several rounded benches and some cafe tables. The park's oak trees are still awaiting pruning.

Thanks to Boston voters approving the property-tax based one-percent surcharge under the Community Preservation Act (CPA) in 2016, there now is money available for the landscaping of, among other places, Library Park. FOSEL is applying for a CPA grant to do just that, with support from BPL President, David Leonard and Parks Commissioner, Chris Cook. We welcome suggestions from all. The South End Stakeholders Report, published seasonally by the Steven Cohen Team, features in its Fall 2018 issue an excellent report about the unique public/private partnership between the BPL, the Mayor's Office and FOSEL to renovate the South End Library, he really group has been very supportive of FOSEL over the years; Steven Cohen himself is a member of the Honorary Fundraising Committee for the Capital Campaign.

winner fully embraces the very different people who live in or visit its run-down but impressively spacious Manhattan setting, and Diaz' strong effort helps to establish the play's heartfelt endorsement of extended family and human connection.

As the play's intriguing title suggests, that connection may sometimes seem crazy. After all, retired NYPD cop Walter Washington—better known as Pops—has a knack for putting off family and friends alike with his cantankerous personality, repeated reliance on curse words and signature stubbornness. At the same time, though, he possesses a heart and a generosity of spirit big enough to touch and mentor the diversity of people who inhabit his world. Tellingly, he states without judgment that there are men who need men just as there are women who need them.

Guirgis quickly and skillfully depicts that diversity. Bronx native Oswaldo, an ex-con determined to remain sober, calls Pops 'Dad' and assists him. Junior, Walter's actual son, is a student at City College but seems to be running a questionable business with boxes of items from the likes of Lowe's. The heated arguments between father and son are classic,

but so is their deep if sometimes unseen love. Junior's girlfriend Lulu also affectionately refers to Walter as Dad and speaks of being pregnant. Washington's universe unsurprisingly stretches to include his 1990's colleague Detective Audrey O'Connor—who also sees him as a kind of father figure—and her fiancé Lieutenant Dave Caro.

All is not clear sailing, though, as Audrey and Dave remind Pops that his violation of lease jeopardizes his good fortune paying \$1500 for rent. In a standout first act verbal volley, Walter adamantly pursues a lingering eight-year suit centered on being shot by a fellow white policeman who he claims uttered the N-word at the time. If Walter maintains that everything is about being black, Dave coldly warns Walter, "Don't be the old black man in the new white world." Audrey and Dave eventually offer Walter a deal that reflects the mayor's eagerness to close the case in an election season. Will Washington compromise? Will he somehow get the upper hand? Also, how does alluring Church Lady figure in Walter's fortunes? Guirgis makes his characters—especially Washington—so believable and human that theatergoers will find the resolution of Walter and his fellow characters' challenges fully absorbing.

Under Tiffany Nichole Greene's seam-

less direction, a first-rate SpeakEasy Stage cast captures the play's fascinating characters with all of their strengths and weaknesses. Tyrees Allen is a revelation in his company debut. His Walter has all of Pops' tenacity and integrity as well as his gusto for life. Guirgis has created a dynamo with the caliber of a stage icon, one Allen richly inhabits. Celeste Oliva proves scene-stealing good as the enigmatic yet charming Church Woman.

Octavia Chavez Richmond finds Lulu's own unique charm as well as her emotional conflict. Stewart Evan Smith catches Junior's irresponsible moments and his caring for both Lulu and Pops. Alejandro Simoes does full justice to the tricky role of Oswaldo—especially his pivotal first act outburst and volatility. Maureen Keiller nicely balances Audrey's affection for Walter and her attention to her work as a detective. Lewis Wheeler is properly tough and no-nonsense as Dave.

Guirgis tantalizingly speculates about a world where right would be enough. At a time where racism and inequality of opportunity persist, such a utopia seems a distant ideal. In its absence, a play as sharply insightful as "Between Riverside and Crazy" offers an inviting two-hour residence.

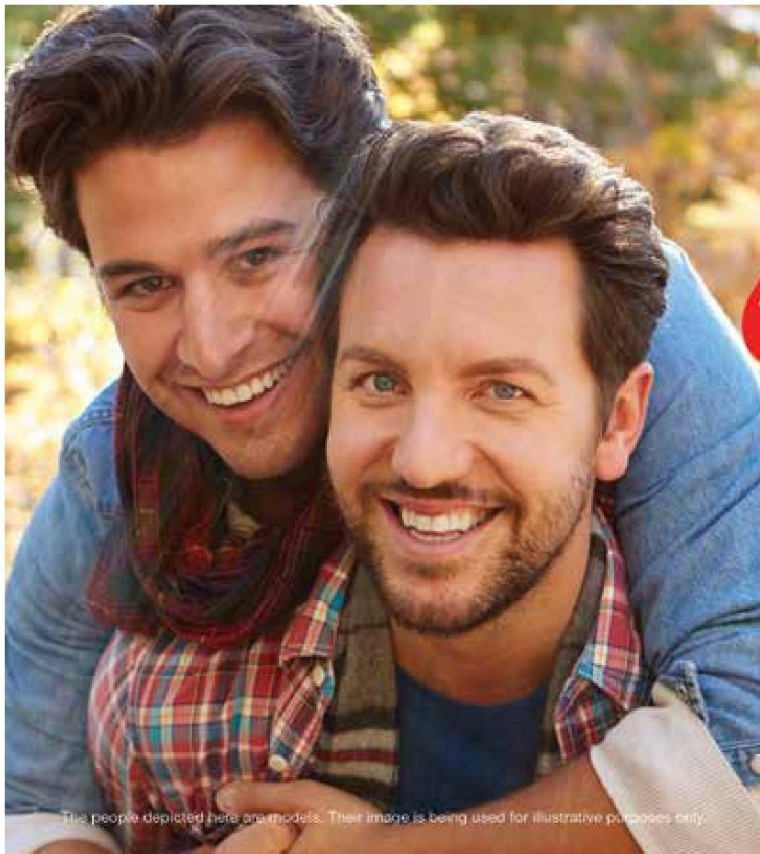

acrylics from her left glove, which she uses as a palette, onto the canvas with her fingertips.

The results range from serene to pulsing with life, as Savino depicts landscapes, street scenes, individuals and group scenes pulsing with movement and color. Saturday afternoon found her working a large, landscape-style South End scene and a portrait-style North End streetscape, surrounded by prints of her previous works laid out on park benches and canvases around the park; the fragrance and color of the park's lavender bush and flowers, and a quiet but steady flow of inquiring minds.

Accompanied by her friend and business partner, fellow South Ender Dan Mouhot, Savino fielded several inquiries and made one sale, which, according to Mouhot, was accompanied by the added value of a potential

exhibit opportunity.

Mouhot draws on his education in management and his corporate and entrepreneurial experience to help Savino navigate the art business. The two recently moved into a co-working building downtown, which offers both office space and artist residency, which includes exhibiting Savino's work in other locations owned by the company.

After a day of rest, Savino and Mouhot were off to their next al fresco painting adventure in New York City, where Savino painted in front of the New York Public Library on Monday and in Greenwich Village on Tuesday.

Mouhot explained, "We're trying to create a disruptive model for the traditional gallery existence, working with pop ups and things like that. We are business partners creating an artistic experience that is different from what you normally see."

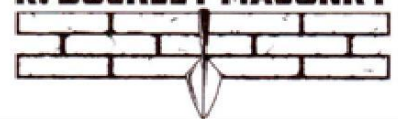
