

South End Native Kim Janey, Boston's 55th Mayor

First woman and the first Black mayor

On Monday, March 22, 2021, Boston City Councillor and City Council President Kim Janey became Boston's acting mayor, replacing outgoing Mayor Marty Walsh, who left to become Secretary of Labor in the Biden administration. She is the first woman and the first Black mayor in the Boston's history. As city councillor, Janey represented parts of the South End.

According to the City of Boston biography, Mayor Janey grew up in the South End, and is currently a fourth-generation Roxbury resident.

"Mayor Janey comes from a long line of educators, entrepreneurs, artists, and advocates. Mayor Janey was raised with values that guide

her to this day: the importance of education, the power of community organizing, and the fundamental principles of equity and justice.

Mayor Janey became a mother in high school and worked hard to give her daughter everything she needed to succeed. She began her advocacy on behalf of children inspired by the interconnection of her own daughter's experiences with those of other children. In her role at Massachusetts Advocates for Children, Mayor Janey championed systemic policy reforms to increase equity, excellence, access, and opportunity in Boston Public Schools. She placed a special focus on eliminating opportunity and achievement gaps for children of color, immigrant children, students who are learning English, children with special needs, and those living in poverty.

GOTVax vaccinates low-income, elderly, disabled BHA residents

State Representative Jon Santiago partnered with Dr. Alistair Martin, the South End Community Health Center, Mascon Medical, the Boston Housing Authority, Brewster Ambulance, and the Professional

Firefighters of Massachusetts to set up pop-up COVID-19 vaccination clinics aimed at administering vaccinations to the most vulnerable and difficult to access populations in the Commonwealth.

The effort, known as Get Out the Vaccine (GOTVax), applies traditional techniques of community organizing to bolster vaccine administration, including text banking, phone banking, and door to door canvassing. Volunteers from Harvard Medical School and student groups

such as We Got Us implemented a week long campaign to engage residents around the issue of vaccine access and hesitancy.

"Addressing the COVID crisis means bringing like-minded people together to take action and get it done," said State Representative Jon Santiago. "I'm so thankful for our partners in this effort and looking forward to improving vaccine equity by bringing shots to those

This is a public meeting to present proposed zoning changes that would make Accessory Parking a Conditional Use in neighborhood business subdistricts. Currently it is an Allowed Use in basements and first floors where there is an Allowed Use on the upper floors, such as residential. This condition creates a blank street wall with no active first floor use and runs counter to planning goals for neighborhood subdistricts. By making Accessory Parking Conditional, requiring a Conditional use permit, it provides an opportunity for community input and design review.

followed a path familiar to many Boston residents. After attending the New School for Children, her parents enrolled her in Boston Public Schools. In middle school she had rocks and racial slurs thrown at her during the tumultuous busing era. Later, Mayor Janey attended Reading Public Schools through the METCO program, where she was one of two Black students in her graduating class. Mayor Janey went on to attend Smith College as an Ada Comstock Scholar, but withdrew to care for her grandfather.

Prior to becoming Mayor in 2021, Janey made history in 2017 when she was elected to the Boston City Council as the first woman to represent District 7, which includes Roxbury and parts of the South End, Dorchester, and the Fenway. In 2020, she was elected by her peers as President of the Boston City Council.

Mayor Janey has been recognized for her service with a number of awards, including the Boston NAACP Difference Maker Award in 2015 and the coveted Sapphire Award in 2017. She was named one of Boston's Most Impactful Black Women in 2021. Mayor Janey is the proud mother of daughter Kimesha and a grandmother of three. She lives in Boston's Roxbury neighborhood."

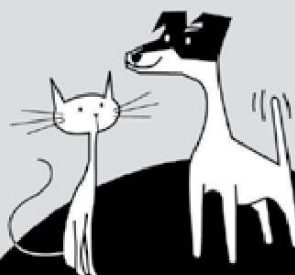

14-Year-Old Male in Custody on Firearm Related Charges Following Response to Shots Fired in Roxbury

At about 8:58 PM on Wednesday March 17, 2021, officers assigned to District B-2 (Roxbury) recovered a loaded firearm while arresting two individuals in the area of 58 Annunciation Road in Roxbury. The officers were canvassing the area following a call for shots fired on District D-4 (South End) in the area of Tremont Street and Lenox Street in Lower Roxbury. During the incident, a 14-year-old male from Roxbury was observed discharging a firearm before getting into the passenger seat of a black sedan which then fled the area. Officers on scene recovered ballistic evidence but reported no injuries or property damage.

The B-2 officers were aware of a vehicle which matched the given description and were also aware that the juvenile suspect was possibly wanted in connection to a similar incident which occurred on Friday March 12, 2021, during which ballistic evidence was discovered at the stairs of the entranceway of 58 Annunciation Road following a call for shots fired.

While on Parker Street, officers observed

the suspect vehicle and followed it onto Annunciation Road where they activated their lights and sirens to enable a traffic stop. As the vehicle slowed to a stop, the juvenile suspect exited and fled on foot into 58 Annunciation Road. The operator was detained while additional officers pursued the fleeing suspect. Officers were able to place the juvenile suspect in custody without incident while recovering a .32 caliber Smith & Wesson revolver which appeared to have been hastily placed on a window ledge.

The operator of the vehicle, later identified as a 19 year-old male of East Boston, was found to be wanted on several outstanding warrants sought out of Suffolk County Juvenile Court and West Roxbury District Court on multiple charges including Assault and Battery by Means of a Dangerous Weapon (Multiple Counts), Aggravated Assault and Battery, Breaking and Entering, Wanton Destruction of Property and Threats to Commit a Crime. The suspect was promptly placed in custody on scene without incident.

Both parties were then transported back to District B-2 for processing. During the booking process, officers recovered a plastic bag containing crack cocaine.

Officers then continued their investigation, executing a search warrant at the address, leading to the recovery of 101 rounds of .223

ammunition and a Shockwave Technologies Blade Pistol Stabilizer.

Man charged as Mass. Ave. drug dealer

Boston Police report officers on patrol in the general Methadone Mile area due to resident complaints about drug sales arrested a man police say the officers spotted selling some drugs, at Massachusetts Avenue and Washington Street around 1 p.m. on Thursday.

Police say the detained the suspect, who seized "a bag the suspect was holding which contained 18 small plastic bags of crack cocaine, 30 small plastic bags of fentanyl, 11 small plastic bags of powdered cocaine and one larger plastic bag of powdered cocaine with a combined total weight of 54 grams."

Officers also seized another bag that contained \$2,964 in cash.

The suspect was charged with trafficking Class A and B drugs and possession with intent to distribute Class A and B drugs, police say.

most vulnerable."

This is the second day of operations for the new program. Today, Santiago, Martin and partners brought vaccines to Torre Unidad complex in the South End, following on their successful administration of vaccines in a variety of BHA buildings, including Frederick Douglass Community, Washington Manor and Hampton House. Since its inception last week, Get Out The Vaccine has administered 297 vaccines.

"GOTVax has now brought vaccinations to nearly 300 people in Boston who are highly most at risk to COVID-19 and otherwise would have a nearly impossible time getting vaccinations through existing sites. This program is changing lives for vulnerable populations in our neighborhoods," Santiago continued.

Vaccines provided by the South End Community Health Center are administered by Last Mile Vaccine Delivery, a mobile vaccine service provider for underserved communities formed by Mascon Medical, Brewster Ambulance Service and the Professional Fire Fighters of Massachusetts.

"The GOTVax program represents the best of Boston," said Dr. Alister Martin, an

attending physician at Massachusetts General Hospital. "Partners like Rep. Santiago, volunteers from Harvard Medical School, South End Community Health Center, Mason Medical, the Boston Housing Authority, Brewster Ambulance and our frontline heroes at the Professional Fire Fighters of Massachusetts have combined their efforts, resources and expertise to make a difference in our collective fight against this virus. Seeing these shots go in the arms of people who need them most is so rewarding."

"We're honored to partner with Representative Jon Santiago and Dr. Alister Martin in their efforts to get the COVID-19 vaccine to Boston's most underserved communities and communities of color," said John Chen, President of Mascon Medical and co-founder of Last Mile Vaccine Delivery. "As a minority-owned business and first generation Asian American, we're sensitive to the challenges of people living in these diverse communities. We're problem solvers here to help municipalities and other non-profits in the Commonwealth accelerate their vaccine distribution in order to save lives. We look forward to operating more of these pop-up vaccination sites, as well as activating our mobile vaccination units."

"Our diverse, low-income elderly and dis-

abled residents are among the most vulnerable in the city - we needed to bring the vaccine to them to ensure vaccine equity," said Lydia Agro, Boston Housing Authority Chief of Staff and Public Affairs. "The Get out the Vaccine effort has been instrumental in vaccinating our residents where they live. We want to thank our GOTVax partners - Dr. Martin and the South End Community Health Center, Mascon, Representative Santiago - and our BHA staff and volunteers for helping us make this happen at multiple sites in the South End. Through this and other partnerships with Boston EMS, Boston Public Health Commission, and the Mass. Association of Independent Pharmacists, we're able to stand up clinics at 35 elderly/disabled sites in Boston."

"The Professional Fire Fighters of Massachusetts stand ready to respond, just as we have throughout the pandemic," said Rich MacKinnon Jr., President of the Professional Fire Fighters of Massachusetts.

Massachusetts. "We know the benefits of getting vaccinated and are eager to put our experience to work to help more residents get vaccinated."

Several more clinics are planned at other low-income, senior housing developments over the next few weeks as eligibility for residents is expanded.

HOMELESS SERVICES AND HOSPITAL CAPACITY

On April 2nd, Mayor Walsh announced that construction begins at the Boston Convention and Exhibition Center to add 500 beds for treating homeless adults who have tested positive for COVID-19 and need care, but do not require full hospitalization.

The City has released a Request for Proposals to secure a partner organization to operate the facility. If necessary, the Convention Center beds will be opened up for hospitals to use for sub-acute COVID patients in the general population.

These 500 beds will bring Boston's total number of new beds for homeless individuals to over 1,000. This includes Boston Medical Center's Newton Pavilion facility, which the City and State are working to re-purpose as a medical facility for homeless residents affected by the coronavirus.
