At the end of October 2020, a small group of Library Park aficionados, including FOSEL founder Marleen Nienhuis and dedicated volunteers Chris Fagg and Walter Newman, chased away the pandemic and election-season blues by taking planting tools and 3,000 bulbs to Library Park.

Buffeted by cold weather, rain, high winds and three inches of the season's first snow, they raked the leaves, removed the fallen branches, dug holes and planted until the last bulb was covered. As we head into spring, their work is paying off. The crocuses, daffodils, and tulips are in full bloom and the grape hyacinth are beginning to peek through.

minutes) and fully involving stage lesson takes the form of a vividly detailed presentation by student research assistant Sally. Complete with a flip chart and bell-signaled 'footnotes,' Sally's vivid lesson calls on her online 'class'—the theatergoers viewing Speak Easy Stage Company's forceful filmed production (in partnership with Boston Conservatory at Berklee, the source of the majority of the cast members)—to come to terms with their own ideas and assumptions about race, sexual harassment, freedom and equality.

Sally challenges her 'students' to examine not only Thomas Jefferson's enslavement—both physical and sexual—of Sally Heming but also the school dean's unrelenting efforts to establish an intimate and totally inappropriate relationship with her.

During her rich presentation, fellow black Beta Beta Epsilon sorority sisters Pam and Annette provide Greek chorus-like advice as well as personal reflections. Along the way, gay African-American activist Harold calls into question the slavery-connected history of the University and confronts the Jefferson-descended Dean about the latter's own feelings and views.

If you think this lesson is preachy or predictable, think again. Right from the start, Sally asks the audience "to consider what we've inherited from our ancestors" and announces that she needs "to tell it (her lesson) with my body." In fact, she enlists Pam and Annette from time to time in expressive full body cheers and dance moves that help bring her legacy and her sorority sisters' own inheritances to high energy life. Kudos to choreographer Kira Cowan Troilo for character-matching exuberance in the dance sequences.

Harold adds his own unique energy to the students' discon-

tent with the University's slavery connections—especially its 1819 foundation by a slave holder—and TJ's very forward stance towards Sally. Repelled by framed images of white college leaders, the feisty activist twice pisses on the wall they cover—later even adding graffiti with a paint can. Not surprisingly, Harold comes to words with TJ—who insists that they are not peers and that the Dean deserves more respect. Their conflict adds real fire to IJames' provocative play.

Eventually TJ's conflict with himself becomes as fiery as Sally's dogged opposition to his advances. IJames has the vulnerable dean actually strip down from a plantation era outfit to his briefs and wonder "Do I know what I'm doing?" Later still, TJ plaintively asks her "Why can't someone like me walk into the future with someone like you?" Jared Troilo gives a tour de force performance as initially cheery and ultimately perplexed and diffident TJ.

To his great credit, Troilo catches all of the dean's predatory qualities before finding his initially hidden sadness and insecurity. By contrast, Tah-Janay Shayone moves persuasively from defensiveness and uncertainty to strong resolve.

Rounding out strong performances—under the sharp direction of Pascale Florestal—are Jordan Pearson's brashly insightful Harold and Sadiyah Dyce Stephens and Dru Sky Berrian respectively as supportive Annette and Pam. Designer Rachel Padula-Shufelt captures period plantation era gowns. Aja M. Jackson's lighting evocatively catches the beauty of Sally's hopes for a future of true equality.

Playwright IJames aims to lead audience members to a full exploration of their lives and legacies. "TJ Loves Sally 4 Ever" is a fine effort in that regard—one that should have an even greater impact in an eventual in-person performance at the Calderwood Pavilion.

thousands of spring bulbs in Library Park began in the fall of 2018, when FOSEL learned that City funding for the Park's re-design would exclude plantings. Rather than leave the Park's garden with nothing to show for the makeover, FOSEL brought in the first round of plantings that fall and watched them bloom profusely

in the spring of 2019. During that 2019 summer, with the help of South End State Reps., Jon Santiago and Aaron Michlewitz, FOSEL secured \$25,000 for soil improvement, perennials, an irrigation system and new low-level interior fencing as well as exterior fence repair.

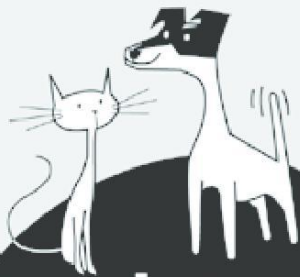

Crime

Murder suspect has long criminal history

When Boston Police Department detectives went to arrest Liquarry Jefferson for the fatal stabbing on Southampton Street of Jamaal Chin-Clark on Feb. 27, they knew right where to go—Jefferson was already being held on a probation violation related to his 2015 conviction for the armed robbery of a Roxbury market.

That conviction—which brought a seven-year sentence and which came after he pleaded guilty in the middle of his trial—came after his 2008 arrest for a pair of armed convenience store robberies.

And that was one year after his 8-year-old son, also named Liquarry Jefferson, was fatally, and accidentally, shot in his Grove Hall apartment by his cousin, who found a loaded gun in a dresser drawer, possibly left by Liquarry's half brother.

The brother pleaded guilty to involuntary slaughter, the mother was acquitted on the same charge when she came to trial.

Jefferson had nothing to do with that incident; in fact, he had been charged with beating the boy's mother in the face with a barbell and belt when she was two months' pregnant with him—a couple months after she allegedly stabbed Jefferson in the stomach and attacked his former girlfriend when she found the two in Jefferson's apartment.

Jefferson, who grew up in Dorchester but

whose last address was in Taunton, also has a manslaughter conviction for a 1997 incident in which he and another man broke into a Castlegate Road apartment and beat and stabbed the occupant to death.

The DA's office provide this account of Jefferson's alleged fatal stabbing of Jamaal Chin-Clark early on Feb. 27—which says the stabbing actually happened on Southampton Street, rather than at the intersection of Massachusetts Avenue and Melnea Cass Boulevard:

"Assistant District Attorney David McGowan told the court that surveillance camera footage captured the victim and a second individual walking on foot to a Southampton Street parking lot on the morning of February 27, 2021. Approximately 20 minutes later, a vehicle driven by an individual later identified as Mr. Jefferson arrived at the location. Mr. Jefferson, the victim and the second individual are seen on camera in what is believed to be a hand-to-hand drug transaction. During the interaction, Mr. Jefferson allegedly punched the victim in the face, knocked the second individual to the ground, and stabbed the victim in the chest and torso. Mr. Jefferson then returned to his vehicle and drove away.

Mr. Chin-Clark walked toward the intersection of Massachusetts Avenue and Melnea Cass Boulevard, where he collapsed in the street. He was transported to Boston Medical Center, where he died of his injuries."

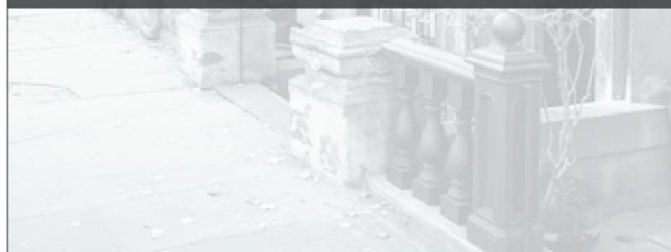
