Man Stabbed Friday Night Has Died, Police Say
Incident occurred near West Newton Street and Shawmut Avenue

Authorities report that Gerie Acevedo, 24, of the South End died. The incident, took place Friday

night, May 14, near West Newton Street and Shawmut Avenue and was reported to police at 8:38 p.m.

Police found Acevedo, who was rushed to an unidentified Boston hospital where he was later pronounced dead.

Acevedo's death was the 13th homicide in Boston this year compared to 15 murders at the same time last year, according to police.

City of Boston Reopening Plan

On Monday, May 17, Mayor Kim Janey announced that the City of Boston will align with the state's reopening plan. All remaining COVID-19 restrictions will be lifted effective May 29.

Following CDC guidance, the

state's face covering order will also be rescinded on May 29. Governor Baker will end the State of Emergency June 15.

Starting Monday, June 7, 2021, Boston City Hall will be open to the public by appointment only for a fourth day each week. In addition to Tuesday, Thursday, and Friday, residents will be able to make in-person

appointments on Monday as well.

The Boston Public Library will reopen for limited in-person services in June. The Library will prioritize bringing back critical services that help residents with economic and educational recovery. They will also be scheduling robust summer

BMC cancels plans for 10-story admin/ research building

Will add housing for homeless patients

Boston Medical Center (BMC) has filed a revised master plan for the next ten years that eliminates a controversial new building on Albany Street but adds the conversion of space in an existing administrative building to "supportive housing" for recovering homeless patients with

complex medical needs.

The hospital filed revisions to its proposed "institutional master plan" with the BPDA on Monday.

An earlier version of the plan, filed in 2019, had drawn opposition from Worcester Square residents over the proposed new administration and research building. A BPDA task force will discuss the new plan at a May 12 meeting.

In its new filing, BMC said it "listened to the feedback from the

serves up an ideal dish of family tradition and sibling warmth. Set in split screen kitchens—respectively in Ithaca, New York and Orlando, this sister-brother collaborative finds Mariana (Marie) and Henrique (Ricky) sharing not only their late Cuban-American mother's 'secret' recipe for the title legumes but also cherished family memories and concerning issues as adults.

"Black Beans Project" may be a disarmingly simple mixture (under an hour in length). Still both tax preparer Mariana and graphic designer Ricky are characters in flux. Mariana tells Ricky that she has been getting rid of her husband Carlos' things since their divorce. She is even offering up the piano their mother played and considering doing the same with her condo. At the same time, she has become a kind of COVID-19 era agoraphobic who depends on home deliveries. For his part, Ricky has been spending about a year with their Orlando-based Puerto Rican-American father—who keeps their mother's ashes "hostage" in a closet box rather than the striking urn his son had purchased. A 'serial monogamist,' her gay New York City-centered brother lacks privacy at his father's place for a relationship with a new boyfriend and resorts to frequent masturbation during a "celibate" year.

Clearly the recipe project provides a welcome escape from their respective limbo-like lives and a potential culinary GPS for more fulfilling family connection—even as COVID-19 and political factors involving Goya's CEO are mentioned. Smartly, Lopez and Perez have divided their play into parts fittingly labeled "Prep," "Simmer" and "Taste." During the prep, Marie vividly remembers sorting beans the morning before Christmas Eve as her talented mother played piano. By

contrast, Ricky reminisces about 'spellbound' campsite beans. Both fondly recall stargazing experiences, and Ricky mentions their mother's belief that owls were a good omen. Lopez and Perez are so adept at blending the recipe's ingredients and the characters' reflections that many theater viewers are likely to try their own hands at the play's vegetable and spice-rich mixture and call up their own memories.

Could the simultaneous preparation, simmering and tasting of their respective bean dishes become a good omen? Might Mariana and Ricky take a timely lesson about living from their father's hatred of Quincy and their mother's dissatisfaction with Florida heat? Does Ricky have a point when he contends that Mariana's willingness to sell the family piano means "You're getting rid of her"? On the other hand, should their father join them and their mother's ashes on a journey to the White Mountains she loved, as she advises? Lopez and Perez incorporate the answers to these questions in a satisfying resolution.

Under Jaime Castaneda's sharp direction, "Black Beans Project" has all the warmth and authenticity of a real sibling zoom. Lopez and Perez are always convincingly affectionate if direct as Mariana and Ricky. Lopez has all of the sister's ease in the kitchen and her deep caring for her brother. She brings stunning force to Mariana's warning that Ricky is running away from grief. Lopez captures Ricky's charm and unassuming manner. He delivers the brother's counsel about Mariana hiding with singular intensity. Making the sibling dynamics and memories all the more expressive are Hana S. Kim's painterly video design and Taylor Ness' radiant zoom and lighting.

"Black Beans Project" is a richly flavored Huntington Theatre Company presentation. Do not miss its savory combination of ethnic cuisine, family tradition and human caring.

"We are excited to be bringing the 23rd annual festival both in person and via online streaming," says Lisa Simmons, Director of the Roxbury International Film Festival. "Our partnership with the MFA gives us this flexibility and provides a way for audiences to come together indoors and outdoors in a safe way. This year we are excited to screen over 65 films that tell stories about reclaiming spaces, countering narratives, taking care of ourselves, and celebrating unapologetically."

Over the course of ten days, RoxFilm will showcase feature-length narrative films, documentaries, shorts and animated films that are truly independent. The festival has featured and celebrated both films and filmmakers of color for the past two decades screening over 1,500 films to over 35,000 attendees. RoxFilm will include online events such as panel discussions, one-on-one conversations, networking opportunities, filmmaker hangouts and Q&A sessions with filmmakers and special guests. Keeping to their mission, the festival will screen a number of local films and highlight films from Boston Public School students, Lynn's Raw Arts Program and other student-made films from around the country.

Directed by Yoruba Richen, *How It Feels*

To Be Free takes an unprecedented look at the intersection of African-American women artists, politics, and entertainment and tells the story of how six trailblazing performers, Lena Horne, Abbey Lincoln, Diahann Carroll, Nina Simone, Cicely Tyson and Pam Grier changed American culture through their films, fashion, their music and their politics.

Memoirs of a Black Girl is a coming-of-age film where an astute and ambitious student named Aisha Johnson is one of the finalists for the coveted Conrad Scholarship. Aisha's goal is to earn the top prize. But one day when Aisha tries to do the right thing, her life is turned upside down, which puts her future in jeopardy. Aisha must learn to navigate life at home, in school, and on the unforgiving streets of Roxbury.

Directed by Thato Rantao Mwosa.

Thato Mwosa is an illustrator, screenwriter, playwright, and filmmaker. She has won several awards for her narrative films and documentaries. Her films have been broadcast nationally and internationally.

This year, RoxFilm takes place June 17 – 26, 2021 at the Museum of Fine Arts Boston with some events hosted virtually.

Fab 5 Freddy will join RoxFilm to discuss his film *Fresh Guide To Florence* with Fab 5 Freddy. The film is a revelatory and iconoclastic look at 15th and 16th century Italian Renaissance art through the eyes of hip hop legend and art lover Fab 5 Freddy. Amidst rockstar artists such as Michelangelo and powerful patrons such as the Medici's Fab discovers groundbreaking images of a multi-racial and multi-ethnic society in artworks which have fallen through the cracks of art history and been neglected by art historians.

Shared Stories@RoxFilm Programming: A Reckoning in Boston – Directed by James Rutenbeck

Kafi Dixon dreams of starting a land cooperative for women of color who have experienced trauma and disenfranchisement in the city of Boston. By day she drives a city bus; at night she studies the humanities in a tuition-free course. Her classmate Carl Chandler, a community elder, is the class's intellectual leader.

Executive Order - Directed by Lázaro Ramos

Set in Rio de Janeiro in a near and hypothetical future, *Executive Order* is a feature fictional film whose plot starts with the enforcement of a law that determines the compulsory return of all afro-descendants to their "countries of origin".

8 Wheels - Directed by Drew Powell, Ryan Everett, Adrian and Gibbons

Chez Vous is the only Black-Owned roller skating rink in New England. As roller skating rinks close down throughout the US due to COVID-19, this film takes a deep dive into what makes *Chez Vous* special.

The Daily Read program will return to RoxFilm, where scripts by RoxFilm alumni will be read by professional local actors. The Daily Read takes place LIVE during lunchtime from 12:00-1:00pm. Audiences have the opportunity to hear works in progress.

Panel Discussions will take place around the history of black film – The panel discussions program will look into film noir, the role white supremacy has played in film, and a conversation with black chefs. There will also be discussions surrounding black storytelling, BIPOC media companies, animation, and much more.

The Roxbury International Film Festival is a competitive festival that awards certificates in the categories of Audience Favorite, Narrative Film, Documentary Film, Narrative Short, Documentary Short, Youth, Emerging Filmmaker, with a special award named after award-winning filmmaker Henry Hampton.

The book is a provocative and intimate collection of personal and

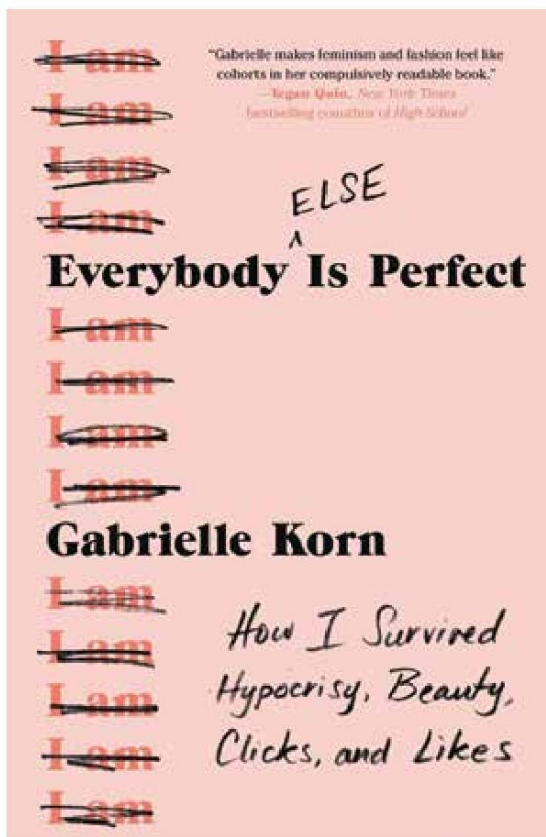

Task Force and neighbors and will not pursue a new building" at the site, next to the Newton Pavilion, originally slated for the administration building. The computational research space originally slated for the building will instead be built in a new building nearby, at 10 Stoughton St., while the hospital will begin to plan a new administration building at the hospital's current power plant, across Albany Street from the main part of the medical center.

The hospital's plans also call for building out space in the Collamore/Old Evans building at the corner of East Newton Street and Harrison Avenue to house up to 30 homeless patients with complex medical, substance-abuse and psychiatric needs, and that:

"COVID-19 pandemic has shown the full depth of disparities on BMC's patient population. It has made housing instability and homelessness worse; housing interventions are necessary to correct this."

BMC says a pilot program showed that providing them with housing coupled with "complex coordinated care management" dramatically reduces their need for hospital care and results in better health outcomes for them.

The hospital's plan also includes a phased increase in the number of overall beds, including an increase in the number of single-patient rooms, but this will be done by reusing existing space rather than through new construction. The hospital says that even before Covid-19 hit, the occupancy rate for its 514 beds was at 90%. BMC says that in 2010, it had 626 in-patient beds, a number it reduced in part because of what turned out to be a temporary decline in demand and in part to increase the number of single-patient rooms.

"The first is to accommodate approximately 69 single bed rooms with the addition of Yawkey 6th floor within two-years; this will allow the decoupling of existing 52 adult medical/surgical double bed rooms with a minor net new increase of 17 beds. The second is to construct the vertical addition to Menino 9th floor to achieve approximately an additional 48 single bed rooms within five-years. If the inpatient volume continues to grow, the long-term plan will include the approved New Inpatient Building Phase 2. This approved building may also be constructed in phases to accommodate approximately an additional 280 to 330 single bed rooms towards the end of ten-years and beyond. BMC will retain existing double bed rooms to handle surge capacity in response to pandemics like COVID-19."

HOMELESS SERVICES AND HOSPITAL CAPACITY

On April 2nd, Mayor Walsh announced that construction begins at the Boston Convention and Exhibition Center to add 500 beds for treating homeless adults who have tested positive for COVID-19 and need care, but do not require full hospitalization.

The City has released a Request for Proposals to secure a partner organization to operate the facility. If necessary, the Convention Center beds will be opened up for hospitals to use for sub-acute COVID patients in the general population.

These 500 beds will bring Boston's total number of new beds for homeless individuals to over 1,000. This includes Boston Medical Center's Newton Pavilion facility, which the City and State are working to re-purpose as a medical facility for homeless residents affected by the coronavirus.

Unit responded to a call for a person stabbed in the area of 112 Southampton Street in Boston after an officer performing a paid detail at the shelter located an adult male victim on Atkinson Street.

The victim was transported to a local area hospital for treatment of injuries which were considered to be non-life-threatening in nature. Although officers observed several people loitering about the area of the scene, they did not assist the officers with a description of the suspect or any account of what had just occurred.

District detectives were eventually able to provide officers with a description of the suspect who was last seen operating a motorized scooter. Investigators later learned that the suspect had stabbed the victim before stealing an undisclosed amount of cash before fleeing the area.

At about 8:20 PM, C-6 officers who were committed to directed patrol around the shelter, observed the suspect as she returned to the area and were able to place her in custody without incident. The suspect will appear in Roxbury District Court on charges of Assault and Battery by Means of a Dangerous Weapon and Armed Robbery.

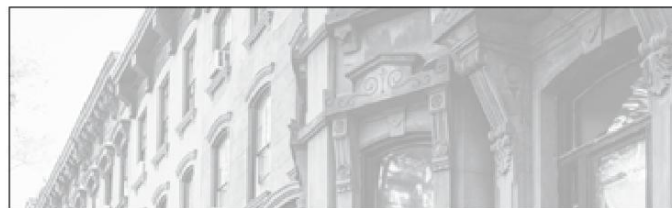
