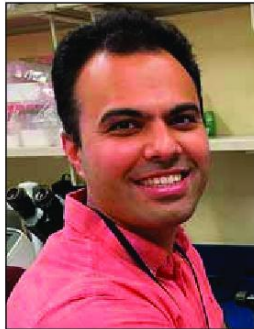

South End Residents Awarded Funding

South End resident Mohsan Saeed, PhD, assistant professor of biochemistry at Boston University School of Medicine (BUSM), has received a five-year, \$2 million R35 grant from the National Institute of General Medical Sciences, as well as a five-year, \$2.5 million R01 grant from the National Institute of Allergy and Infectious Diseases. It is extremely rare for an early-stage investigator to win these highly competitive awards during the same funding cycle.

Human cells respond to foreign agents such as pathogens and toxins by initiating a strong innate defense response that creates a protective environment in the cells and incapacitates the invading pathogens and foreign substances. The initiation, activation and resolution of this innate defense response is a carefully regulated process designed to avoid both hyperactivation and underactivation of the immune system, either of which can lead to tissue damage, organ dysfunction

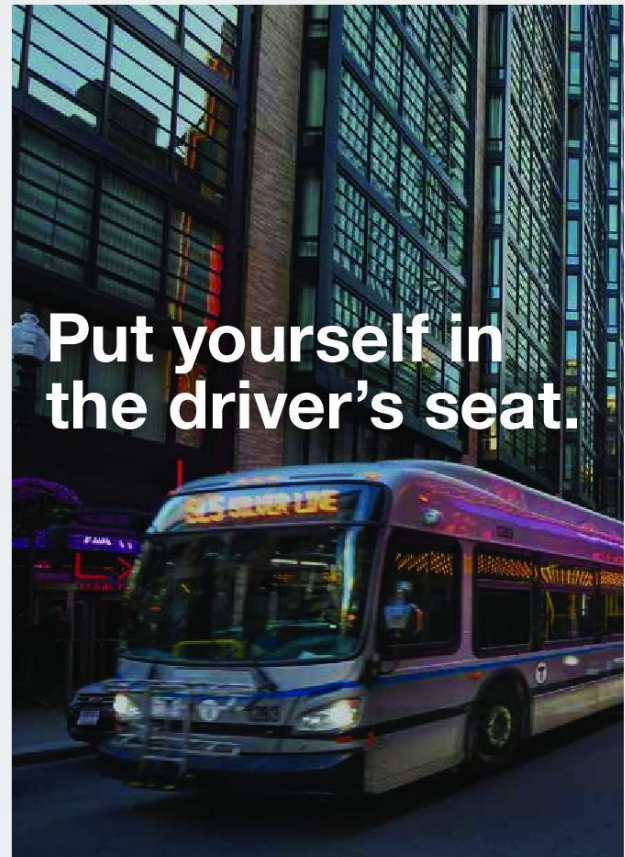

- lumbus Ave.); St. James Street (west of Berkeley Street to Dartmouth Street). These bus lanes support the 39, 9, and 10 bus routes, which together serve more than 10,000 riders per weekday.
- South End loading zones and drop-off zones: Changes to parking restrictions in this area will remain in place for improved curbside management and reduced double parking in the unprotected bike lane.
- Jamaica Plain pavement marking and signage: This includes traffic safety elements such as "Don't Block the Box" and parking restrictions at corners to improve visibility. These changes have shown to improve traffic safety and management.
- Boylston Street one-way for vehicles: Closing part of Boylston Street (between Amory & Lamartine) to traffic throughout the shutdown has improved safety (collisions and near-misses) along the Southwest Corridor. Reopening this stretch as a one-way street from Amory to Lamartine for vehicles will support long-term bike connectivity plans, improve safety for all modes, and reduce conflict at the high crash intersection of Boylston and Lamartine Streets.
- Huntington Avenue bus & bike priority lane: The priority bus and bike lane that was added to Huntington Avenue from Brigham Circle to Gainsborough Street has improved speed for the Route 39 bus. As a permanent lane, it will continue to support the thousands of people who ride the Route 39 bus and will improve safety for those on bikes.
- Columbus Avenue pop-up bike lane: This will remain until early December and then be removed for the season. BTD Active Transportation will continue to monitor and move barrels daily to enable street sweeping. Long-term planning is underway for a potential permanent facility. This is one of the busiest corridors for biking. Improving conditions, even on just a few blocks, can make the overall trip safer and more enjoyable.
- Bluebikes parking: The City will retain Bluebikes docks added during the shutdown, with minor modifications as needed, to keep up with record-breaking ridership numbers. The City is also exploring options to provide free or low-cost bike share service.
- The Boylston Street pop-up bike lane will be removed as the City works to design the recently announced permanent facility. Boylston Street is an important link in the bike network, and improved infrastructure here will make a safer ride for people biking from Brookline, Mission Hill, the LMA, and Back Bay to Downtown. The pop-up Boylston Street bike lane will be in place through September 26. The permanent Boylston Street bike lane will be prioritized for installation in the spring.

and microbial diseases.

With his R35 award, Saeed and his colleagues hope to generate new knowledge about the role of proteases (enzyme which breaks down proteins and peptides) in the regulation of cellular defenses and inform the development of strategies to improve the performance of innate defense mechanisms against escalating microbial and environmental threats.

Enteroviruses are human pathogens that replicate in multiple organs and cause a variety of diseases, including gastroenteritis, pneumonia, myocarditis and encephalitis. Currently, little is known about how enteroviruses alter the biology of infected cells. Using his R01 grant, Saeed plans to clarify the role of enteroviral proteases in changing the host cell environment during infection.

Saeed received his MPhil in microbiology from Quaid-e-Azam University, Pakistan, where he studied the molecular epidemiology of polio-like viruses in patients suffering from paralysis. He then joined the University of Tokyo, receiving his PhD in pathology, immunology and microbiology. During his doctoral studies, he developed novel cell culture systems for the study of hepatitis C virus (HCV) and investigated various aspects of this virus in diverse in vitro and in vivo settings.

He then entered the laboratory of Nobel Laureate Dr. Charles M. Rice at the Rockefeller University, New York, for his postdoctoral training. Although his research in the Rice Lab mainly focused on HCV, he also gained expertise with a number of other positive-strand RNA

viruses, including enteroviruses, flaviviruses and alphaviruses. In addition, Saeed developed a novel "viral degradomics" technique that allows an unbiased identification of cellular proteins cleaved during viral infections.

Saeed joined BUSM in 2019; his group explores the role of viral and host proteases in disease mechanisms of positive-strand RNA viruses at the National Emerging Infectious Diseases Laboratories (NEIDL). In early 2021 when COVID-19 was declared a global pandemic, his lab pivoted to SARS-CoV-2 research and has since made contributions to the molecular understanding of how SARS-CoV-2 establishes infection in various tissues and interacts with the human innate and adaptive immune systems.

South End resident Deborah Jean Anderson, PhD, professor of medicine at Boston University School of Medicine (BUSM), has received a four-year, \$7.2 million grant from the NIH's National Institute of Child Health and Human Development renewing support for a Contraceptive Research Center (CRC) at BUSM to further her research to develop innovative monoclonal antibody (mAb)-based contraceptive and multipurpose prevention technology (MPT) products.

"This research has the potential to improve the lives of millions of women globally by addressing two concurrent reproductive health crises: an unacceptably high rate of unintended pregnancies in both developing and developed countries and an epidemic of sexually transmissible infections," explains Anderson.

With prior funding from the National Institute of Allergy and Infectious Diseases,

Anderson and her team developed a vaginal film containing mAbs against HIV-1 and HSV-2 (herpes simplex virus type 2) that proved safe and effective in a Phase 1 clinical trial, and recently, with funding from her first CRC grant, Anderson developed an antisperm antibody for contraception. With this new award, Anderson plans to advance these products through advanced clinical trials.

For the past 40 years, Anderson has directed a research laboratory that studies reproductive health, mucosal immunology and HIV sexual transmission. Her laboratory was among the first to study immunological causes of infertility, and to identify risk factors for HIV transmission.

her effort at the Calderwood Pavilion needs strengthening as does the 1980's appropriate Gary Clark and Carney score which ought to have more memorable numbers.

As with "Once," Broadway-bound (2019 Off-Broadway) "Sing Street" is set in Dublin—this time a poor 1982 area with work-challenged and financially struggling families. A clever center stage miniature house—kudos to scenic designer Bob Crowley, who also co-designs the vivid 80's costumes and get-ups with Lisa Zinni—opens up to make way for the home of the focal Lawlor Family. The Lawlors—father Robert, mother Penny and siblings Brendan, Conor and Anna—are beset by marital strife and diverse growing pains.

Working mother Penny is having an affair with her boss, and jobless Robert is emotionally conflicted. Older brother Brendan has virtually dropped out of life outside his home as well as college, spending many months on the living room couch. Anna is approaching graduation but angry about her mother's infidelity and her father's apparent weakness in reacting to it.

Because the family is financially strapped, Conor has had to switch from private school to a parochial one named Synge Street and run by Brother Baxter. Abusive despot Baxter makes him remove his non-black shoes which he considers a violation of his arbitrary regulations.

Central to the evolving family dynamics is Conor's desire to form a band with fellow students and find both haven from home problems and artistic fulfillment in rock music with an affinity to the decade's celebrated Duran Duran and The Core. Very soon he establishes a songwriting partnership with keyboardist Eamon. While finding a lead singer, he falls for elusive enlistee Raphina.

If the formation of the band may seem too easy—with the student singer/musicians quickly coming together, the same can be said for Conor's enrapture with his older would-be

girlfriend (who warns him that she is involved with a much older London-bound man named Dave). At the same time Conor and his fellow musicians see the band's name Sing Street—of course a change from the school's name—as a signal for cultural revolution.

Unsurprisingly, Father Baxter tries to reign in the students and stifle what he considers their controversial and unacceptable extracurricular activities. The students' retaliation may seem like unsatisfying plotting—especially if

compared with the parents-impressing student performance near the end of the musical "School of Rock."

Bully Barry Bray initially puts down the band's Duran Duran-like rock but eventually changes his tune in a turnaround that many theatergoers are likely to find too neat.

Plot and score issues notwithstanding, the production team is first-rate and the cast—directed forcefully by Rebecca Taichman (a very deserving Tony Award winner for the play "Inecent")—winningly exuberant. As with "Once," the students play their own instruments—and with fine technique. Choreographer Sonya Tayeh (an equally deserving Tony winner for "Moulin Rouge") has the students high-stepping during their numbers and the Lawlors moving strikingly during tense family moments—particularly Brendan almost acrobatically on the couch. Luke Halls and Brad Peterson add imaginative video design

to the band's 80's ambience.

Most of all, the cast keep the characters' inner music engaging. Adam Bregman has all of Conor's naivete and spirit—notably on the romantic "To Find You." Donal Finn is a standout as complicated Brendan; he demonstrates appealingly the older brother's closeness with Conor and he persuasively moves from the shoeless couch sitter (a smart symbol) to closing shoe-donning optimist.

Courtnee Carter combines sweetness and street savvy as Raphina. Alexa Xioufaridou Moser makes the most of the as yet underwritten Anne. Ben Wang catches Eamon's reserve as well as his commitment to songwriting. Anne L. Nathan finds all of his mother Sandra's wonderful support for his music and the band.

Sandra advises that "Collaboration is your best friend." That wisdom has proven very true for "Once." If the team working on "Sing Street" can fine tune their collaboration, audiences at the Calderwood Pavilion and on Broadway will embrace an enjoyable tryout turned true musical winner.

the 45-minute performance for all ages features choreography set to powerful stories of perseverance from Boston's youth. The dancers will play with power structures rooted in social interaction to create an immersive story of empowerment and peer intervention. Performed by the Professional Company and Boston Arts Academy students, the event is a collaboration between Boston Arts Academy Dance Program Students and Brighter Boston Students, who participate in all aspects of the production, both onstage and behind the scenes. five minutes from 6:00 to 7:30pm. Audience members (up to 6 per group) can participate together, creating a special memory with a uniquely-designed experience for the entire group.
