Women were not allowed to act on stage in the Elizabeth Age—in fact not until 1660 in England. As many theater buffs know, male actors dressed up as women and played female roles. During the last century the proverbial tables have turned as great actresses tackle some of Shakespeare's greatest male

Rita Hester's life mattered

In the pantheon of slain Americans who have furthered civil rights gains of a marginalized group, Rita Hester, an African American transgender woman, is among them. There had been several transgender murders prior to Rita's—Chanelle Pickett in Watertown in 1995 and Monique

Thomas in Dorchester in September 1998. Rita lived large and loved big, but she could have never imagined her life as her death would mean so much to so many.

On November 28, 1998, Rita was found dead in her first-floor apartment with 20 stab wounds to her chest, just two days before her 35th birthday. Hester's murder kicked off the "Remembering Our Dead" web

project that became the catalyst for the annual International Transgender Day of Remembrance on November 20. Her murder occurred six weeks after Matthew Shepard's in Laramie, Wyoming, which became an internationally known homophobic hate crime that in 2009 President Barack Obama signed into law. The Matthew Shepard

Martin's Park Ship Lighting November 26

A special children's celebration will be held on Saturday, November 26, at 4 p.m. at the Smith Family Waterfront in the Seaport District and Fort Point neighborhood when the Friends of Martin's Park and the Boston Parks and Recreation Department host the second annual holiday lighting of the ship in Martin's Park.

Located at 64 Sleeper Street on the South Boston Waterfront and visible from the Northern Avenue Bridge, Martin's Park at the Smith Family Waterfront is a climate-resilient park built in memory of eight-year-old Martin W. Richard, the youngest victim of the 2013 Boston Marathon bombing. The accessible park provides play opportunities for children, families, and visitors of all abilities. The wooden play ship is the centerpiece of the space that will be lit for the holidays.

Martin's Park will be transformed into a beautiful holiday display when the ship, surrounding beach fencing, and pedestrian

bridge are illuminated with over 1,500 feet of blue and white tube lights.

WS Development is a key sponsor supporting this year's event as well as the holiday lights on Martin's Ship. Visitors are encouraged to head inside the park for the celebration sponsored by the Friends of Martin's Park and the Boston Parks and Recreation Department.

Santa will arrive by boat with the Boston Police Harbor Unit at the Harborwalk and enter the Park to switch on the lights. Entertainment will be provided by acappella group Ball In The House performing a selection of holiday classics, along with special guest, the Seaport's own Betty the Yeti. Hot cocoa will be provided by Tuscan Kitchen, Caffe Nero and Dunkin', and with donation, attendees will have the opportunity to take home a customized special souvenir of the second annual event while supplies last.

In addition to this event, the City of Boston will be hosting other tree lightings. roles—among them Dame Judith Anderson as Hamlet and Olympia Dukakis as King Lear (the latter in a strong performance seen by this critic).

Recently, accomplished dramatist George Brant (“Grounded”) has focused on such a gender-bending scenario in his wise and affecting play “Into the Breeches!” (2018).

Now the always-exploring Hub Theatre Company of Boston has smartly added a veteran female director—namely Bryn Boice—who has already staged a sublime all-female cast “Julius Caesar.” Thanks to Boice and a strong ensemble, the Hub Theatre area premiere at the Boston Center for the Arts proves both a celebration of the power of women and the gender-bending friendliness of Shakespeare’s plays.

The plays in question here are the history plays known as “The Henriad”—namely Henry IV, Parts I and II, and Henry V. Set here in the Hub (and in other respective cities where the play is produced) at a fictional renowned theater called The Oberon Playhouse, “Into the Breeches!” centers on the attempt of artistic director Andrew’s wife Maggie to stage the four-hour production in the absence of her husband and male actors, all serving in America’s armed forces in World War II.

As Maggie assembles a cast of largely novice actresses and confronts a variety of company board reservations, Brant’s clever dramedy works on two levels—the ups and downs of the developing staging and the personal concerns of the actresses and Maggie herself in a play-within-a-play. The inner play also includes issues involving emotionally conflicted stage manager Stuart and African-American costume designer Ida.

How Maggie—between the proverbial rock and a hard place—decides to respond to board positions about gays and blacks performing on stage will serve as a moment of truth for her about personal courage in a kind of home front war.

By its nature, such a play involving a community of characters requires a cast that can both define the characters’ diverse per-

sonalities and become a tightly knit ensemble. Under director Boice’s careful guidance, Hub Theatre’s players turn in the kind of lively, amusing and loving performance that Shakespeare would likely embrace. Lauren Elias as intrepid Maggie moves convincingly from initial uncertainty about the production and her mostly untested actors to admiration for their talents.

Throughout, Elias captures the novice director’s empathy with fellow women worrying about their fighting men. Kathleen Pickett is a standout as feisty Oberon Playhouse veteran Celeste. She displays sharp timing and proper attitude as Celeste repeatedly questions rehearsal choices and equal warmth as she grows to appreciate her fellow cast members.

The supporting players are uniformly strong. Jessica Golden catches Grace’s inner strengths and considerable talent—especially as she convinces even demanding Celeste of her readiness. Lily Ayotte has the right as ingénue June. June Kfoury is properly amusing and appealing finding a place in the cast as board member’s wife Winnifred, while gifted Steve Auger makes his very good most of her initially skeptical but ultimately approving husband Ellsworth.

Robert Orzalli smartly balances Stuart’s sharpness as stage manager and vulnerability as the only male in the production. Nette Chickering has all of Ida’s costuming savvy and majesty as a “Henriad” performer. Katherine

Lawrence’s costumes for the play and inner play are equally vivid.

In “Henry V,” King Henry rousing invokes the spirit of his countrymen. The same can be said for Hub Theatre Company’s winningly attired “Into the Breeches!”

and James Byrd Hate Crimes Prevention Act.

In 2022, Rita’s murder is still an unsolved cold case like most transgender murders. Her murder occurred in an era when the “trans panic defense”—a defendant melodramatically pleads temporary insanity for killing—was a legal strategy. Friends of Rita told NBC.com their suspicion about her murder. “A man (or woman) who couldn’t face his attraction to a trans woman came home with Hester and killed her in a fit of shame.”

I’ll never forget Rita’s vigil because the words of Rita’s mother, Kathleen Hester, haunt me to this day. When Rita’s mother came up to the microphone during the Speak Out portion of the vigil at the Model Cafe, where Rita was known, she brought most of us to tears, myself included. “I would have gladly died for you, Rita. I would have taken the stabs and told you

to run. I loved you!” After her remarks, Rita’s mother collapsed in a grief-induced faint. When the Speak-out portion ended, the crowd moved outside with lit candles and gathered behind Rita’s family. As the vigil processed from the Model Cafe to 21 Park Vale Avenue, where Rita lived and died, Rita’s mother again brought me to tears as she and her surviving children knelt in front of the doorway of Rita’s apartment building and recited “The Lord’s Prayer.” Many of us joined in unison.

According to the Human Rights Campaign, this year, at least 32 transgender Black and LatinX sisters have been fatally shot or killed.

At this year’s Association of Black Harvard Women Annual Vigil for Black Trans Lives, photos and the reading of names of departed Black Trans individuals were part of the liturgy in Holden Chapel on Harvard’s campus. Chastity Boswick, executive director of the Transgender Emergency Fund of Massachusetts, was the keynote speaker. Boswick told the audience “she

hopes next year she’ll not be among the photos and names.” It’s an ongoing concern Boswick expresses publicly every chance she can. “What happened to Hester could happen to any of us. That’s her daily battle,” she told WBUR in 2020.

And that concern I heard during the “Trans Catholic Voices” breakout session at the DignityUSA conference in Boston in 2017. I listened to the vulnerability of an African American transwoman who pointed out that Pope Francis’s statements about trans people deny them basic human dignity and perpetuate violence against them. In her closing remarks, the African American trans-sister asked for help from advocates and allies in the room, bringing me to tears. She said, “Trans lives are real lives. Trans deaths are real deaths. God works through other people. Maybe you can be those other people.”

As we celebrate Trans Day of Remembrance, we are those other people honoring Rita Hester and others.
