

World AIDS Day 2022 message acknowledges inequalities

Dec. 1 is World AIDS Day! With the COVID pandemic foremost on the minds of many, HIV/AIDS seems like a distant problem. A POZ Poll asked its readers, "Are you participating in any World AIDS Day 2022 events?" On 11/28, when I responded to the poll questions, 20% said "yes," 20% said "I don't know,"

and 60% said "no."

In 1988, the World Health Organization designated the day to pause and reflect on the magnitude of the devastating effect this disease continues to have on domestic and global communities. Much of the focus still is on developing countries. However, African Americans are still disproportionately affected by the HIV epidemic. And the epidemic is heavily concentrated in urban

enclaves like Boston, Detroit, New York, Newark, Washington, D.C., and the Deep South.

In February, on National Black HIV/AIDS Awareness Day 2022, "Poz" reported that according to AIDSvu.org, African Americans in 2019 made up 43 percent of new HIV cases and comprised roughly 12-13 percent of the U.S. population. This

Lorin Douglas—also known as Calvin—recently passed away. He was 83.

Growing up on Camden Street, he often played at Carter Playground and was well-known at Charlie's Sandwich Shoppe in the South End as the "Turkey

Hash Kid."

Although he dropped out of school early on, he learned to read from a friend who liked books and showed him the importance of reading. He became an avid reader. For example, he went out of his way to find me after he liked an article I wrote. We began sharing stories of "When the South End was the

South End," as he liked to say. I was impressed with his amazing memory and accuracy. Sometimes I'd check something he told me and always found he was right.

He was an early practitioner of martial arts. Although not a member of the Nation of Islam, he was be-

friendied by Ella Collins and spent time with Malcolm X's nephew Rodnell. In 1964 he and Rodnell painted 72 Dale Street in Roxbury. And he taught Arabic at the Sarah A. Little School in Chester Square.

In 1955, he worked in maintenance at the

Huntington YMCA and then for 16 years at Harvard libraries. "There was almost no place you couldn't get a job back then," he said.

He lived at quite a few South End addresses: Worcester, Tremont, and West Springfield Streets, and then for 15 years at 507 Mass. Ave. before arthritis in his left hip forced him into a "power chair" and a move to the Frederick Douglass House on Tremont Street where he recently died.

Racism has taken many faces and forms in America. The repeated exploitation of Native Americans tribes and the 1619-starting enslavement of African-Americans are well-documented and studied in many schools. The beginnings of racist treatment of Chinese-Americans may be much less well-known. A recent Lloyd Suh play entitled "The Chinese Lady" (2018)—focused on the first known Chinese native to arrive in America—should rightly bring greater attention to anti-Chinese racism. Central Square Theater and CHUANG Stage—the first Mandarin-English bilingual bicultural theater company nationwide—have partnered to produce this striking and beautifully staged fact-inspired look at a 19th century Chinese teenager placed at the center of a profitable stereotype-rich touring exhibition.

The teenager in question is 14 year old Guangzhou (formerly Canton City) native Afong Moy, bought from her father and brought to New York City in 1834 by brother merchants Nathaniel and Frederic Caine in order to call business attention to their Chinese goods. Creating a kind of very large museum display room with Afong Moy dressed in an ornate silk outfit—kudos to costume designer Sandra Zhihan Jia—on a kind of throne chair and assistant Atung also serving as translator, the Caines had her proceed to make Chinese tea, eat with chopsticks, explain her country's social practices and walk around with bound feet. For this unusual exhibition they initially charged adults 25 cents and children 10 cents (with admission repeatedly rising over the course of two decades).

"The Chinese Lady" artfully begins with Atung stage left opening a ceiling-high stage-wide curtain to reveal that exhibition—elegant yet smartly spare with furniture (that the Caines hope will lead to customers for their own merchandise) and a flower-filled vase in Qingan Zhang's design—in which Afong sits as a kind of faux cultural centerpiece waiting to fulfill the Caines' demands. In a room unlike any in China at that time, Moy declares "My entire life is a

performance." As she speaks, the Central Square Theater audience—and any audience for that matter—effectively become the attendees at the exhibition. Mention is made of a 40 week tour to 15 cities including Boston and such cities as Baltimore, Philadelphia and San Francisco.

In a tellingly ironic moment, Moy envisions the possibility of a 14-year-old white counterpart on display in China and being like Atung. Even so, she speaks of the young translator as "irrelevant" and considers the relatively stoic assistant passive aggressive. Throughout the 90-minute, no-intermission play, the openings and closings of the curtain—accompanied by Asian music—separate Moy's "performances." One particularly haunting scene finds President Andrew Jackson—now rightly vilified for his actions against Cherokee Native Americans—creepily inspecting and touching Moy's right bound foot. Gradually the set becomes bare as though symbolizing the eventual decline in popularity of the exhibition (1850 the last recorded display). Later P.T. Barnum demeans Moy still further in his own show.

As the years go by, Moy becomes understandably subdued and the play includes a disturbing timeline with rising anti-Chinese action. The escalating hatred results in the 1882 Chinese Exclusion Act—the only legislation passed against one race or ethnic group—which lasts until 1943. Under Sarah Shin's strong direction, Sophorl Ngin as Afong artfully moves from naivete and hope to a growing understanding of the ways in which she has been exploited. Along the way she beautifully captures Moy's regal bearing, her disarming simplicity and her evolving attitude towards Atung. By contrast, Jae Woo sharply understates Atung's reservations about his work and the exhibition itself. Woo's terrific breakout moment occurs as Atung casts caution to the wind and describes a wild dream of loving women and overpowering men.

Do Americans—and by extension all people—often create boxes of stereotypes about people who are different from them? In this light, "The Chinese Lady" is a clever cautionary tale as well as a timely eye-opener.

Holiday Package Delivery Tips

Between last-minute online shoppers and long-distance gift givers, it’s no secret that the Holiday Season is a peak time for package deliveries, but the increase in activity also makes it a busy time for package thieves.

The Boston Police Department would like to offer some safety tips to ensure that packages end up in the right hands this holiday season.

- Make arrangements with relatives if you know they won’t be home when shipping them a package. Arrange for packages to be shipped to a location where someone will be available to receive them—such as a relative’s home or a work address—or leave special instructions for the carrier to leave the package with a neighbor or in another

secure location.

- Don’t assume that common hallways and back doors are “secure” locations. If the door is unlocked and accessible by those who do not reside there, it’s still a vulnerable location.
- The United States Post Office (USPS) offers special delivery instructions which can be submitted online via the USPS website. Be sure to read them before shipping packages.
- Ask that mail carriers post a notice that a package is available for pickup at the local post office instead of leaving it unattended.
- UPS drivers are trained to leave packages in places that are away from public sight and inclement weather, and customers can submit detailed delivery instructions online for where they’d like delivery items to be left in the event they aren’t home to receive them.
- Customers can choose to have their

UPS packages shipped to a specific UPS Store location. A notification will be sent via text message or e-mail when they’ve arrived and are ready for pickup.

- FedEx offers a “signature for delivery” option. Choosing this option would mean a person would need to sign for the package and it would never be left unattended.
- FedEx Packages can also be shipped to FedEx Office stores, and customers even have the option to go online and redirect a package to a store while it is en route.
- Taking advantage of the security options offered by the carriers will help ensure packages are not easy targets for thieves. If you or someone you know has been victimized by this type of crime, please report the incident to the Boston Police Department. If you see criminal activity taking place, or are in need of police assistance, always call 9-1-1.

means that African Americans were 8.4 times more likely to contract the HIV infection compared to whites, according to The Office of Minority Health at the U.S. Department of Health and Human Services.

Massachusetts is a world-renowned medical hub known for its HIV/AIDS research and support systems, but the outcomes are equally grim. In 2019, according to a UMass Chan Medical School report titled "Burden of HIV & AIDS amongst the Black Community in Massachusetts..." African Americans comprise 7.3 percent of the population but represent 32 percent of people newly diagnosed with HIV. This means that the rate of African American males living with HIV is 5.2 times of Whites males, and the rate of African American females living with HIV is 22.7 times that of white females. African Americans who contract HIV are more likely to die from it than members of other racial groups.

But this data doesn't reflect the wave of recent African diasporic immigrants of the last decade coming from the Caribbean Islands and the Motherland. This demographic group is overwhelmingly underreported and underserved—for fear of not only deportation but also of homophobic insults and assaults from their communities.

In 2022, why is HIV/AIDS still an overwhelmingly Black disease in the United States?

There are many persistent social and economic determinants contributing to the high rates of the epidemic in the African American community—poverty, homelessness, health care disparity, industrial prison complex, and violence, to name a few. And while we know

that the epidemic moves along the fault lines of race, class, gender and sexual orientation, homophobia, stigma, and the Black Church continue to be barriers to ending the AIDS epidemic. However, the most significant obstacle is systemic racism.

"I would not expect anything other than the data quoted. No matter what is being measured in America, you already know who will fare worse. Systems in America are designed to have this outcome," said Dr. Thea James of Boston Medical Center, my spouse.

In 2021, The CDC declared racism a serious public health threat and its impact on health outcomes. World AIDS Day 2021, the National HIV/AIDS Strategy (2022–2025) was released, bringing shockwaves to people of color with its goal to center people living with HIV and address racism.

"The Strategy recognizes racism as a public health threat that directly affects the well-being of millions of Americans," the strategy states. "Over generations, these structural inequities have resulted in racial and ethnic health disparities that are severe, far-reaching, and unacceptable."

The UNAIDS 2022 theme is "Putting Ourselves to the Test: Achieving Equity to End HIV."

I hope the Poz Poll is incorrect and that many will participate in a World AIDS Day event. But I feel assured that no matter who does or doesn't participate on that day, Black Lives living with HIV/AIDS are beginning to matter.

"We can end AIDS—if we end the inequalities which perpetuate it. This World AIDS Day, we need everyone to get involved in sharing the message that we will all benefit when we tackle inequalities," says UNAIDS Executive Director Winnie Byanyima. "To keep everyone safe, to protect everyone's health, we need to Equalize."

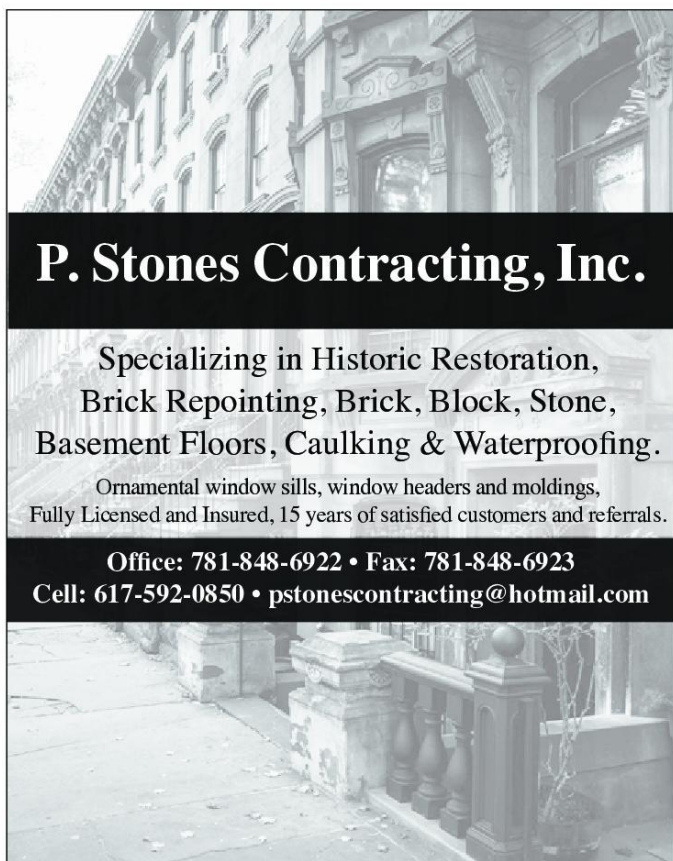

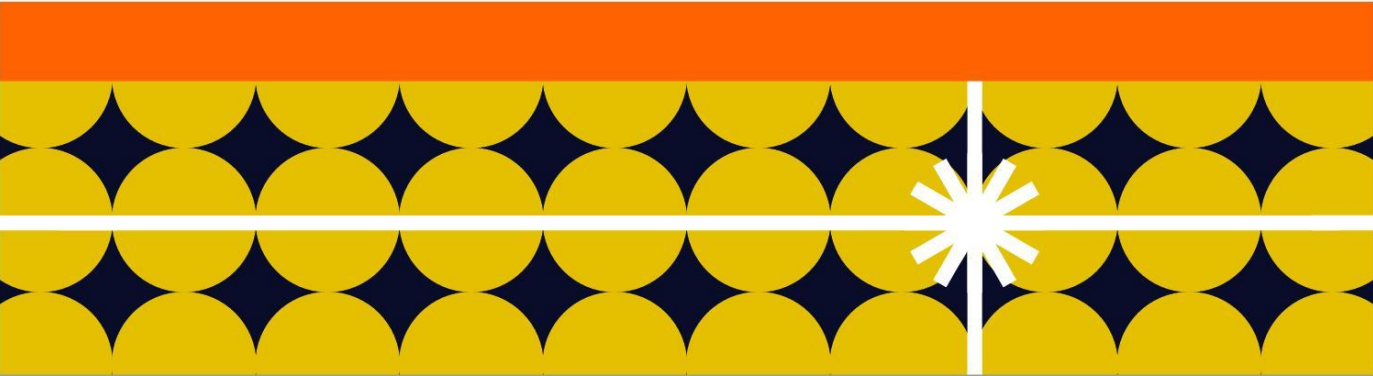
