A Prom for Everyone

Gay and Lesbian teenagers have had to fight for inclusion in school proms for many years—a situation that has inspired some timely recent theater. In 2012, Boston Children's Theatre staged "Reflections of a Rock Lobster," a moving dramatization of real-life Pawtucket, Rhode Island gay senior Aaron Fricke's ultimately successful 1980 struggle to attend his school's prom with his boyfriend.

The similar 2010 efforts by Fulton, Mississippi lesbian senior Constance McMillen inspired the creation of a 2018 musical counterpart appropriately called "The Prom." SpeakEasy Stage Company artistic director Paul Daigneault is giving this alternately touching and humorous 2019 Tony Award nominee (and Drama Desk best musical winner) a Calderwood Pavilion staging at once both riveting and rousing.

Set in Present Day New York and Edgewater, Indiana, "The Prom" disarmingly begins with the opening night closing of a Broadway premiere titled "Eleanor!—The Eleanor Roosevelt Story." Despite the presence of two-time Tony Award winner Dee Dee Allen in the title role and two-time Drama Desk Award winner Barry Glickman as FDR, terrible reviews turn the show into a flop.

Thanks to amusing putdowns of the leads as narcissists in the Chad Beguelin-Bob Martin book (with an original concept by Jack Viertel), Allen and Glickman seek out a cause

that will benefit their reputations—with the latter promising "We will become celebrity activists." Hub veterans Mary Callanan and John Kuntz deliver tour de force fun as the initially insincere self-promoters.

That self-promotion does lead Allen and Glickman to find what Juilliard graduate and fellow actor Trent Oliver calls a "cause celebre"—here a prom challenge at James Madison School in politically conservative Edgewater, Indiana involving lesbian senior Emma Nolan (with an actual 2013 such case occurring in Sullivan, Indiana). Allen tries to say "It's Not About Me"—Callanan in high vocal form here—but it eventually will take some real soul-searching for Allen, Glickman, Oliver and an accompanying "Chicago" ensemble player and jaded Fosse woman named Angie Dickinson to actually make everything about Emma and her initially closeted girlfriend Alyssa (student council president and daughter of P.T.A. head Mrs. Greene).

Before the quartet and press agent Sheldon Saperstein pay for a truly inclusive prom, a culture clash ensues as well as an 'alternate' prom organized by homophobic parents that leaves Emma alone at the originally scheduled one. As the actors bring Emma's inclusive prom to life, they experience their own rite of passage from self-centered performers to truly caring ones.

Matthew Sklar's tuneful music and Chad Beguelin's insightful if sometimes humorous

Casa Myrna Hosts 14th Annual "Community of Conscience" Breakfast

To Support of Domestic Violence Survivors

Casa Myrna, Boston's largest provider of shelter and supportive services to survivors of domestic violence, will celebrate its 14th Annual Community of Conscience Breakfast on Wednesday, May 17 from 7-9am at the Omni Boston Hotel at the Seaport.

Around 300 supporters are expected for Casa Myrna's annual signature event, including Lt. Governor Kim Driscoll, Attorney General Andrea Joy Campbell, State Senator Liz Miranda, Chief of Housing and Director of the Mayor's Office of Housing Sheila A. Dillon, Boston City Councilor President Ed Flynn, Boston Police Commissioner Michael Cox, Suffolk County District Attorney Kevin Hayden, and Suffolk County Sheriff Steven Tompkins.

The event will include a togetherness breakfast, a silent auction, a program including a moving story from a survivor, and a number of special guests from the business, philanthropic, government, and community sectors.

"We are thrilled to be back in person for the first time since the pandemic to host our signature fundraising event," said Stephanie Brown, Casa Myrna's CEO. "This year's theme is Resistance, Persistence, Perseverance: Building a Community of Safety and

Trust. While the past three years have been isolating for all of us, survivors of domestic violence experienced heightened danger and escalating abuse in their homes.

Despite these enormous challenges and trauma, we continued and expanded our services to survivors in the Boston area, prioritizing their health and safety. Casa Myrna does not do this work alone: we rely on our community and partners to help end domestic violence and ensure that all relationships are safe and healthy. By supporting us throughout the pandemic and for this event, we know our community stands with survivors."

The event will feature Keynote Speaker Andrea Joy Campbell, who has pledged to build economic prosperity and stability for all residents, prioritize the mental health and well-being of children, and stop cycles of incarceration and violence. Lt. Governor Kim Driscoll, who became Salem's first woman Mayor in 2006, will provide remarks.

The program will include a story from a survivor who worked with Casa Myrna to find safety and healing. The breakfast will also feature Miss Boston 2023 Arcadia Ewell, who is a survivor of dating violence and a passionate advocate for dating and domestic violence prevention. Finally, Casa Myrna will honor Nicky Bandera of Project Paulie, a nonprofit organization dedicated to feeding people in need, for her incredible contributions to survivors.

Since 1977, Casa Myrna has supported

survivors as they escape domestic violence and recover from the trauma of abuse. The organization has grown from a single shelter for women and children fleeing violence into an organization that serves over 2,000 survivors a year as they rebuild lives free from abuse.

Casa Myrna provides residential shelter and a comprehensive range of supports—ranging from legal to housing and counseling to economic stability—that help participants recover from the trauma of abuse and build safe, stable, and independent futures for themselves and their children. Casa Myrna also answers nearly 28,000 calls annually to our statewide domestic violence hotline, SafeLink.

Every spring for the last 13 years, we have honored survivors' strength, resilience, and bravery. We look forward to being back in person to generate critical resources for our comprehensive work and increase awareness about domestic and dating violence.

Inn, with new windows to be installed over the coming months. Current 30-year-old, deteriorated windows will be replaced with 313 energy-efficient windows that will also bring in additional natural light.

Lead funding for the project comes from the Yawkey Foundation, which has provided approximately \$1.1 million toward the project, including a recent \$500,000 grant as part of a multi-year, transformational \$15 million commitment to Pine Street Inn. This commitment, the largest in Pine Street's 50+-year history, announced in December 2021, is helping accelerate expansion of the organization's housing by creating 400-500 new permanent supportive housing apartments within a five-year timeframe.

lyrics help to make both the quartet's transformation and Emma and Alyssa's heartfelt connection fully convincing. Callanan has the opportunity to display her trademark belt as diva Allen. Kuntz, always expert at comedy, also proves persuasive at singing and phrasing as Glickman.

Troilo, who possesses one of the Hub's finest voices, has a standout number "Love Thy Neighbor" as Oliver gives Emma's fellow students a needed lesson about love and understanding. Liesle Kelly is a revelation as vulnerable Emma—especially in serenading Alyssa on the sweet number "Dance with You." Abriel Coleman captures Alyssa's evolution from ambivalence to coming out with Emma.

Other strong efforts include Anthony Pires Jr.'s supportive principal Hawkins, Lisa Yuen's often frustrated Dickinson and Meagan Lewis-Michelson's shrewd Saperstein. Taavon Gamble's exuberant choreography has Madison students executing high lifts and impressive turns. Paul S. Katz conducts the talented orchestra effectively though there are some overly loud moments.

"Hairspray" proved a feel-good show even as it railed against racism and prejudice involving body shape. "The Prom" is doing the same about anti-LGBTQ bigotry. SpeakEasy Stage's very affecting staging is the perfect musical partner for everyone.

crowd of over 300 attendees. Retired WCVB 5 anchor Susan Wornick and WBUR's Darryl C. Murphy served as event co-hosts.
