## City Councillors Request State of Emergency

Dear Boston Public Health Commission,

We write with a sense of urgency in hopes that you take a vote at your next Board of Health meeting on September 13th to declare a State of Emergency in the area of Massachusetts Avenue and Melnea Cass Boulevard. This will give the administration more flexibility to respond to the ongoing tragedy of substance use disorder, mental illness, open use of illegal drugs, violence, criminality, and disturbance

of urban life that has gone on for far too long.

We have reached a stage where dramatic intervention is vital. We need real solutions that address underlying problems and causes. We believe that the risk exists of compounding the "Mass and Cass" problem by attempting politically expedient solutions that do not address the underlying problems. Additionally, a recent proposal to relocate clinical services and add a shelter at the corner of Massachusetts Avenue and Albany Street

would continue adding to the undue burden already shouldered by the South End and Roxbury neighborhoods.

In truth, the root causes of what has become the central problem of a concentrated handful of neighborhoods lie far outside Boston, but the intersection of Mass and Cass has borne the toll. We ask for swift and comprehensive action to begin the process of bringing relief to this area and the people suffering there.

## Officers Arrest Three Suspects After Person With A Gun Call

### Boston Centers for Youth & Families To Host Two Additional Lifeguard Hiring Events

**Saturday, September 16 from 9:00 to 11:00 am**

Boston Centers for Youth & Families (BCYF) is hosting two additional free lifeguard hiring events on Monday, September 11 from 3:00 to 7:00 p.m. and Saturday, September 16 from 9:00 to 11:00 a.m. at the BCYF Mason Pool in Roxbury. Any Boston residents with valid lifeguard certification who are interested in working as a lifeguard at a BCYF pool are invited to attend one of the events.

The lifeguard hiring events will combine all the necessary steps to become a lifeguard for a City of Boston pool in one location. These include a swim evaluation, skill evaluation, interview, and paperwork processing. Full-time and part-time positions are available as well as Head Lifeguard positions.

BCYF lifeguard positions start at \$22/hour and all lifeguards, even those who work part-time hours, are eligible for all the benefits available to City of Boston employees, including generous health, dental and retirement benefits

as well as paid vacation. With pools located in almost every neighborhood of Boston, working at a BCYF pool is a great way to serve your community.

Interested candidates must be at least 18 years old and should bring the following: at least two references, contact information we can follow up on, a state ID or license, and American Red Cross Lifeguard Certification. Proof of Boston residency will be required later in the application process. We recommend signing up at this link: [bit.ly/BCYFLifeguardHiringEvent](https://bit.ly/BCYFLifeguardHiringEvent). However walk-ins are welcome. If you are interested and can't stop by, more information about lifeguarding at BCYF as well as the link to apply can be found at [boston.gov/BCYF-Aquatics](https://boston.gov/BCYF-Aquatics).

BCYF Mason Pool is located at 159 Norfolk Ave in Roxbury. Parking is available next to the pool or on nearby streets or it's a short walk up Proctor Street from any of the buses that serve Massachusetts Avenue.

The City of Boston is working across departments to renovate several city-owned pools following years of disinvestment. Over the last 3 months, the City has reopened the BCYF Paris Street Pool in East Boston and the BCYF Hennigan Pool in Jamaica Plain. The BCYF Paris Street Pool reopening was the result of a \$10.2 million investment. More pools will be reopened in the coming months and this hiring event is seeking lifeguards to help staff them and other BCYF pools.

Lifeguard recruitment and pool renovations are part of Mayor Wu's Swim Safe initiative, a commitment to support Boston residents' safety around water.

# Martin Richard Foundation Announces 6th Annual Mr8k Registration Opens

The Martin Richard Foundation, in partnership with the Boston Bruins Foundation, New Balance, WS Development, Amazon, and DMSE Sports, a true collaboration of Boston's leading teams, today announced it will host the sixth annual MR8K. For the first time, the 5-mile race will take place in Boston's Seaport District on Sunday, October 15th. Registration is now open at <http://mr8k.org/>.

In 2019 the Martin Richard Foundation established the MR8K as its signature annual fundraising event, giving more people an opportunity to run for Team MR8. This year the MR8K marks its 6th-year milestone they will hold a unique running and social experience in Boston's Seaport. This 8K run through Seaport allows participants to come together on a special course starting at Martin's Park with a proud finish at Cisco Brewers. Additionally, there will be kid-specific age-qualifying races ensuring every member of the family can be a part of Boston's team and compete for Boston youth and community causes. The MR8K will also offer a virtual option for runners to join across the globe who want to be a part of Boston's team. All funds raised will benefit the Martin Richard Foundation's work to support community organizations that advance its values of inclusion, kindness, justice and peace.

"We are excited to be running this race in the Seaport this year. While this is a new location for the MR8K, we are no strangers to the Seaport. The event is open to runners, walkers and para-athletes of all abilities, as well as families with small children.

## BACK TO SCHOOL

### MassReconnect, Massachusetts Free Community College Program Begins

In August, Massachusetts Governor Maura Healey (D) announced the launch of MassReconnect, a program for students over age 25 who have lived in the state for at least a year, and who don't already have a college degree.

State officials expect as many as 8,000 students could enroll through MassReconnect in the spring and fall semesters.

Healy said in a news release that MassReconnect "will bolster the role of community colleges as economic drivers in our state and help us better meet the needs of businesses to

find qualified, well-trained workers. We can also make progress in breaking cycles of intergenerational poverty by helping residents complete their higher education credentials, so they can attain good jobs and build a career path."

The program is open to residents who have accumulated some college credits, but not enough for a degree. MassReconnect also covers costs like books and class-related fees. State officials plan to expand the program to more residents in the coming years.

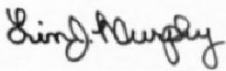
The "Mass and Cass" situation is worsening, not improving. Data maintained by the City of Boston reflects a 57 percent increase from June 2023 to July 2023 in the number of people who received substance use treatment. In January of 2022, there were 76 BPD incident reports; for the week of August 13, 2023, there were 170 such reports. Outside health care providers have pulled out of the area over safety concerns to their employees. Businesses are suffering, youth activity programs have been jeopardized, and our first responders are subject to dangerous conditions that exceed what should reasonably be expected of people already performing difficult jobs. Long ago, this exceeded the quality of life threshold and has become an outright Public Health Emergency.

Recently, we have seen States of Emergency declared to address the Covid-19 pandemic and the surge in immigrants overwhelming the Commonwealth's capacity. What is unfolding at Mass and Cass, and surrounding neighborhoods, is similar in its multifaceted complexity, and no less dire in its threat to human life and well-being. Our neighbor city Somerville is considering a similar State of Emergency, and Boston's problem is not only far more acute, it is now nearing a decade long.

We know there is no magical solution at Mass and Cass, that the humanitarian crisis was not created overnight and will not be cured that way. Underlying societal ills such as mental health and addiction lie outside of your control, and we pledge to do our part in continuing to do our best in addressing those. But we believe that the human cost is too great to delay significant, concrete action any further.

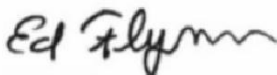
